



MONAGHAN ALERTS

SIGN ME UP!

Monaghan Alerts is a one-stop-shop service where you can sign up to receive alerts from the Council about things like road closures, weather alerts and boil water notices, and now we've added GARDA ALERTS about criminal activity in your area. This replaces the stand-alone 'Monaghan Community Alerts' service which was in operation until end 2022. If you were subscribed to the Monaghan Community Alerts service and wish to continue to receive Garda alerts, you will need to re-register with Monaghan Alerts, as we require your consent in order to comply with data protection.

You can join the service in 3 ways:

1. By downloading the 'Monaghan Alerts' app onto your smartphone. You will then receive alerts onto the app
2. By going onto the Council's website and joining there. You can opt to receive your messages by email or by text as you go through the registration process
3. By returning this paper registration form, and we'll put it onto the website for you. You still get to opt for email or text messages

Whichever option you choose, you will be asked to select the area of the county closest to you from a list. This is for two reasons:

1. It will help to ensure that only relevant Garda messages are sent to you.
2. It signs you up to receive community messages* from that area.

You can select **ONLY ONE** area.

The *Community Messaging service is limited to app and email subscribers only. If you are a text subscriber you will not receive community messages, but will receive Garda and Council messages.

Monaghan Alerts Data Subject Notification

Background

The purpose of this notification is to set out some information regarding the collection and processing of your information by Monaghan County Council. During the course of our activities we will collect, store and process personal data about our service users for the purpose of receiving Monaghan Alerts. Alerts are issued by a combination of App, Email and SMS notifications. Monaghan County Council is the data controller in respect of this data.

Monaghan County Council creates, collects and processes a significant amount of 'personal data' and 'sensitive personal data' in various multiple formats daily. Our commitment is to ensure that the personal data supplied is:

- Obtained lawfully, fairly and in a transparent manner
- Collected for only specified, explicit and legitimate purposes,
- Adequate, relevant and limited to what is necessary for the purpose for which it was obtained,
- Recorded, stored accurately and where necessary kept up to date,
- Kept for no longer that is necessary, and, in a form, which permits identification of the data subject,
- Processed in a manner that ensures the appropriate security of the personal data including protection against unauthorised or unlawful processing of the data.

What data we collect and process

The types of personal data that we will collect, and process includes **your name, email address and telephone number.**

Why do we collect this personal data?

We collect and process this information in order to manage and administer the relationship between you and us for the purpose of facilitating Monaghan Alerts and keeping you up to date on what is happening in your area, town or village.

Lawfulness of processing

We process this personal data with your consent under Article 6 (1) (a) GDPR, Article 6 (1) (e) GDPR and Section 66 of the Local Government Act 2001.

Right to withdraw Consent

Unsubscribe Feature on Website and App

You can unsubscribe from the service by logging onto the member area on www.alerts.monaghancoco.ie or on the Monaghan Alerts app and following the 'close my account' link.

Sharing of Personal Data

We may share your Personal Data with selected third parties, including for example our Service Provider.. We may also share your data with other third parties who assist us in fulfilling our functions. How long do we hold your personal data for?

We will keep your information for no longer than is required in accordance with the lifetime of the service.
