## Information Note

### **Dynamic Purchasing System for Civil Engineering Materials (Supply Only)**

A Dynamic Purchasing System for Civil Engineering Materials (Supply Only) (the "DPS") was advertised on [www.etenders.gov.ie](http://www.etenders.gov.ie) on the 26<sup>th</sup> of June 2020. The Initial Application Period closed on the 21<sup>st</sup> of August 2020 at 3:00pm. The DPS was established on the 16<sup>th</sup> February 2021. New and previously unsuccessful applications for admittance to the DPS may be made at any time during the period of validity (DPS duration). The DPS duration is 5 years.

This **DPS replaces** the existing; Multi-Party Framework Agreement for **Road Making Materials (Supply Only) for Local Authorities** and the Multi-Party Framework Agreement for **Supply Only of Ready-Mix Concrete to Local Authorities**.

### **What is a Dynamic Purchasing System?**

A Dynamic Purchasing System is a two-stage electronic process that contracting authorities use to streamline the procurement of commonly available goods, works or services that meet their requirements from all suitably qualified Economic Operators that have been admitted to the DPS.

#### **Stage 1 Call for Competition – DPS Qualification**

Call for competition issued by LGOPC seeking requests to participate in the DPS and the DPS is established.

#### **Stage 2 Supplementary Request for Tender**

Contracting Authorities invite the Suppliers admitted to the DPS to tender for specific SRFT Contracts.

## Who should Apply?

**Suppliers who are experienced in supplying Bound and Unbound Aggregate Materials and/or Ready-Mix Concrete.**

## How Many Lots are in the DPS?

There are **two** Lots in the DPS:

### **Lot 1 - Bound and Unbound Aggregate Materials (Supply Only)**

- Bituminous Bound Materials
- Cold Mix Bitumen Bound Materials
- Cold Mix Delay Set Bituminous Macadam
- Fill Material & Unbound Material
- Sand, Gravels and Topsoil
- Stone
- Surface Dressing Chips
- All-in aggregate for concrete

### **Lot 2 – Ready-Mix Concrete (Supply Only)**

- Ready-mix Concrete to Concrete Standard EN206
- Ready-mix 'low carbon' Concrete
- Mortar
- Cement Bound Mixtures

**Suppliers wishing to participate in the Lots above must apply for each Lot separately.**

## Selection Criteria

Suppliers applying for admittance to the DPS will be required to meet selection criteria in relation to the following:

- Exclusion grounds and conflict of interest Declarations
- Health and Safety Declarations
- Financial and Economic Standing
- Previous experience in supply of goods (i.e. Bound and Unbound Aggregate Materials and/or Ready-Mix Concrete)

## Which Public Service Bodies will Call-Off from this DPS?

The supply of the materials will be predominantly required by Local Authorities in the Republic of Ireland but may also be required by other Public Service Bodies in the Republic of Ireland (e.g. the HSE, the OPW, etc) following the completion of Supplementary Request for Tender competitions under the DPS.

Suppliers can indicate which county or counties they wish to apply for during the application process.

### **Call-Offs from the DPS**

Supplementary Request for Tender (call-offs) competitions will be run separately through [www.Supplygov.ie](http://www.Supplygov.ie) by each of the contracting authorities. Details required at the Supplementary Request for Tender stage will be set out in the tender documents.

### **Duration of the DPS**

It is anticipated the DPS will be established for a period of five (5) years.

### **Who we are?**

The Local Government Operational Procurement Centre (LGOPC) operating under the auspices of Kerry County Council is tasked with leading the two Categories of procurement of Plant Hire and Minor Building Works and Civils.
