Request for ecological services to support delivery of Wonderful Wetlands restoration scheme.

SUMMARY

Monaghan County Council seeks the services of a suitably qualified and experienced wetlands ecologist deliver an exciting initiative to help landowners and communities protect nature in Monaghan by restoring wetlands.

This project will build on the work of the County Monaghan Wetland Action Plan (2021) which identified wetlands from the Monaghan Wetland Database, on which conservation works to improve biodiversity outcomes and climate mitigation/adaptation can be undertaken, in order to prioritise conservation effort and expenditure.

PROJECT OVERVIEW

The project runs over three years and will commence in **September 2022** and be completed by **October 2024**. Landowners and communities will access the scheme by submitting expressions of interest applications at various stages throughout the initiative as funding and resources allow. The first tranche of expressions of interest will be sought by the Monaghan Heritage Office in July-August 2022.

It is envisaged that the ecologist will work approximately 50 days per year at 2-3 days per week depending on time of year and adherence to Wildlife Legislation and other provisions.

Tasks for the ecologist

The ecologist will work with landowners and communities to:

- Assess wetland habitats and draw up simple restoration plans for eligible sites.
- Organise training for landowners and communities.
- Provide ecological supervision for restoration works.
- Liaise with stakeholders and communicate with the public.
- Liaise with the NPWS and Monaghan County Council.
- Monitor the sites after restoration.
- Keep records of work and produce annual reports showing results of scheme.
- Actions will be costed as part of each restoration plan and include activities such as rewetting of drained peatlands, creating additional wetland areas, prevention of nutrient inputs to wetlands, removal of invasive species, awareness raising and capacity building initiatives. Base costs are provided for in the Wetlands Action Plan.
- Collaboration and building partnerships will be a necessary part of the project, both with agencies, nature organisations and other projects that are active in this area.

Applicants are asked to submit their CV and a summary of three recent initiatives that are of relevance to the delivery of this contract along with a schedule of daily rates applicable to:

Quotations are sought from qualified wetlands ecologists for a daily rate.

Travel and subsistence will be paid within the county in line with local authority rates and policies.

The successful candidate can work remotely / from home or can be provided with a hot desk in a Monaghan County Council building.

The successful candidate will require their own transport.

Interviews may be held with short-listed applicants.

OTHER MATTERS

This contract will be awarded on the basis of a fixed price contract, and as such, all costs must be submitted as a fixed cost in Euro. No amount over and above the negotiated total contract price amount will be paid to the appointed contractor.
