Pursuant to Part II, Sections 11, 12 (1) and 12(2) of the Planning and Development Acts 2000-2017:

Monaghan County Council has prepared a Draft Monaghan County Development Plan 2019-2025 in accordance with the provisions of Section 11 of the Planning and Development Acts 2000-2017, for the functional area of Monaghan County Council including the towns of Monaghan, Carrickmacross, Castleblayney, Clones and Ballybay.

The Council has also prepared (i) an Environmental Report in accordance with the Planning and Development (Strategic Environmental Assessment) Regulations 2004 and the Planning and Development (Strategic Environmental Assessment) (Amendment) Regulations 2011 and (ii) a Natura Impact Report (Stage 2 Appropriate Assessment) in accordance with Article 6 of the EU Habitats Directive ((2/443/EEC). The Environmental Report accompanies the Draft Monaghan County Development Plan 2019-2025. A Natura Impact Report (Stage 2 Appropriate Assessment) is also available for inspection.
