Notice is hereby given pursuant to Section 24(4) of the Planning and Development Acts 2000-2018 (the Act) that the Northern and Western Regional Assembly has prepared a Draft Regional Spatial and Economic Strategy for the whole of the Northern and Western Region. This Draft strategy is available for viewing and written submissions or observations are invited with respect to the Draft.

The purpose of the Regional Spatial and Economic Strategy (RSES) is to support the implementation of the National Planning Framework and the economic policies and objectives of the Government by providing a long-term strategic planning and economic framework for the development of the region over a period of between 12 years and 20 years.

An Environmental Report in accordance with the Planning and Development (Strategic Environmental Assessment) Regulations 2004 and the Planning and Development (Strategic Environmental Assessment) (Amendment) Regulations 2011 and a Natura Impact Report to inform the Appropriate Assessment, in accordance with Article 6 of the EU Habitats Directive (92/443/EEC), the Planning and Development Act 2000-2018, and the European Communities (Birds and Natural Habitats) Regulations, S.I. No. 477 of 2011 (as amended), have been prepared. These Reports accompany the Draft Regional Spatial and Economic Strategy for the Northern and Western Region

Le seo tugtar fógra de bhun Roinn 24(4) do Achtanna um Pleanáil agus Forbairt 2000-2018 (an Acht) go bhfuil dréacht Spásúil Reigiúnach agus Straitéis Eacnamaíochta ullmhaithe ag an Tionól Reigiúnach Tuaisceartach agus Iartharach don Réigiún Tuaisceartach agus Iartharach ina iomláine.
