We would like to request that a special designation is made in the Monaghan County Development Plan 2019-2025, at a very limited area of the shoreline of Lough Muckno (as specified on the attached map), to develop very special and unique tourist accommodation to further enhance the area.

Monaghan County Council have identified that there is shortage of tourist accommodation in the county which our proposal will address.

The owners of this land (Peter McGinn and Fiona & Brian McGuinness), have agreed with Monaghan County Council and the Irish Angling Development Alliance to allow for the development of Angling pegs on their land along the full stretch of shoreline at the South Lodge point of Lough Muckno to develop the county's angling tourism product. Work on this project is due to commence summer 2018. This fantastic project will attract additional angling tourists to the area.

Therefore, we feel that given there is a shortage of accommodation, the development of tourist accommodation along this stretch would be a natural and fitting compliment to the great work already being carried out by Monaghan County Council and the IADA on this project.
