Submission regarding Draft Monaghan County Development Plan 2019-2025

Dear Sir/ Madam,

I refer to the draft Monaghan County Development Plan 2019-2025.

The Council provided this Department with information regarding proposed population targets in Co Monaghan by 2025. The information indicates an additional ca. 5,867 persons.

With respect to the school requirements generated from the population increase, should the identified increase materialise, it would give rise to a requirement for an 8 classroom primary school in Monaghan Town. Further, the school requirements generated from the population increase would give rise to a requirement for an additional 5 classrooms in Carrickmacross and an 8 classroom primary school would also be required in that location should the identified need materialise.

This Department therefore requests that sites be reserved and zoned as educational for primary schools in Monaghan Town and Carrickmacross.

As a guide, the Department recommends an area of 0.77ha (1.9 acres) for a 4-8 classroom primary school. The Department's Technical Guidance Document TGD 25 – Identification and Suitability Assessment of Sites for Primary Schools

Department officials would be happy to review any proposed locations in order to inform the decision-making process around the optimum school location.

In addition, this Department is also progressing an acquisition process in respect of a site for an existing primary school in Castleblaney. This Department requests that the site outlined on the attached map, at Bree, be zoned for educational purposes in that regard.
