## **Subject: Development Contribution Charges**

Order: That the Development Contribution Scheme made under Section 48 of the Planning and Development Act 2000 (as amended) as adopted by Monaghan County Council on 6<sup>th</sup> September 2021, be amended in line with the Wholesale Price Index for Building and Construction with effect from the 1<sup>st</sup> January 2022.
