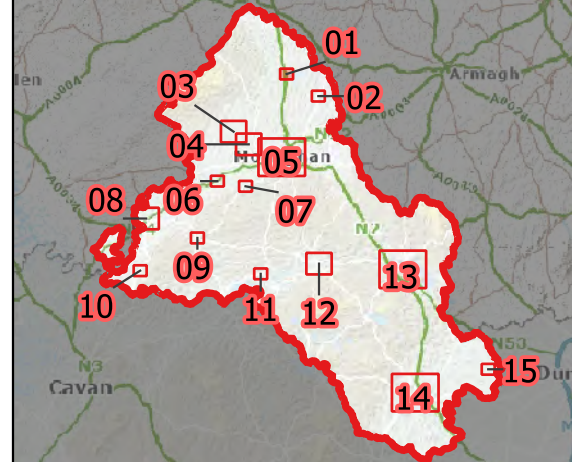

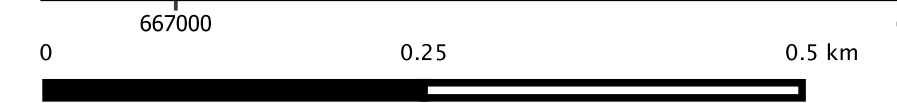
MAP: EMYVALE MID RANGE FUTURE SCENARIO FLOOD EXTENT

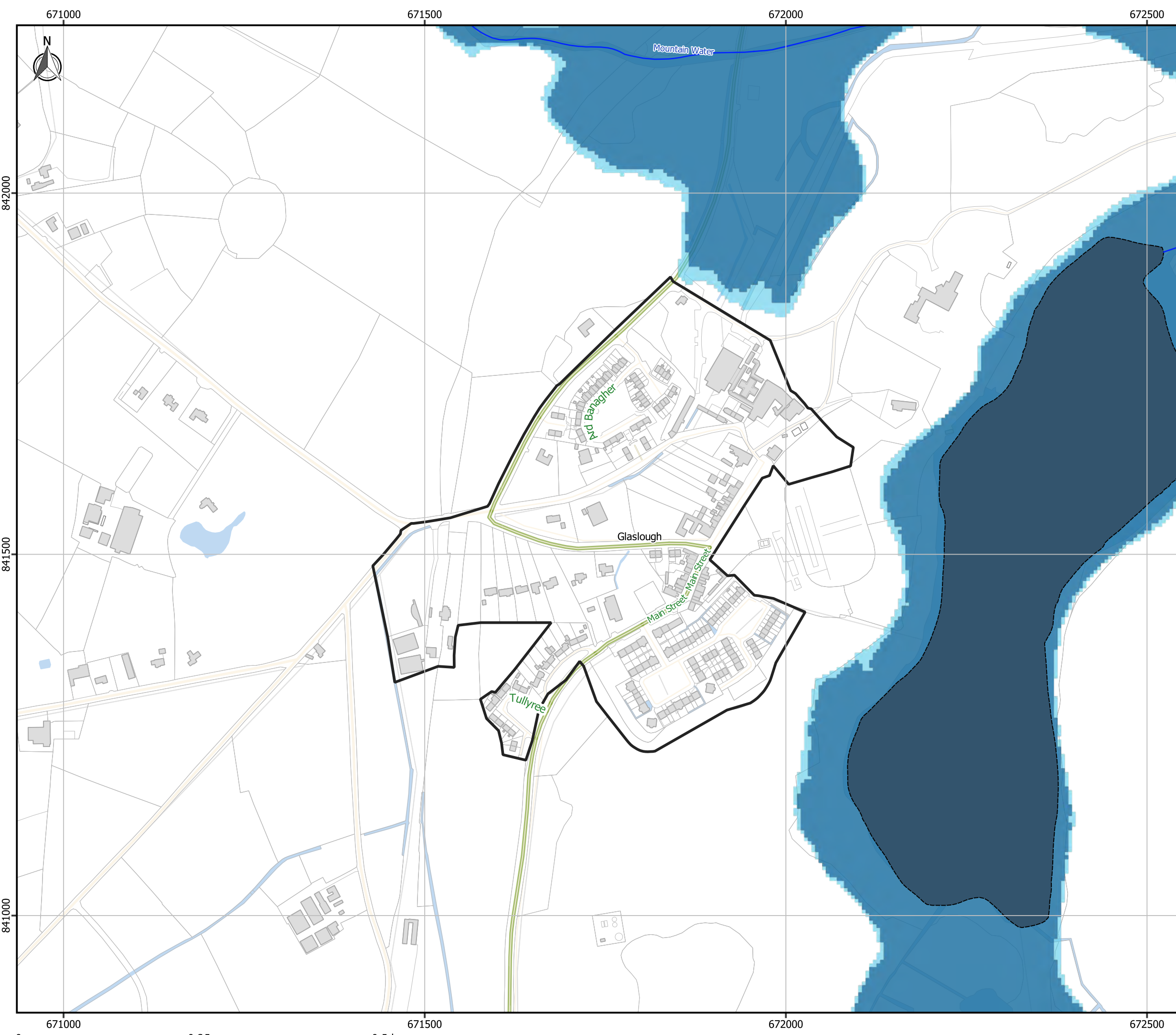

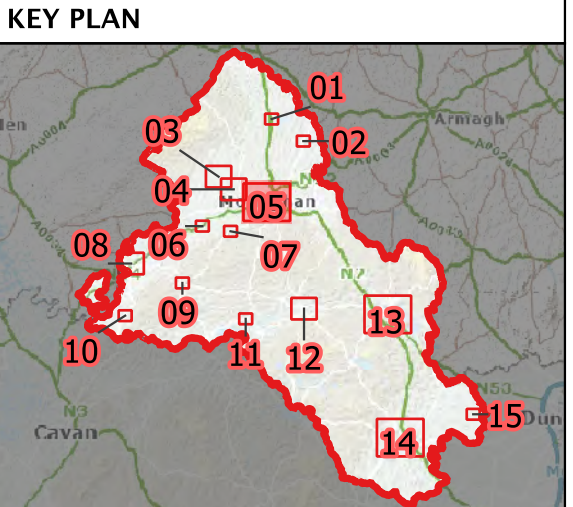
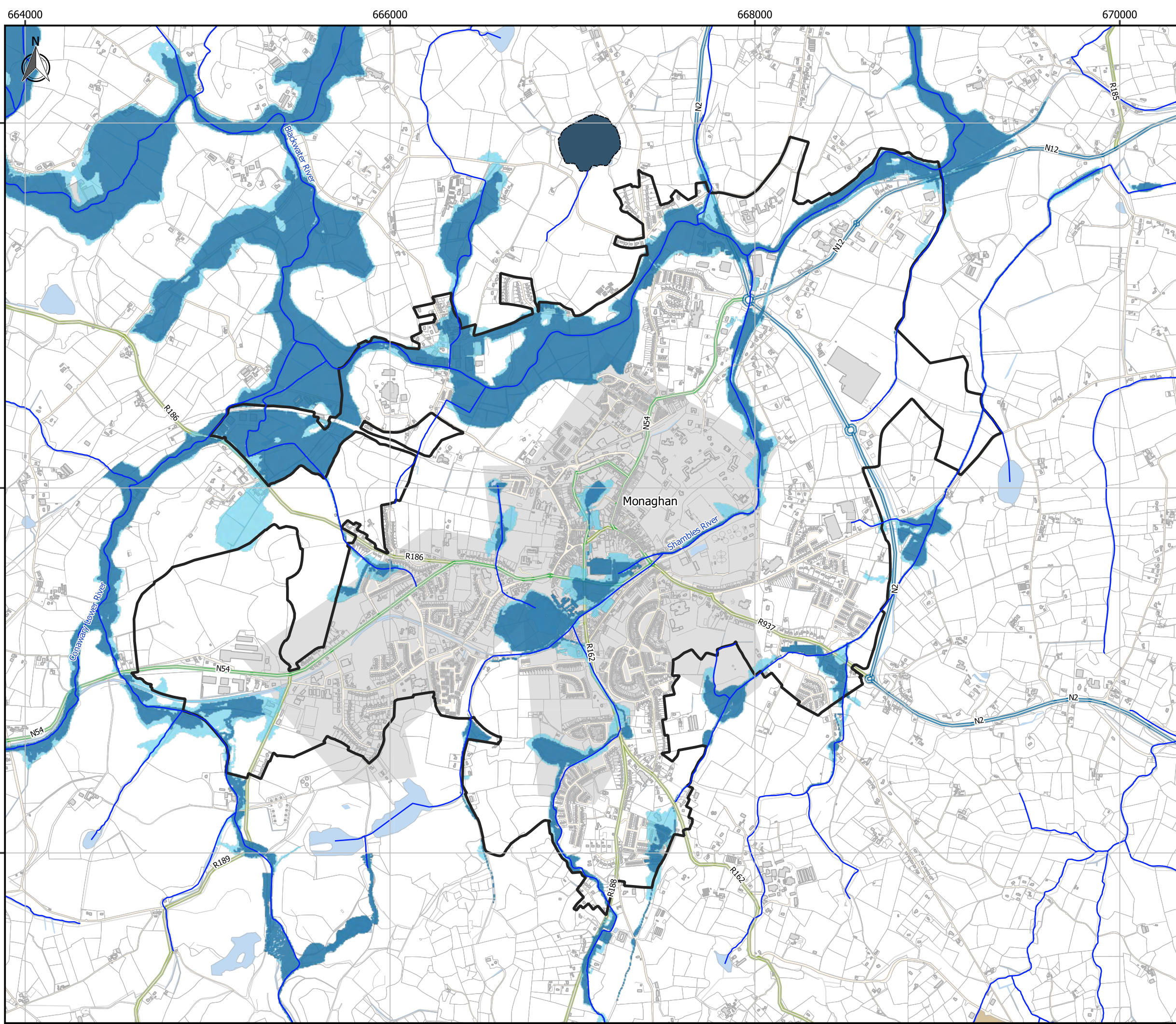
MAP: BELLANODE MID RANGE FUTURE SCENARIO FLOOD EXTENT

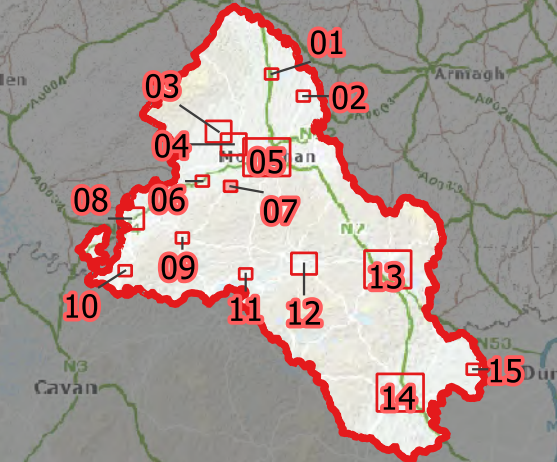
MAP: SMITHBOROUGH MID RANGE FUTURE SCENARIO FLOOD EXTENT

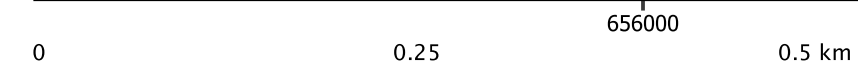
MAP: NEWBLISS MID RANGE FUTURE SCENARIO FLOOD EXTENT

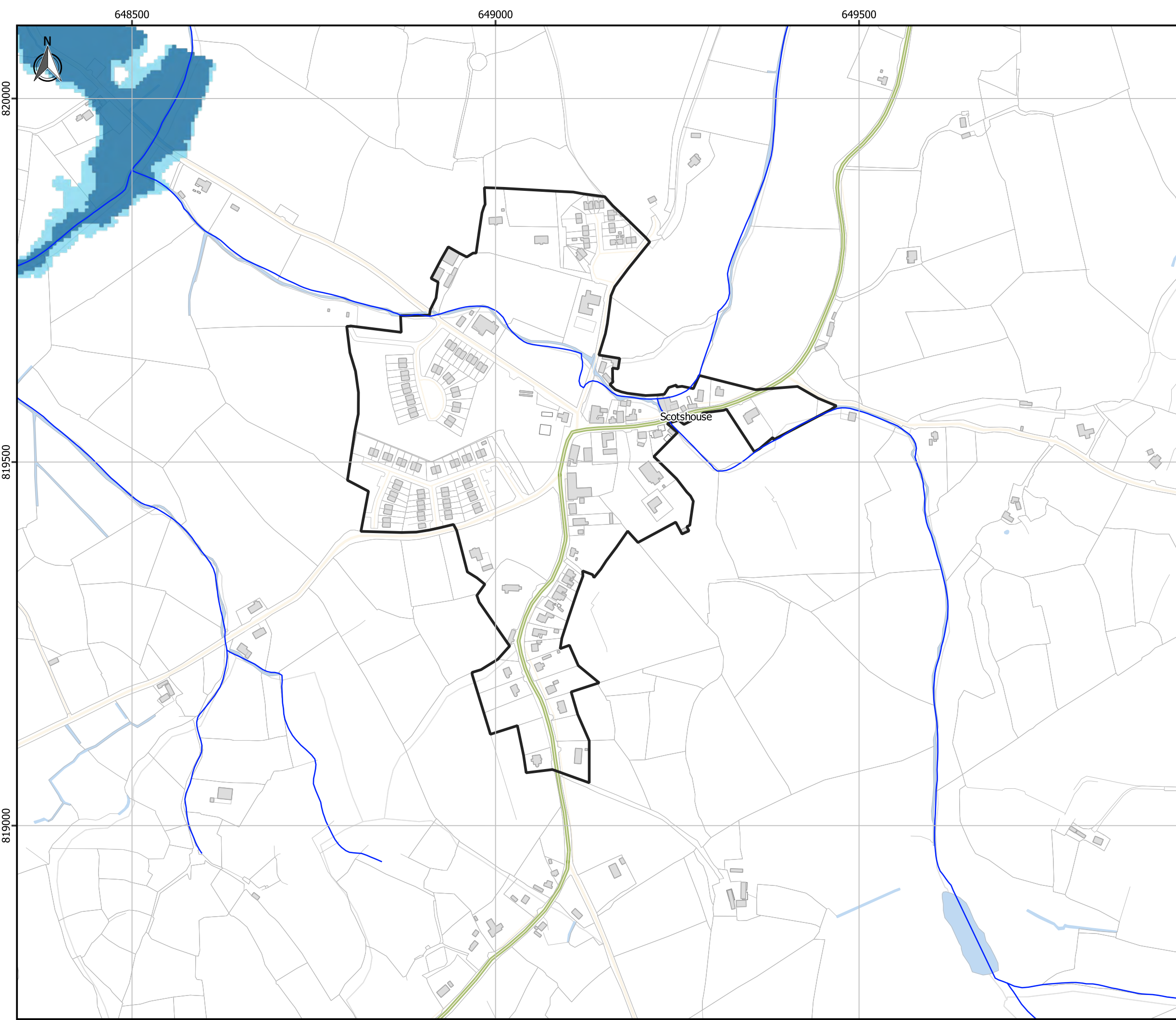

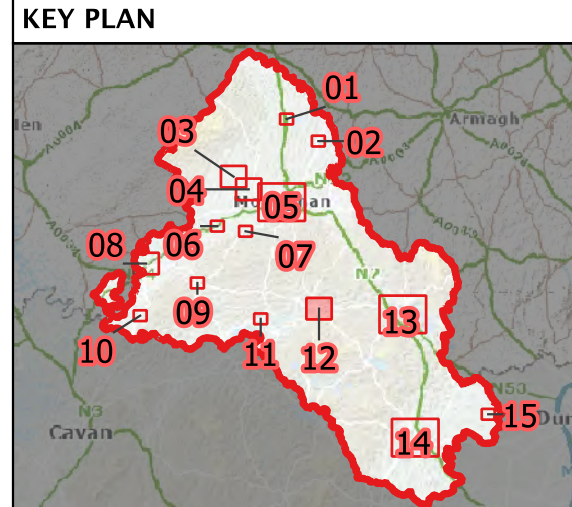
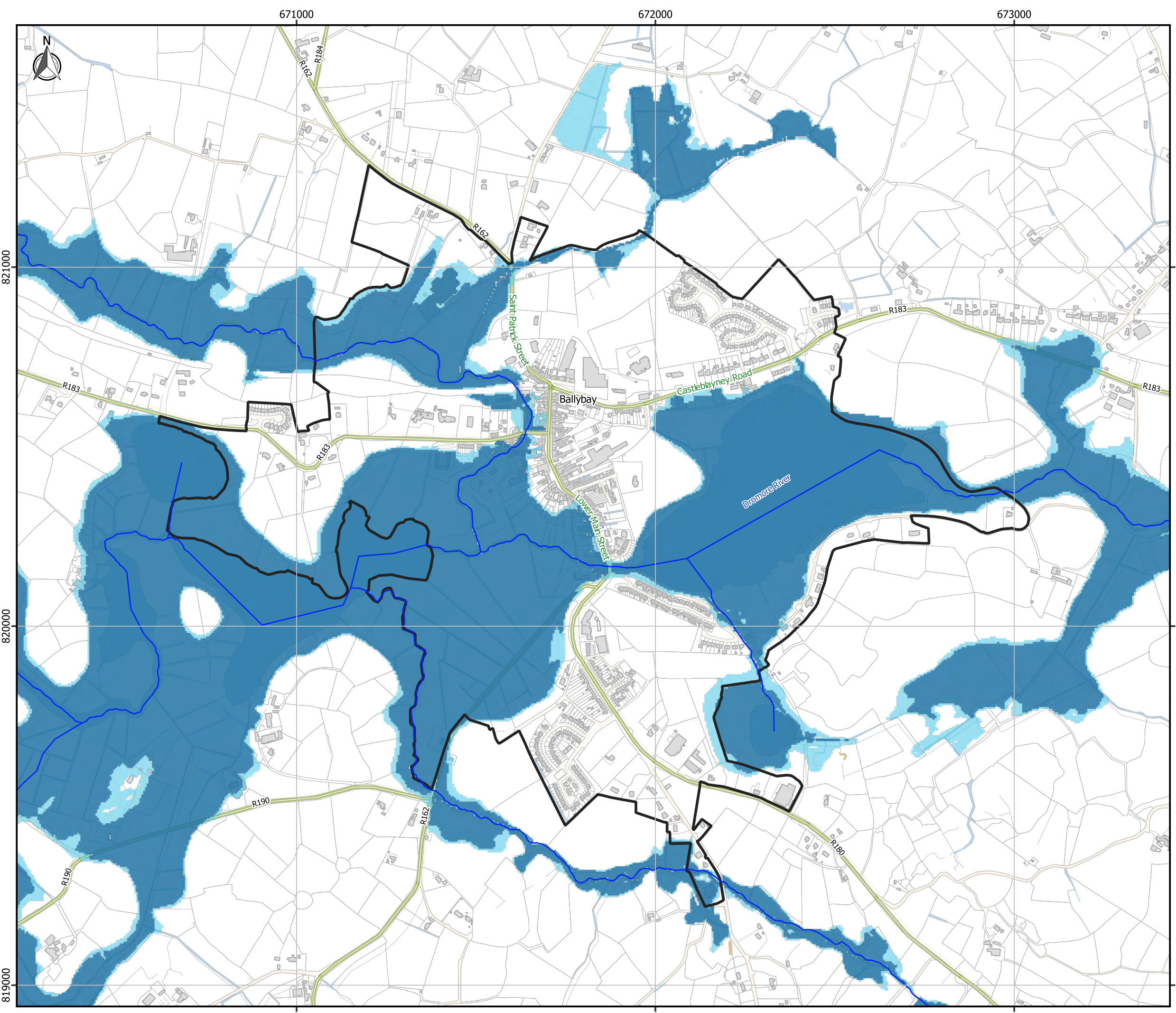
MAP: ROCKCORRY MID RANGE FUTURE SCENARIO FLOOD EXTENT

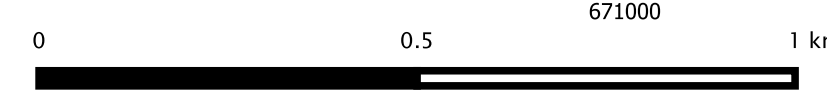
MAP: BALLYBAY MID RANGE FUTURE SCENARIO FLOOD EXTENT

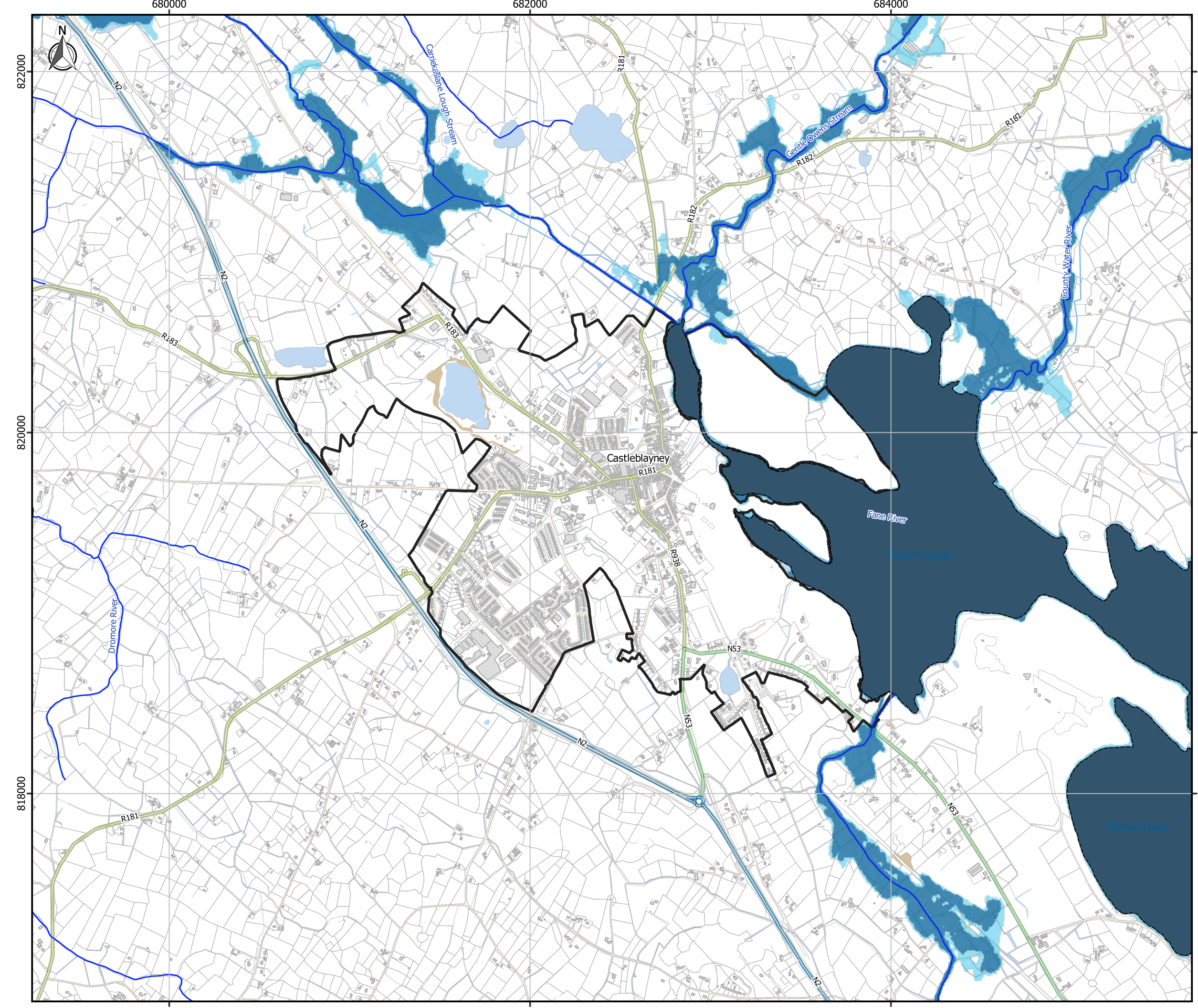

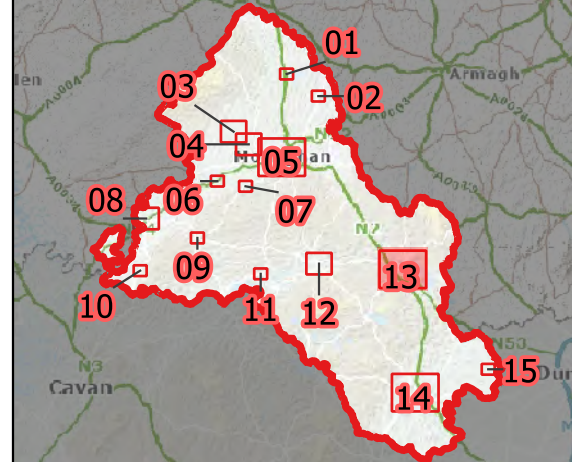

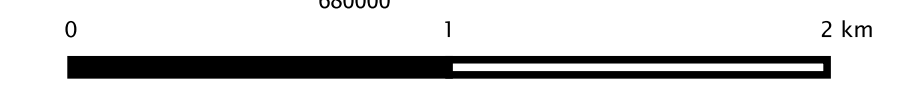
MAP: CASTLEBLAYNEY MID RANGE FUTURE SCENARIO FLOOD EXTENT

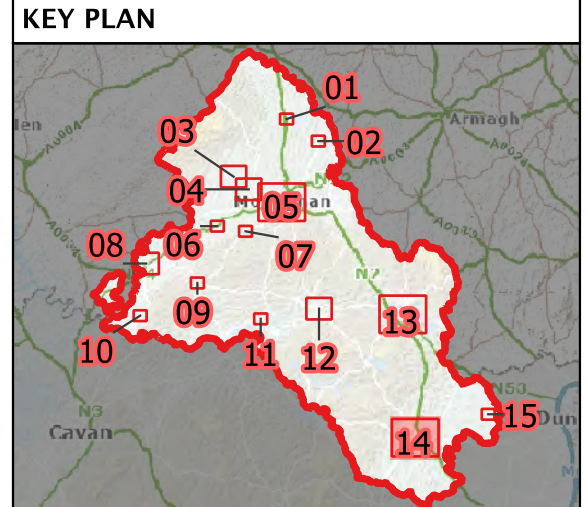
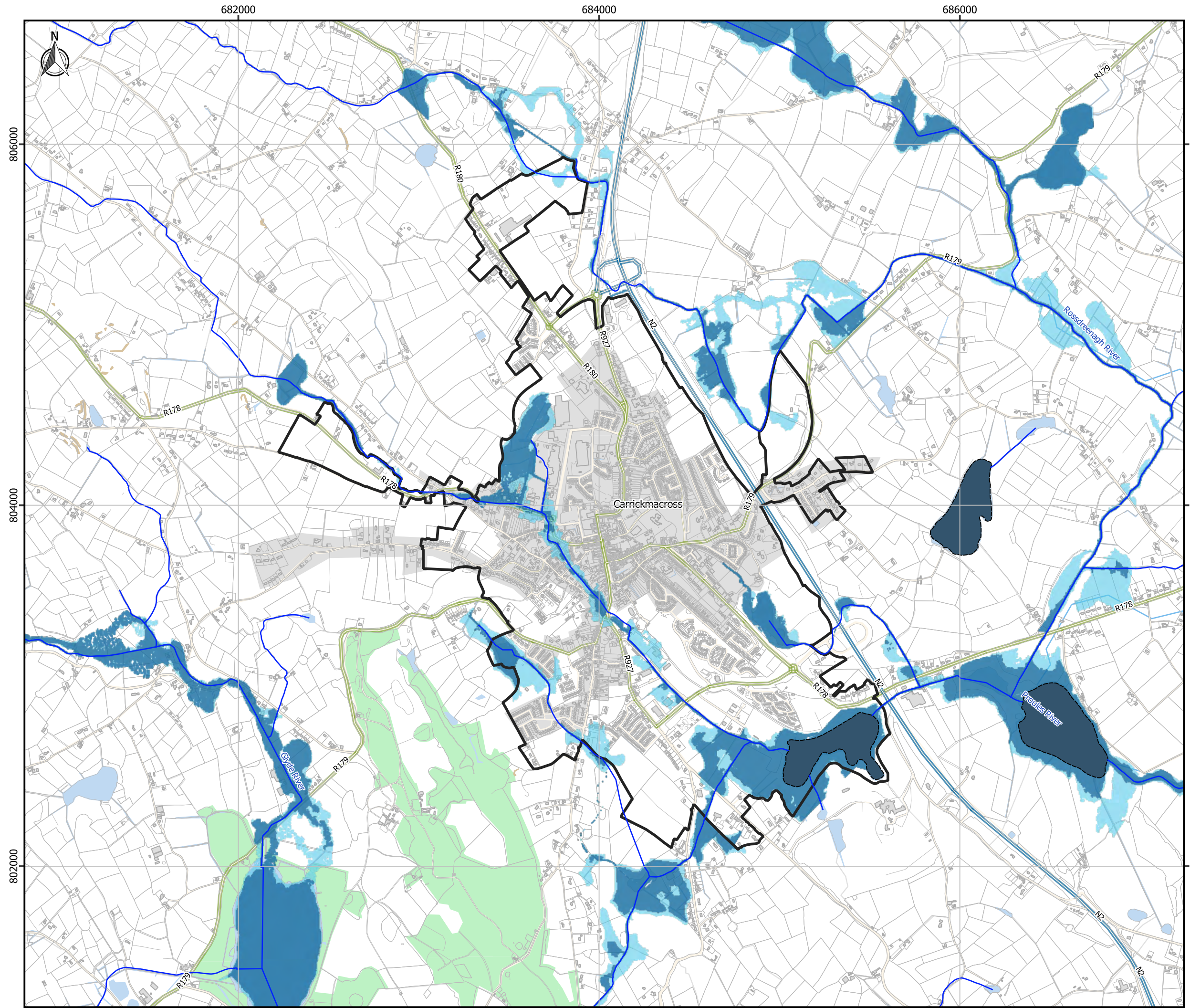

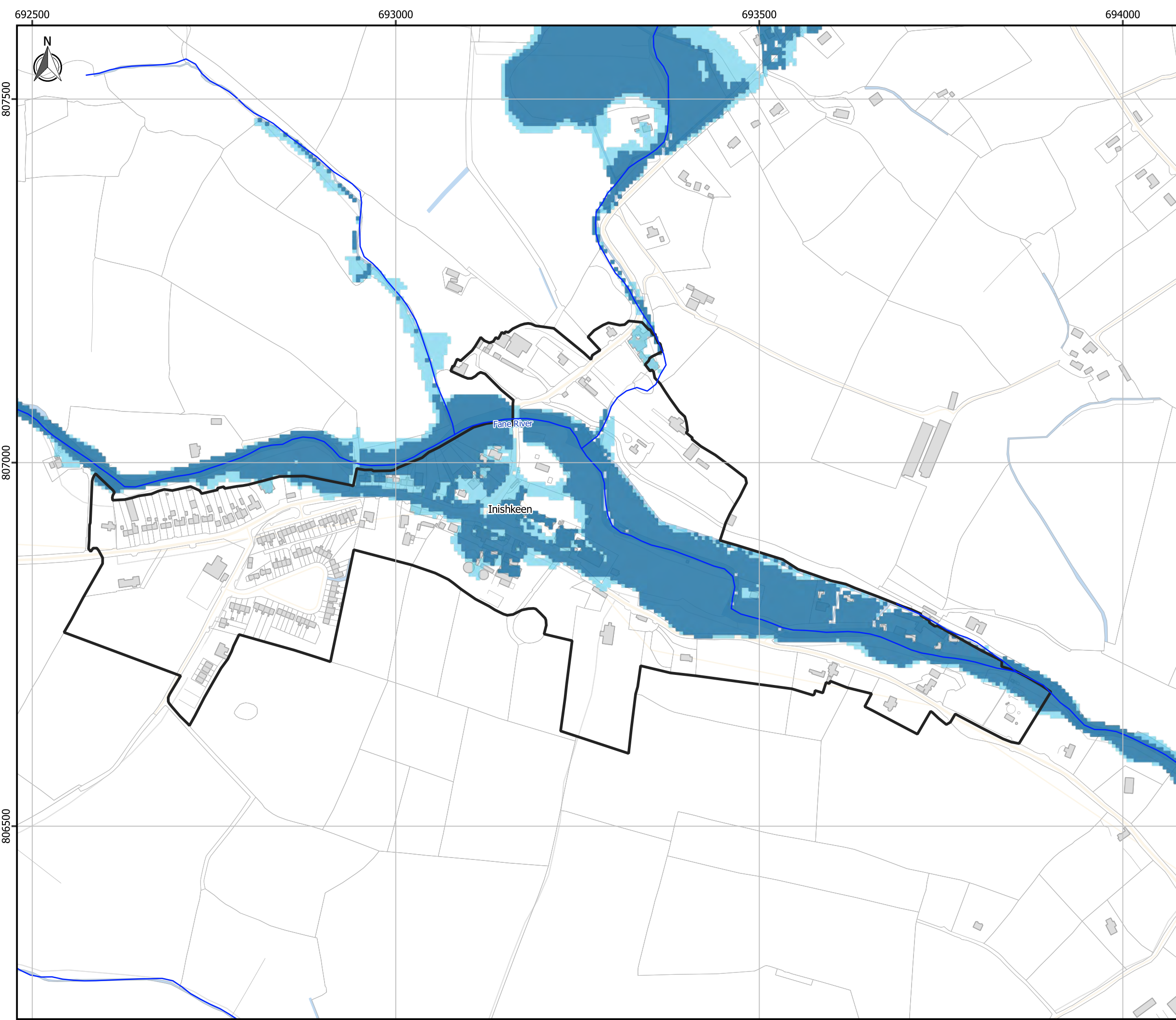
MAP: CARRICKMACROSS MID RANGE FUTURE SCENARIO FLOOD EXTENT

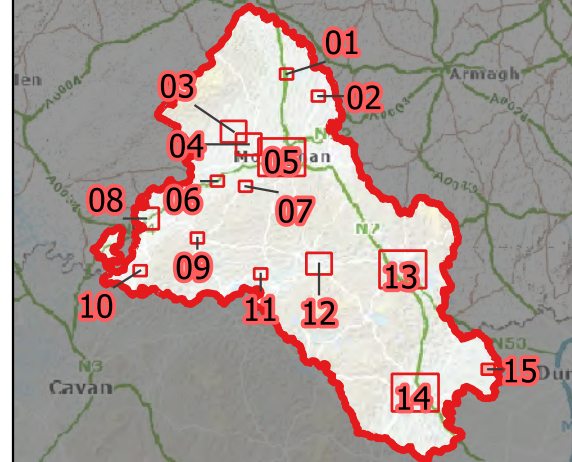
