**Re: Planning Compliance Submission for Condition 3 of ABP Reference 02.VA0017
– North-South 400 kV Interconnector Project**

Dear Sir,

I refer to the above An Bord Pleanála Board Order for the North-South 400 kV Interconnector project 02.VA0017.

You will be aware of the ongoing planning discussions taking place between ESB and Monaghan, Meath and Cavan County Councils.

Arising from those discussions ESB are making this submission to all three County Councils to discharge the requirements of Condition 3; and to provide an update on the status of Conditions 4, 6 and 8, as these all require matters to be agreed in writing prior to commencement of development.

It should be noted that Condition 7 only relates to Monaghan County Council and is the subject of a separate submission.

The wording of each of the planning conditions is detailed in the Construction Environmental Management Plan (CEMP) documents submitted with this cover letter.

Whilst conditions 4, 6 and 8 are considered and proposals to discharge the requirements of these are contained in the document, the key condition is Condition 3. This requires agreement on a Construction Environmental Management Plan (CEMP), a Traffic Management Plan (TMP) and a Resource and Waste Management Plan (RWMP).



These are prepared as separate documents to facilitate review of the plans separately by relevant sections within the County Councils but all form part of the proposals to discharge the requirements of Condition 3.

As well as these three main documents, respective Addendum documents for each work package will be submitted in due course to Local Authorities for agreement prior to construction works commencing at the specific work package areas, as detailed in the CEMP.

Whilst this submission is being sent by email, hard copies of the documents can also be sent by post if required.

The documents being submitted to each County Council are all the same and are being submitted at the same time to facilitate co-ordination amongst the three County Councils.
