FORM OF NOTICE OF A COMPULSORY PURCHASE ORDER UNDER SECTION 76 OF AND THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, (AS AMENDED) AS EXTENDED BY SECTION 10 OF THE LOCAL GOVERNMENT (NO. 2) ACT, 1960, AS SUBSTITUTED BY SECTION 86 OF THE HOUSING ACT, 1966 (AS AMENDED), AND AS AMENDED AND EXTENDED BY THE PLANNING AND DEVELOPMENT ACTS 2000 TO 2021, THE LOCAL GOVERNMENT ACTS 1925 TO 2019, ROADS ACTS 1993 TO 2015 AND ALL OTHER ACTS THEREBY ENABLING THE COMPULSORY PURCHASE OF LANDS, TO BE PUBLISHED IN ACCORDANCE WITH ARTICLE 4 (a) OF THE THIRD SCHEDULE TO THE HOUSING ACT, 1966, AS AMENDED BY THE PLANNING AND DEVELOPMENT ACT, 2000 - 2021.

WHEREAS in pursuance of Section 10 of the Local Government (No. 2) Act, 1960, as substituted by Section 86 of the Housing Act, 1966 as amended by Section 6 and the Second Schedule to the Roads Act, 1993 – 2015 and as amended by the Planning and Development Act, 2000 to 2021 and pursuant to the provisions of the Local Government Act 2001 (as amended), Monaghan County Council of the County of Monaghan (hereinafter referred to as "the local authority") have decided to effect the acquisition of the land to which this order relates under the Housing Act, 1966:

NOW THEREFORE it is hereby ordered that: -

1. Subject to the provisions of this order, the local authority are hereby authorised: -
 - a) to acquire compulsorily, for the purposes of the construction of N54 Tullygrimes to Annaghervy realignment in the townland of Tullygrimes, Cornecassa Demesne, Ballyleck, Tullybryan, Brandrum, Kilnahaltar, Aghalisk, Annagola, Drumacaslan, Drummaconor, Aghnamallagh and Annaghervy Monaghan in the County of Monaghan together with all ancillary works associated therewith, the lands described in Part I, Part II.a and Part II.b of the Schedule hereto which land is shown on the maps marked **"Monaghan County Council Compulsory Purchase Order No 1 of 2022 (N54 Tullygrimes to Annaghervy Road Realignment)"** (Drawings No. DP1000, DP1001, DP1002, DP1003 and DP1004) and sealed with the seal of the local authority and deposited at the offices of the local authority (hereafter referred to as "The Deposited Maps"), and
 - b) to extinguish the public rights of way described in Part III of the Schedule hereto by order made after the acquisition of the land, where the said public rights of way are over the land so acquired or any part thereof, or over land adjacent to or associated with the land so acquired or any part thereof.

2. (1) The land described in Part I of the Schedule hereto and coloured pink on the said maps is to be permanently acquired land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
(2) The land described in Part II.a of the Schedule hereto and coloured light grey on the said maps is to be permanently acquired land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense.
(3) The land described in Part II.b of the Schedule hereto and coloured dark grey on the said maps is to be temporarily acquired land other than land consisting of a house or houses unfit for human habitation and not capable of being rendered fit for human habitation at reasonable expense

3. Subject to any necessary adaptations, the provisions of: -
 - (a) the Lands Clauses Acts (except sections 127 to 132 of the Lands Clauses Consolidation Act, 1845, and article 20 of the Second Schedule to the Housing of the Working Classes Act, 1890), and
 - (b) the Acquisition of Land (Assessment of Compensation) Act, 1919, as amended by the Acquisition of Land (Reference Committee) Act, 1925, the Property Values (Arbitrations and Appeals) Act, 1960, and the Local Government (Planning and Development) Act, 1963 (as applied by section 265(3) of the Planning and Development Act, 2000),as modified by the Third Schedule to the Housing Act, 1966 are hereby incorporated in this order and the provisions of those Acts shall apply accordingly.

4. This order may be cited as the “Monaghan County Council Compulsory Purchase Order No. 1 of 2022 (N54 Tullygrimes to Annaghervy Road Realignment)”.
