

Minutes of meeting of Monaghan County Council held in the MTek Building, Armagh Road, Monaghan on Monday 4th February 2013 at 10.00 p.m.

At the outset the Mayor thanked the Council for its vote of sympathy extended to his wife and the family of her late nephew, Alan Toal, Smithboro. He also extended best wishes for a speedy recovery to Carmel Thornton, Meeting Administrator and Adge King, Director of Services.

It was agreed to discuss the section 140 notice placed before the Council as the second item on the agenda.

Vote of sympathy

With the unanimous agreement of the members, the Mayor agreed to deal with two votes of sympathy to the family of the late Garda Adrian Donohue before considering the Section 140 Motion.

On the proposal of Cllr Murray, seconded by Cllr Gallagher it was agreed that the sympathy of the Council be extended to the wife and family of the late Garda Adrian Donohoe, RIP ,the Commissioner of An Gardaí Siochana and all members of An Gardaí Siochana, on the brutal murder of Detective Garda Donohoe, in the course of his duties and urge all with information that could lead to the arrest and conviction of all involved, to forward it to An Gardaí Siochana or the Police Service of Northern Ireland

The Co Manager on his own behalf and on behalf of the staff of Monaghan Local Authorities also wished to be associated with the vote of sympathy.

The meeting was then adjourned for 5 minutes as a mark of respect to the late Garda.

The meeting re-convened at 10.30am

1. To consider Notice received by the County Manager on 21st January 2013 under Section 140 of the Local Government Act 2001.

The following is a copy of the text of the said Section 140 Notice:

We, members of Monaghan County Council, by resolution hereby issue a requisition to the County Manager under Section 140 of the Local Government Act 2001 to:

Refrain from increasing the rent payable by local authority tenants as a result of the government's property tax (Home Tax)

The Co. Manager advised the members that details in relation to the local property tax had not been finalised. A mechanism has not yet been decided on whether it will be passed on to tenants. The Co. Manager advised the members that he considers that it is premature to consider the motion at present in view of this and that if regulations are brought into force he will be obliged to obey the law.

Proposals arising out of correspondence:

Arising from a resolution circulated by Limerick County Council on the 23rd January 2013 On the proposal of Cllr Carthy, seconded by Cllr McKenna it was agreed that the Council adopt the resolution from Limerick County Council which calls on the Government to ensure, by the most appropriate means, that banks in which the State holds majority shareholding should be governed by State nominated directors with the power to direct decision-making in the working of the bank, including determining the salaries and pensions for bank employees and that Monaghan County Council calls on the Minister for Finance to remove the current public interest directors on banks with state shareholding and to replace them with people who will genuinely act in the interests of the people of Ireland.

Following on from a Motion received from Clare County Council and on the proposal of Cllr Carthy, seconded by Cllr Conlon it was agreed, that in view of the excessive burden placed on sporting community and voluntary sections in relation to the cost of water, that this Council request the Minister of Environment to allow Monaghan County Council lessen the cost on these voluntary bodies by putting in place some legislative process at Government level.

On the proposal of Cllr O'Hanlon and seconded by Cllr Gallagher it was agreed that this Council call on the Minister of Agriculture and Minister of Health to meet a deputation of Monaghan County Council in relation to the serious issue of labelling and quality of products – beef, chicken and pork being imported into this country and ask the Minister, how many inspections have there been on factories or outlets where imported chicken have come in over the last 3 years.

On the proposal of Cllr Coyle, seconded by Cllr Treanor it was agreed that Monaghan County Council call on the Minister for the Environment, Community and Local Government, Phil Hogan T.D., to immediately, recommence the funding to Clones Regeneration Partnership, for the position of project co-ordinator as initiated by former Minister, Eamon O'Cuiv T.D.

On the proposal of Cllr Connolly, seconded by Cllr Treanor it was agreed that the Council write to the NRA requesting that in view of the fact that lands at Tullygrimes on the Clones Road are zoned for industry and proposals for eight industrial incubator units are in place, that the NRA reconsider their refusal to extend the 60km limit on the N54.

It was agreed to write to Ms. Anne McDermott, Project Manager, Network Operations, NRA to invite her to attend a meeting with the Council.

In relation to the speed limit at Tullygrimes it was agreed that the roads SPC should examine the issue.

Cllr Conlon then agreed to the removal of his motion No. 17 (5) on the Agenda.

13. Business submitted by County Manager

Housing applications

The Co. Manager advised that it is proposed to process housing applications centrally to increase efficiency. Applications are currently being processed in the County Council and four Town Councils.

Roads Allocations

The Discretionary Maintenance Grant for Regional and Local Roads for 2013 is €1,471,710. The members have discretion to allocate up to 7% of the allocation to Local Improvement Schemes in the area.

After discussion, it was agreed that the allocation remain as notified in the Department's circular letter.

On the proposed of Cllr Keelan, seconded by Cllr Treanor it was agreed that this Council calls on the Minister of Transport, Tourism and Sport, Leo Varadkar to provide a separate allocation towards the Local Lane Improvement Scheme, given that there are over three hundred laneways on the council waiting list at present.

Update on the Ulster Canal

In relation to the Waterways Ireland planning application, Monaghan County Council is currently awaiting a response from the Planning Service Northern Ireland on transboundary issues. A response is expected in March which should enable a decision to issue.

McElvaney, it was agreed to extend an invitation to Stephen Harper, Canadian Premier to visit Monaghan, during his visit to Ireland for the G8 Summit meeting this summer. The invitation to the Canadian Premier to issue through the Canadian Ambassador to Ireland

Mr. Doherty outlined his presentation on the project supplemented by replies to members questions by Jonathan Condell, Assistant Town Engineer and Carol Lambe, Administrative Officer, Community and Enterprise Section.

16. Questions

Cllr P. Connolly asked:

1. In relation to the "Fix Your Street" website (www.fixyourstreet.ie) allowing the public to report issues directly to the Council regarding local difficulties such as poor light, graffiti, illegal dumping, road deficiencies, and many other maintenance issues when will this scheme be rolled out by Monaghan County Council?

Reply: The "Fix Your Street" reporting system for County Monaghan has been in operation since 1 January 2013. The site can be accessed at www.fixyourstreet.ie or at Monaghan County Council's website www.monaghan.ie

16. Questions (contd.)

Cllr B. McKenna asked:

2. In relation to the proposed realignment works on the N12 Monaghan to Middletown road at the Piper's Bridge, can the Council confirm if we have received any funding for these works in the National Road allocation? If so, can the Council indicate what works it proposes to carry out in the current year and will the funding received enable the realignment to be completed in full?

Reply: *The National Roads Authority have notified the Council of a grant allocation of €200,000 for this location. This year it is intended to complete land acquisition, carry out fencing and site clearance works. The Council intend to develop the scheme design and apply for further funding to carry out realignment works in 2014.*

Cllr C. Bennett asked:

3. Due to the N2 Coolkill East to Corracrin Road Realignment Scheme, considerable diverted traffic will be accessing local roads through the Tydavnet and Glaslough areas for a 5 month period. Will regular monitoring and necessary road repair/strengthening occur to ensure surfaces on these minor roads are maintained?

Reply: *The Contractor proposes as part of his traffic management plan to monitor diversion routes regularly and to carry out maintenance in accordance with the requirements of the Contract.*

Cllr P. McNally asked:

4. How many applicants are presently on our LIS list?

Reply: *There are 190 applications listed in total. The distribution per electoral area is as follows:*

<i>Clones</i>	<i>52</i>
<i>North Monaghan</i>	<i>51</i>
<i>Castleblayney</i>	<i>48</i>

5. (a) Has this Council finalised its emergency plan?
(b) Is it available for the Members today?

Reply: *The Council is currently finalising the plan following discussion of elements of the plan with the Infrastructure Strategic Policy Committee. The final plan will be presented to the Members in April.*

6. Has this Council received any response from the Department of Environment / NRA re making all junctions safer along the N2, especially the junction adjacent to Donaghmoynne Church, school and GAA pitch?

Reply: *The Council have received notification of an allocation of €60,000 to carry out safety improvements at the following junctions along the N2 from this location up to the N2 Castleblayney By-pass:*

*N2 / L8130 Aghadreenan Junction
N2 / L4110 Aghnafarcán Junction
N2 / L8152/L4510 Lisdoonan-Donaghmoyne Crossroads Junction.*

Measures proposed include the provision of right turning lanes or nearside overtaking lanes. The works are planned to take place in the third quarter of 2013.

7. In light of the numbers of people unemployed will this Council consider reducing development charges where the developer intends creating additional jobs or maintaining existing jobs?

Reply: New guidelines in relation to Development Contribution Schemes have been issued by the Department of the Environment, Community and Local Government. A new draft Development Contribution Scheme is currently being prepared and will be considered by the Planning and Development Strategic Policy Committee, Corporate Policy Group and full Council meeting during the first half of 2013.

Cllr M. Carthy asked:

8. Will Monaghan County Council, in conjunction with Respond! Housing Association and Carrickmacross Town Council carry out an inventory of all houses at Tailte An Chlochair/ Convent Lands, Carrickmacross with a view to determining the excess levels of Dampness at each dwelling and if the Council will put in place a programme of works to resolve any identified problems?

Reply: Monaghan County Council owns 55No. of the 170no houses at Convent Lands, Carrickmacross that were built between 2003 and 2006. During the past 18 months several complaints were received regarding “damp” in Council owned houses at Convent Lands. On investigation it has been discovered that the “damp” referred to in all of the complaints to date has been caused by condensation. It has been found that condensation is occurring in localised areas in the corners of rooms and at ceiling wall junctions where it is contributing to the growth of mould. The excessive condensation has a number of causes including clothes being dried on radiators and steam from cooking and water vapour after showers and baths not being removed rapidly by opening windows. The information below may help some occupiers to deal with condensation in their homes. In any cases where the measures below do not prove effective the tenants should notify Housing Section.

What can you do to reduce condensation?

1. Produce less moisture

- Dry your washing outside the property whenever you can. You can also hang it in the bathroom, keeping the door closed and the window wide open.*
- Never use portable gas bottles or paraffin (flueless) heaters.*
- Permanently vent your tumble drier to the outside of your home, using a suitable kit recommended by the manufacturer of the appliance.*
- While cooking, always cover saucepans (simmer don't boil) and don't leave kettles boiling.*

2. Ventilate well to remove moisture

- **When a room is in use, keep a small window and/or a trickle vent open**
- **Ventilate bathrooms and kitchens (use extractor fans where fitted)**
- **Keep bathroom and kitchen doors closed even if they have extractor fans.**
- **Ventilate cupboards and wardrobes - do not overfill wardrobes - let the air circulate freely inside. For the same reason, cut holes in the back panel of the wardrobe and move it 50mm away from the surrounding wall. If possible, locate wardrobes against internal partition walls.**

3. Heat your home

- **A constant, low-level form of heating provides the most economical form of heat and reduces the likelihood of condensation**

4. Remove the mould

- **Treat and remove the mould - there are various products on the market that will help such as fungicidal products available in DIY stores.**
- **Wipe down windows, frames and other affected areas with a fungicidal (mould-killing wash). Make sure you follow the manufacturer's instructions precisely. Dry-clean mildewed clothes and shampoo mouldy carpets.**

9. In welcoming the €60,000 provided by the NRA towards road junction treatment along the N2 Castleblayney to Carrickmacross Road, will the Council outline the junctions in which works will be carried out in 2013, the nature of the works in each case and the expected timeframes?

Reply: The Council has received notification of an allocation of €60,000 to carry out safety improvements at the following junctions:

N2 / L8130 Aghadreenan Junction

N2 / L4110 Aghnafarcán Junction

N2 / L8152/L4510 Lisdoonan-Donaghmoyne Crossroads Junction.

Measures proposed include the provision of right turning lanes or nearside overtaking lanes. The works are planned to take place in the third quarter of 2013.

10. When will Monaghan County Council carry out works at the Aghvilla junction on the N2 north of Carrickmacross to facilitate additional traffic movements at said junction?

Reply: The works are planned to take place in the third quarter of 2013.

11. What works will the Council carry out to prevent the continued flooding at the play-park at Cloughvalley, Carrickmacross and to restore the playing field to an acceptable condition? When is it expected that this work will be completed?

Reply: The Council will carry out remedial drainage works when weather conditions improve to minimise damage to the grass surface.

16. Questions (contd.)

12. Following approval by Monaghan County Council of planning permission for a Group Home for women with physical/ sensory disabilities at Drummond Otra, Carrickmacross will the Council outline the remaining stages in development and an expected timeframe for this project to be completed?

Reply: *Monaghan County Council is in the process of submitting a final pre-tender submission to the Department of Environment, Community and Local Government. This submission will be made by 8th February 2013.*

It is proposed to procure this project via a two stage restricted procurement process.

Stage 1 will consist of the placing of adverts seeking expressions of interest from contractors in early March 2013. The return date for the expression of interest will be mid April 2013. During this time, the Councils Design Team will be progressing the detailed design of the facility and also finalising submissions for Fire and Disability Access Certificates.

Stage 2 will consist of the issuing of tender documentation to preselected tenderers. This will occur in mid May 2013. Subsequent to receipt of tenders and the analysis of same, it is programmed that the Council will be seeking Departmental approval to appoint contractor by early July 2013.

Once Departmental approval has been obtained, the issue by the Council of notifications to unsuccessful tenders and the compliance of the contractor with all precontractual requirements such as provision of bond etc, construction can then commence. This is programmed for early September 2013. Construction programme is estimated to be 12 months.

Cllr A. Murray asked:

13. Re: Littering
- (a) How many people did Monaghan Co Council issue fines for littering in 2012?
Reply: *119 fines were issued by Monaghan Co Council in 2012.*
- (b) How many prosecutions were initiated for littering in 2012?
Reply: *There were no prosecutions initiated in 2012.*

Cllr R. Gallagher asked:

14. Would the Council consider seeking further funding from the Department to progress outstanding issues with regard to unfinished estates in the county?

Reply: *Monaghan County Council has sought funding in respect of the four "Category 4" Developments located within the County. Funding has been awarded and remedial works carried out in respect of three of these (Wylies Hill, Ballybay; Chapel Court, Carrickroe; & Forest Walk, Monaghan Town). An application for funding to carry out remedial works at The Alders, Ballybay is currently with the Department for consideration.*

Funding is not currently available for any other category of unfinished housing development.

16. Questions (contd.)

15. In the light of new Contribution Guidelines to Prioritise Jobs, Investment and Sustainable Development from the Department of the Environment, Community and Local Government - features of which include a requirement for planning authorities to establish reduced rates of contribution for projects such as developments in town centres and industrial development particularly with regard to prioritising job creation and economic investment - what effect will this have with regard to development and contributions in Monaghan?

Reply: *New guidelines in relation to Development Contribution Schemes have been issued by the Department of Environment, Community and Local Government. A new draft Development Contribution Scheme is currently being prepared and will be considered by the Planning and Development Strategic Policy Committee, Corporate Policy Group and full Council meeting during the first half of 2013.*

16. Can the Council provide clarity with regard to the proposed procedure for septic tank inspections and guidelines for householders with regard to how to determine whether their septic tank is functioning properly and whether they will need to upgrade?

Reply: *The Environmental Protection Agency (EPA) is developing a National Inspection Plan for Domestic Waste Water Treatment Systems as required under the Water Services (Amendment) Act 2012. Domestic waste water treatment systems can and do cause pollution when they are not properly sited, installed or maintained.*

The National Inspection Plan will incorporate a twin track approach using citizen engagement strategies as well as the more traditional inspection strategies.

The aim of the Inspection Plan is to make sure that:

- *Engagement takes place with a range of stakeholders to explore effective education strategies;*
- *Information is available to owners of domestic waste water treatment systems regarding their responsibilities and how to operate and maintain their systems;*
- *Information is supplied in multiple, easy to understand formats such as leaflets, video and web-based 'frequently asked questions';*
- *Incentives are used such as lower probability of inspections for registered sites;*
- *Adequate treatment of domestic waste water is in place;*
- *Treatment systems are adequately operated and maintained;*
- *Risks to human health and the environment are identified and managed;*
- *Wastewater sludges from domestic wastewater treatment systems are managed appropriately.*

The Inspection Plan will be carried out for the most part by local authorities. The plan will commence in 2013, with the initial focus on engagement and incentive strategies. These strategies will involve working closely with householders and other stakeholders to ensure that those who are responsible for domestic waste water treatment systems know how to comply and are encouraged to do so. Risk-based inspections will also commence in 2013.

A risk-based approach

Risk-based means putting our resources where the risks are highest to human health and the environment. The Inspection Plan will focus particularly on areas where the potential risk to public health and valuable water resources are higher.

Citizen engagement

Raising awareness and working with interested parties

The EPA and local authorities will talk to interested parties and particularly groups that represent the rural community, such as Irish Farmers' Association, Irish Creamery Milk Suppliers Association, Irish Country Women's Association, the National Federation of Group Water Schemes, as well as Non-Governmental Organisations such as Irish Environmental Network, SWAN, An Taisce and others. The Department of Environment, Community and Local Government, in conjunction with the EPA and local authorities, will also undertake a series of activities to create awareness in order to increase compliance related to the operation and maintenance of domestic waste water treatment systems. Assistance will include dissemination of information for householders through leaflets, newspaper articles, videos and dynamic website pages. Technical guidance will also be made available on the EPA website.

To determine if an individual's 'septic tank' is functioning to the required standard prior to any inspection the householder can consult the 'CODE OF PRACTICE – Wastewater Treatment and Disposal Systems Serving Single Houses (p.e. < 10)' This publication is currently on the EPA's / LA's Website.

17. As the route of the Monaghan bypass is used extensively by walkers and cyclists would the Council contact the NRA in relation to taking measures to make the route safer for all road users?

Reply: The Council will contact the NRA regarding this matter.

Cllr S. Conlon asked:

18. In relation to county Monaghan, what is the operational status of the 'fixyourstreet.ie' website that enables citizens to report road, lighting, environmental and other issues requiring local authority response within two working days? Are additional funds being allocated by the Department to address the deteriorating roads in the county?

Reply: The "Fix Your Street" reporting system for County Monaghan has been in operation since 1 January 2013. The site can be accessed at www.fixyourstreet.ie or at Monaghan County Council's website www.monaghan.ie

Road grant allocations were notified to Monaghan County Council on the 22nd and 25th January for national roads and rural and local roads by the NRA and the Department of Transport, Tourism and Sport respectively. The Council are not aware of any notification in relation to additional funding.

19. In the absence of any specific programme by Sustainable Energy Authority Ireland that will result in cost saving LED street lighting being installed throughout the county, will this local authority take the initiative and explore with industry experts the feasibility of such a programme and potential savings that will result by using this advanced energy efficient technology?

Reply: *Monaghan County Council are participating in a working group on public lighting that has been established by SEAI. This working group has developed a road map to overcome the barriers, including the current tariff structure, and best available technology that exist, to delivering energy efficient public lighting. The Council recently signed a contract to ensure that the best price possible per kilowatt hour for public lighting was achieved.*

Cllr C. McPhillips asked:

20. The R188, Monaghan to Cootehill Road travels from the North Monaghan area and comes into the Clones Area at the Beaghkearns junction approximately. This road is currently in excellent condition up until the said junction but the road from Beaghkearns up to Corcaghan is now showing signs of serious wear and has been in need of patching in recent weeks. The road is also prone to holding surface water in this area. Can Monaghan County Council please advise when works were last carried out on this section of road? What works does Monaghan County Council intend to carry out to repair the road in the future and when approximately might these works occur?

Reply: *Major resurfacing works were carried out on this section of road over 14 years ago, with routine maintenance being carried out when necessary in the intervening years. Maintenance patching has been carried out recently and it is proposed to carry out strengthening patching to the worst affect areas in the near future following a pavement survey.*

21. It was recently reported that one of our border county neighbours, namely County Louth recorded a 40% decrease in diesel laundering instances in 2012 as compared to 2011. Can Monaghan County Council provide similar comparative figures for County Monaghan?

Reply: *During 2012, Monaghan County Council dealt with 97 separate incidents of diesel laundering dumping which represents an increase of over 260% in comparison to 2011 which saw 37 such incidents. Again the vast majority of these incidents occurred in the Castleblayney and Carrickmacross electoral areas and particularly in and around the Oram and Donaghmoyne areas. During 2012 in the region of 500,000Kg's or 500 Tonnes of material were dealt with by Monaghan County Council. During 2012 Monaghan County Council recouped over €352,000 from the Department of Environment to cover the costs incurred in dealing with this problem up until October 2012. A further claim will be made to the Department shortly to cover costs incurred during November and December 2012 and January 2013. As of January 28th 2013 Monaghan County Council has already dealt with a further 7 incidents of diesel wash dumping that have occurred since the beginning of 2013.*

Regarding Louth County Council, although there was a 26% decrease in the quantity of diesel wash discovered in 2012 from 2011 the number of diesel wash dumping incidents actually increased in 2012 to 119. During 2011 there were 90 incidents in Louth but the higher tonnage figure for 2011 can be attributed to the fact that 17 trailers loads of wash were handled in 2011 whilst in 2012 this dropped to 6 trailer loads.

16. Questions (contd.)

22. Can Monaghan County Council please confirm how much funding was received from this year's Local and Regional Roads funding allocation from Central Government for works on the Threemilehouse to Newbliss road? Does Monaghan County Council intend to add to this funding from its own resources? How much work will be carried out to this road in 2013 on foot of this funding?

Reply: *An allocation of €350,000 has been received in 2013 from the Department of Transport in relation to road improvements on the R189 Threemilehouse to Newbliss Road. It is hoped that the allocation will allow for the improvement of a 1.5km section of the road towards Greenan's Cross. The County Council do not have any additional funds available to add to the project.*

Cllr N. Keelan asked:

23. In relation to Bawn, will Monaghan County Council consider extending the public lighting and footpath from the Church Cross, along the regional road R162 out to the new handball alley, in the interest of public safety?

Reply: *There is no funding available for these works.*

24. Has any further progress been made by Monaghan County Council, working in tandem with Louth County Council, to secure formal village status for Killanny, given that in the area there is a school, church, shop, busy state of the art Community Centre, newly formed Boxing Club and recently opened children's play park. Village status would be welcomed by the community and it would also enhance the great work being done by the Community Development & Sports Association.

Reply: *That part of Killanny which is located with County Monaghan is considered to be a Tier 6 settlement in the draft Monaghan County Development Plan 2013 – 2019. Subject to adoption, the related polices contained within the Plan, which provides for small scale development, will apply*

Killanny is not currently designated as a settlement in the Louth County Development Plan 2009 – 2015. The statutory review of the Louth Plan is due to commence at the end of 2013. A settlement strategy will be prepared as part of that review and will be progressed through the relevant periods of public consultation, as required by statutory provisions relating to the preparation of development plans. Monaghan County Council will be formally consulted as part of this review.

25. In relation to Inniskeen village, what progress has been made regarding the taking-in-charge by Monaghan County Council of the newly constructed footpath and public lighting adjacent to the pitch & putt, given that this work was planned and carried out by the combined efforts of the Inniskeen Community Groups on a voluntary basis and given that all the engineering reports have now been completed; when is it hoped to have the public lighting switched on?

Reply: *The Council is in the process of taking these works in charge. When this process is completed Monaghan County Council will be responsible for public lighting.*
