Foreword

We are pleased to present Monaghan County Council's Annual Report for 2022, which outlines the vast scope of activities, services, and supports undertaken by Monaghan County Council in support of the communities we serve. During 2022 the Council continued to deliver significant efficiencies and innovation, while focusing on its leadership role to drive local, community and economic development, in line with the Corporate Plan 2019-2024, to ensure that Monaghan remains an attractive place to live, work, do business and visit.

Monaghan County Council is at the heart of public service delivery in the county and takes a leadership role at national level in areas such as rural development and tourism. The Council, working with its communities, large and small, will continue to be innovative and responsive to the changing needs and expectations of the people of Monaghan during 2023.

Throughout 2022, the Council continued to progress a number of successful projects and strategies, such as:

As part of the broader local authority commitment to climate change as well as its educational role in encouraging the public to undertake lifestyle changes to reduce their carbon footprint, the Housing Section have, in conjunction with the Climate Action Steering Committee, developed a booklet outlining simple measures that can be used in the home to reduce energy spend and usage. The document will be made available on the Council's website and launched on other social media in 2023.

2022 was another successful year for the Local Enterprise Office (LEO) Monaghan, despite economic challenges such as Brexit, the number, and more importantly the quality, of projects, applying for support was very encouraging. In 2022, approximately €400,000 was approved in grant aid with a potential to create an additional 45 jobs. LEO continues to be the first port of call to anyone thinking of starting a business. In 2022 we had circa 300 enquiries from individuals starting their own business and/or seeking advice and information on other government business supports and services.

In 2022, the world was rocked by the advent of the war in Ukraine. We acknowledge the outstanding work of Civil Defence volunteers who played a pivotal role in welcoming Ukrainian refugees to our county. We also recognise and commend the community of Knockatallon for the compassion they demonstrated in taking in Ukrainian refugees, newly arrived in Ireland, while they awaited housing allocation.

We are grateful to our elected members who, throughout 2022, continued to work with the Council executive to make financial provision for various services and projects in the county in a competitive and challenging operating environment. Key to achieving a range of infrastructural improvements and service provisions was the ongoing collaboration between elected members, council executive, the Oireachtas members, government departments and other stakeholders and partners which continued to contribute productively to progress on a number of fronts.

We would also like to commend the Members of the Strategic Policy Committees, the Corporate Policy Group and the LCDC and to acknowledge all the work that is carried out at Municipal District Level and by the various other hardworking committees. We would like to commend and thank the Management and staff of Monaghan County Council for their continued hard work and contribution to the delivery of a high-quality service to the public in 2022; their work with communities and Elected Members underpins all of the progressive actions the Council can be proud of over the last year.

We are grateful to Councillor Aidan Campbell, outgoing Cathaoirleach, for his commitment and cooperation in the delivery of the Council's highlevel goals in 2021/2022. We are confident that the work of the Council and the progress achieved will enhance the quality of life for the people of Monaghan.

Above all else, we want to thank you, the people of County Monaghan; it is your sense of community that has seen us emerge from the pandemic, stronger and more able to cope with such events in the future. Thank you to all the community groups who showed such leadership during this time.

Over the past 3 years we have shown our collective capacity to adapt, innovate and maintain services in the face of uncertainty and adversity. Our Corporate Plan commits us to continuing our work with all partners to strive to meet Monaghan's existing, changing and future needs. As we look back at the achievements of 2022 and the opportunities and challenges that lie ahead, that collective capacity as well as our continued commitment, will serve to deliver our shared vision for Monaghan.

It was with deep sadness that we learned of the death of our colleague and friend, Peter Murphy, General Operative, who passed away in May 2022. Our thoughts and prayers are with Peter's family.

Finally, we wish to pay tribute to our recently retired Chief Executive, Eamonn O'Sullivan, for his leadership, support and guidance since joining Monaghan County Council and for the dedicated service he gave to the people of Monaghan and we wish Eamonn a long and healthy retirement.



Finance

Reconciliation of Statement of Financial Position (SoFP) and review of Statement of Comprehensive Income (SoCI)

The Finance section carry out regular reconciliations and reviews of balances on the SoFP, thus adhering best to practice recommendations. This ensures that debts are collected as quickly as possible, funding for capital projects is identified and transactions are monitored and reviewed on a timely basis, loans are reconciled to statements and fixed assets are reconciled to other available registers such as iHouse and the Property Asset Register. In addition to this, Finance carry out a quarterly analysis of actual versus budgeted revenue expenditure and income to ensure that all expenditure and income are accurately posted and are recognised in the correct period.

Cumulative surplus

The Council achieved a cumulative surplus in 2021 ($\leq 130,409$) for the first time since 2005. The Council hope to retain a surplus going forward. An annual surplus is achieved through accurate budget preparation, cost reduction awareness and careful monitoring of actual spend versus budget. The highest level of cumulative deficit was $\leq 3.3m$ in 2013.

Treasury Management

In order to maximise interest receivable on excess funds, Finance staff monitor the bank balance and transfer excess funds to HFA who pay 1.25% on investments up to three months and 1.5% on investments over three months.

Rates Collection

Monaghan County Council's Rates collection excelled again in 2022. The final collection rate is estimated at 95%. The Rates collection for 2021 was the highest of all 31 local authorities at 95%. Monaghan County Council's high rate of collection is due to early and accurate billing, experienced staff, multiple payment options for customers and use of specialist legal firms.

Budget preparation

During Q3/Q4 2022, the Finance section prepared the 2023 annual Revenue budget. This provides for €80m of income and expenditure. Rates income is budgeted at €14.9m (ARV 0.2374) and LPT funding at €11.7m which includes 15% increase on the base rate. Rising energy costs prevalent at the time of budget preparation increased budgeted energy costs. Due to funding pressures facing the local government sector particularly in relation to these rising energy costs, the Department of Housing, Local Government and Heritage is providing supplementary support of €515,245 to Monaghan County Council in 2023.

Housing & Building

Housing Capital Building Programme

A total of 151 social houses were provided in 2022 through a mix of new build and acquisitions. New build projects were the main focus of the capital expenditure programme in 2022 and Monaghan County Council completed 35 houses at Ard an Radhairc in Carrickmacross, 26 houses at Luí na Gréine in Scotstown, 2 houses Church Street, Ballybay, 30 houses at Coill Darach, Castleblayney and 20 houses in Clones as part of Clones Renewal Scheme.

A further 25 new built social houses were provided in conjunction with Tuath Housing Association and North & East Housing Association.

Eight homes were provided in 2022 for the redevelopment of units at Gortakeegan Halting site. Three houses were acquired on the open market and two via Part V by Monaghan County Council. 45 social houses owned by Monaghan County Council were re-let in 2022.

Approved Housing Bodies

As previously mentioned, in 2022, Approved Housing Bodies delivered 25 social homes through a mix of new build and acquisitions. Through the Capital Advance Leasing Facility (CALF), 25 homes in Carrickmacross-Castleblayney MD area have been delivered.

Through the Mortgage to Rent scheme a further eight properties are now being managed by Home for Life (not included in overall delivery figures).

Casual Vacancies / Voids

Monaghan County Council carried out renovation works on 45 Casual Vacancies in 2022 at a cost of €718,639. The houses were prepared for reletting at an average cost of €15,969.77 in an average time of approximately 16.22 weeks. Typical works include a new kitchen, flooring, electrics, painting, new heating system, bathroom upgrades and fencing. One of the properties was a protected structure that required significant & specialist works which due to these factors increased the average reletting time by 1.5 weeks. Monaghan County Council does not have any long-term vacant houses (Voids).

Housing Maintenance:

In 2022, a budget allocation of €1,119,979 provided for response & planned general maintenance of the Council's housing stock. The Housing Section received and logged in excess of 1,850 repair requests in 2022. The key areas of housing maintenance for occupied dwellings include:

1. **Response Maintenance** which involves responding to tenant emergencies and reported repair requests. Housing Section continues to engage with tenants to provide appropriate information in relation to these responsibilities.

2. Planned Maintenance involves the delivery of targeted programmes for specific improvement and replacement works. In 2022 targeted planned maintenance works were focused on external works including wastewater treatment systems, boundary replacements, window and door replacement and roof replacement.

Renewal Schemes

Clones

The ongoing work at the derelict sites in Clones as part of the Clones Renewal Scheme (24 units) continued in 2022 with all remaining units delivered in an exceptionally challenging environment for a scheme of this nature.

Ballybay

Monaghan County Council received final funding approval, with permission to commence works on site to address an unfinished housing development in An Clós, Ballybay, town centre, where four derelict properties exist along with a vacant derelict site. These works are progressing well and will be completed in Q3 2023.

Traveller Accommodation

Monaghan County Council are delivering our Traveller accommodation programme through the provision of Social Housing, Approved Housing Bodies and HAP assistance. final phase of Furthermore, the the redevelopment of Gortakeegan Halting Site was completed in March 2022. The 14 houses available comprised of eight one-bedroom houses and six 2-bedroom houses all of which are now occupied.

There are 112 households of Traveller ethnicity living in local authority dwellings, 14 living in traveller specific accommodation and 16 living in Private Rented accommodation with social housing supports.



Gortakeegan

County Council Tenancies

The Tenant Liaison Officer, in 2022, was mainly involved in dealing with Breaches of Tenancy. The number of cases opened in 2022 is outlined below.

There were 57 cases which breached the Tenancy Agreement (non-rent related). They were categorised under the following headings:

- Category A Drug Activity: 2
- Category B Non-Drug Related Antisocial Behaviour Activity (e.g. property damage or actions hostile to a person): 9

Property damage & Actions hostile to the person

• Category C - (Other- breaches of tenancy): 46

In respect of these matters the investigations of the cases resulted in the following

- 1st warning, Tenant Notifications issued: 3 Statutory Warnings served (Housing Miscellaneous Provisions Act 2014.): 6
- Abandonment Notices served: 2
- Dwellings taken back into MCC possession following the service of statutory tenancy Warnings/Notices: 4
- Applications to Court for re-possession: 1

The Tenant Liaison Officer visited 236 individual household from April 2022 to end of year.

In 2022 Monaghan County Council had 151 new

tenancies commenced plus an additional 28 persons from the Council's housing list were offered tenancies with an AHB.

Homeless Services

Monaghan County Council is responsible for the assessment of people who present to their offices for social housing support and who state that they are homeless. In 2022 there were 124 households reporting homelessness. Of those who presented, 20 were assessed as homeless. In respect of all persons presenting as homeless support was provided. This was either through directly providing emergency accommodation or local authority accommodation or private rented accommodation supports or indirect assistance which can include advice/mediation or liaison with relatives/landlords.

Housing Assistance Payment

HAP continues to play an important role as a form of social housing support for those with a longterm housing need. 101 tenancies commenced in 2022 and there were a total of 496 active HAP supported tenancies as at 31st December 2022. The monthly landlord rent cost is €281,489.49. HAP Shared Services Centre based in Limerick City and County Council have the responsibility for all financial transactions, collection of rent from tenants and landlord payment at month end.

Rental Accommodation Scheme

The Rental Accommodation Scheme (RAS) is a support to people who have a need for long term housing. The total number of tenancies in receipt of RAS support was 188 at 31st December 2022: 67 households in private rented accommodation and 121 households in AHB properties. The monthly landlord rent cost for all RAS tenancies is €73,834.94.

Housing Grants

It was yet another busy year for housing grants. In 2022 an initial allocation of ≤ 1.043 million was increased to ≤ 2.3 million due to the continued high up take of housing grants in the County. Housing Section approved 233 housing grant applications, paying out on 234 applications and recouping in full on 245 applications.

Monaghan County Council continues to be at the top of the Departments 'drawdown table' for 2022, a testament to the great work being undertaken by all involved in promoting and delivering the various schemes.

Climate Change

Monaghan County Council is committed to reducing the negative effects of Climate Change on its social housing stock. All social housing projects are being designed to either mitigate against or adapt to the impacts of climate change.

An internal desktop Flood Risk Identification Report was carried out on all Social Housing Stock in 2022. In 2023, following on from this report, Monaghan County Council will carry out further Flood Risk Assessments on properties that have been identified as potentially being at risk of flooding in a one-thousand-year storm event. The potential necessity and feasibility of flood mitigation or adaptation measures will be considered.

In 2022 Housing Section Planned Maintenance Programme included two Climate Action projects. The first project involved the removal of seriously diseased and dangerous ash trees and the installation of a native hedgerow in their place in Cavanreagh, Scotshouse. The second project involved the pledging of open space at Folly Court Ballybay for Pollinators.

Energy Efficiency Works

The Social Housing Energy Efficiency Retrofit Programme continued to accelerate in 2022 and Monaghan County Council delivered upgrade works to 72 homes in 2022 at a cost of €2,166,070.

The Department of Housing, Local Government and Heritage funded 97% of these costs (€2,109,265).

The works included new windows and doors, internal or external wall insulation (if required) and heat pump installation. Works also include removing old, inefficient heating systems, upgrading flat roof insulation, closing existing chimneys and all other works necessary to achieve a minimum B2 Building Energy Rating (BER).

As the Energy Efficiency Retro-fit Programme is funded under "Housing for All" it is anticipated that in 2023 the funding allocation for this programme will increase. Monaghan County Council aims to maximise the number of properties being completed each year subject to funding.

The programme of works for 2023 will aim to improve the energy performance of the poorer performing (F and G-rated) social housing stock in the county.

Health and Safety Unit

Operational Plan

The Health and Safety Unit (HSU) set out the work targets to be achieved in the Annual Service Delivery Plan (ASDP) 2022. The HSU documented its programme of work in the HSU Operational Plan 2022 to deliver the requirements of the ASDP. The HSU reviewed the Operational Plan on a weekly basis to ensure achievement of the plan. This programme of work was successfully achieved and the requirements of the ASDP 2022 met.

The following is a summary of the main elements of work conducted by the HSU in 2022:

- HSU Annual Service Delivery plan developed on time and implemented.
- HSU Operational Plan developed on time and delivered.
- HSU Corporate Plan Progress Report issued on time.
- HSU Corporate Risk Register reviewed and updated quarterly.
- Corporate Safety Statement reviewed six monthly and as required throughout 2022.
- HSU Monthly Reports issued on time.
- HSU carried out our duties following fatal accident in May 2023.
- A detailed review of the Health and Safety (H&S) Registers HSM01 to HSM12 conducted.
- H&S Generic Procedures HSSP21 to HSSP43 reviewed and updated.
- HSSP58 Working in the Sun (new procedure) developed and issued.
- DRAFT HSSP29 Events Management Procedure developed.
- Civil Defence documents added to the Online Health and Safety Manual.
- Health and Safety Management System (HSMS) Update online training delivered to all employees.
- VDU Audit conducted in May 2022 and report issued.
- Covid Induction Training delivered to employees in March 2022.

- Additional HSMS Training delivered to MD employees in March 2022.
- 5 x LASOG Meetings attended by Head of H&S
- National H&S Conference attended by HSU.
- 29 x Safety Briefings developed and delivered to all employees (2 x monthly and 5 for H&S Week).
- Quarterly defibrillator testing, maintenance and cleaning carried out. Testing changed to bi-monthly in Q4 due to maintenance requirements.
- New Defibrillators placed in Dartrey Forest and Rossmore Park.
- Quarterly consultation with each member of the Safety Committee and the COVID-19 Employee Representatives.
- A number of events delivered for Workers' Memorial Day in April.
- Daily events delivered for Health and Safety Week in November 2022.
- December Safety Link newsletter developed and issued with very positive feedback from employees.

Water Services

During 2022, Irish Water was rebranded as Uisce Éireann. They are responsible for the operation and maintenance of public water and wastewater services, including:

- Management of national water and wastewater assets.
- Maintenance of the water and wastewater system.
- Investment and planning.
- Managing capital projects; and
- Customer care and billing.

Every year, since 2014, a Service Plan has been agreed between Uisce Éireann and Monaghan County Council. This committed both parties to deliver specific objectives and compliance standards against a budget for payroll, goods, and services.

The Annual Service Plan has ensured service continuity to the customer, value for money and that water services complied with environmental and health standards.

Under the Rural Water programme Monaghan County Council is the Water Services Authority in relation to the supervision of Group Water Schemes and small private water supplies under the Drinking Water Regulations 2014.

Monaghan County Council administer payment of grants and subsidies towards the running costs of Group Water Schemes and grants for private water supplies - Well Grants - and Domestic Wastewater Treatment Systems.

The Water Services section also assists the council's planning department in transferring non-public water and Wastewater infrastructure within private developments to Uisce Éireann through the Taking in Charge process.

Future Delivery of Services

There were significant developments in relation to the Uisce Éireann /Irish Water

transformation program in 2022 following the publication of the Water Sector Transformation policy paper, Irish Water -Towards a National, Publicly Owned, Regulated, Water Services Utility.

The paper outlined a process within the Workplace Relations Commission (WRC), which will assist the parties to devise a mutually agreed operational framework to replace the existing service level agreements.

This engagement led to a Framework for Future Delivery of Water Services – which addresses staff concerns relating to the future delivery of water services.

The migration of public services from Monaghan County Council to the direct managerial control of Uisce Éireann will commence in 2023 and be completed by 2026.

The Councils responsibility regarding overseeing the Rural Water Program will be unaffected by this transition of public services.

Capital Investment Programme

National Water Resources Plan

Uisce Éireann commenced a three-month public consultation on the draft Regional Water Resource Plan – Northwest (RWRP-NW) in November.

The plan sets out options for providing a more secure, reliable, and sustainable water supply for 732,700 customers in the Northwest region over the next 25 years. The plan includes counties Cavan, Donegal, Galway, Leitrim, Mayo, Monaghan, Sligo and parts of Clare, Longford, Louth, Meath and Roscommon. Eight islands off the coast of Ireland are also included in the region.



New Wastewater Treatment Plant Castleblayney

Uisce Éireann National Water Resources Plan will be the first resources plan for the entire public water supply in Ireland. The National Plan will identify the needs across existing supplies and the challenges and opportunities that will be faced over the coming years including legislation, climate change, the environment, growth, and economic development.

The National Plan will allow Uisce Éireann to understand the actions and activities required to transform its water supplies and provide a safe, secure, reliable, and sustainable water supply for current and future customers. The National Plan will also provide a transparent roadmap on how Irish Water will plan for its water assets to align with national policy.

Leakage Reduction programme

Uisce Éireann approved the following schemes to go forward for design and construction in 2022.

Newbliss Mains Rehabilitation:

This mains rehabilitation scheme was to replace 2.80km of old 4-inch Cast Iron watermain with 125mm High Density Polyethylene (HDPE) pipe. The new pipework was commissioned and put into service in 2022.

Ballybay Road, Newbliss

This mains rehabilitation scheme involved the replacement of 2.35km of old Cast Iron watermain with new improved plastic pipes along the Ballybay Road from the outskirts of Newbliss village. The new pipework was commissioned and put into service at the end of Quarter 2, 2022.

With both sections now completed, all the cast iron watermains will have been successfully removed from the network which will benefit customers in Newbliss. The new and improved plastic pipes will strengthen and reinforce the water network. Customers will see an improvement to water supply in the area as well as fewer disruptions to water supply.

Castleblayney Main Street

This scheme completes the removal of the asbestos pipes from the town centre watermains. The project was commissioned and put into service at the end of Quarter 4, 2022.

With the new watermain installed, customers will see an improvement to water supply and less disruption.

Tullyhirm, Armagh Road, Monaghan

This scheme will go to design stage and construction next year, 2023. The project will remove the old 150mm diameter problematic asbestos watermain from immediately east of ulster canal road bridge after the Coolshannagh roundabout for 270m.

Carrickmacross Wastewater Treatment Plant Upgrade

Construction of a new 3.3 km final effluent pipeline extending from the Wastewater treatment plant to the Longfield River. These works also involve upgrade to elements of the existing wastewater treatment plant – including new final effluent and inlet pumping stations and a new access road off Oriel Road.

The works will increase plant capacity to 16,000 PE and bring the plant into compliance with the ELV. These upgrade works will improve operational performance and compliance with statutory legislation.

EPS have been appointed as the main contractor under a design and build contract and commenced in July 2022.

Drainage Area Plan – Monaghan Town

Uisce Éireann is continuing its work to safeguard wastewater services in Monaghan town by undertaking surveys of the existing sewer network in partnership with Monaghan County Council.

The Drainage Area Plan process is overseen by ARUP Consultants and involved CCTV surveys and installation of rainfall, flow, depth and conductivity monitors in the sewers and manholes as part of stages 1 & 2.

The data collected presents a clearer picture as to what defects and capacity issues exist in the sewer network and where future upgrades should be prioritised.

Consultants met with Roads and Water Services staff as part of stage 3 of the process.

Stage 4 Draft report is being prepared by consultants on behalf of Uisce Éireann. Several alternative solutions have been identified and high-level costings associated with same. Report to be finalised in coming months.

Wastewater Treatment Plant Works – IWSS Programme

Uisce Éireann Asset Delivery have identified a number of Wastewater Treatment Plants presenting with asset deficiencies.

These are being addressed as part of the Inlet Works Storm Sludge Management (IWSS) and National Certificate of Authorisation (NCAP) Programme.

Under Uisce Éireann Inlet Works Sludge and

Storm Programme works have commenced at Ballybay WWTP.

DBO contractor appointed in 2022, and contractor started works at the beginning of 2023

Planned works for Clones WWTP are at design stage.

Wastewater Pumping Station National Programme

The 98 Avenue Pumping Station in Clones was selected for review under the Wastewater Pumping Station National Program – Design Team appointed.

Solar Photovoltaic Phase 2 Programme

This project will involve installation of PV panels at MonaghanWWTP – the project is awaiting confirmation of funding.

INTERREG – Peace Plus

Shared Waters Enhancement & Loughs Legacy (SWELL) project

Uisce Eireann has been awarded funding under the SWELL Project. The EU-funded Shared Waters Enhancement & Loughs Legacy (SWELL) project aims to improve the quality of water in the Lough Erne catchment through the upgrade of wastewater assets on both sides of the border.

Ballybay WWTP and Clones WWTP are being earmarked for upgrade through this programme.

Both schemes are being progressed with a view to submitting a bid in Q1 of 2023.

National Telemetry Programme

Kilkitt Water Treatment Plant which supplies the Lough Egish Regional Water Supply Scheme has been selected by Irish Water to Pilot the rollout of its centralised national telemetry system. To date all telemetry systems are locally based and predate the establishment of Irish Water. The new system will ensure continuity and security for a modern water supply and wastewater system against the growing level of cyber security risk.

Small Towns & Villages Growth Programme

Small Towns and Villages Growth Programme is primarily intended to provide capacity in Irish Water Wastewater Treatment Plants (WWTPs) to cater for growth in smaller settlements which would not otherwise be provided for in the current Investment Plan.

Monaghan County Council has been allocated €1.238m funding under the Small Towns and Villages Growth Programme.

Monaghan County Council identified five settlements that have the least headroom in terms of capacity per Population Equivalent treatment and compliance with current discharge standards.

Oram Wastewater Treatment Plant had been identified for funding under this program. It is hoped that Newbliss and Clontibret will be considered for inclusion under tranche 2 of this national project.

Wastewater Pumping Station National Programme

98 Avenue Pumping Station Clones has been selected for review under the Wastewater Pumping Station National Program – Design Team appointed.

Rural Water Programme

The Rural Water Programme in County Monaghan is administered by Monaghan County Council.

The programme provides measures to address deficiencies in:

- Group Water Schemes
- Group Sewerage Schemes
- Private Water Supplies where no alternative group or public supply is available.
- Private Domestic Wastewater Treatment systems (DWWTs) whereby the applicant qualifies under the Housing (Domestic Wastewater Treatment Systems Financial Assistance) Regulations 2020.
- Private Water Supplies whereby the applicant qualifies under the Housing (Domestic Lead Remediation Grant) Regulations 2022.

Subsidies

Annual subsidies are administered by Monaghan County Council towards the cost of providing domestic water to group water schemes in the county. €4.83m in subsidy payments were made to twelve group water schemes in 2022 by the Local Authority.

Multi Annual Rural Water Programme (MARWP) 2019-2021

The 2019-2021 funding cycle of the multiannual programme consists of measures which reflect the key challenges currently facing the rural water sector - from catchment to consumers (source – treatment - distribution), to prevent water contamination and ensure that drinking water is safe and meets quality parameters of the Drinking Water Regulations on a consistent long-term basis.

This funding cycle is now complete. Department Circulars and guidance expected in 2023 for the 2022-2025 MARWP funding cycle.

Capital grant amount of €430,096 were administered to group water schemes in 2022 in the county under the MARWP.

Well Grants

Seven well grant applications were processed in 2022 by the Local Authority and €21,448 grant aid paid to applicants towards upgrade/remedial works or the installation of treatment systems to their private water supply.

Domestic Wastewater Treatment Systems

Under the Water Services Amendment Act 2012, Monaghan County Council undertakes inspections of private wastewater treatment systems. In 2022, under the National Inspection Plan (NIP) 32 domestic wastewater treatment system (DWWTs) inspections were undertaken by Local Authority staff resulting in 19 compliance notices and 13 advisory notices issued to households. 6 grant applications, amounting to &24,566, was paid for remedial/improvement works to DWTTS in 2022 to eligible applicants.

Grant applications relating to 2022 advisory notice requirements will continue to be submitted in 2023 by households as improvement works are completed and inspected.

Monaghan County Council also have responsibility for sampling and testing of private group water schemes and small private supplies. The results for 2022 show that the compliance rate was 98.9% out of 3026 parameters analysed. There were 34 exceedances noted throughout the year and HSE consulted, where relevant. Samples are taken at random locations in houses and businesses throughout each water supply within the county.

Environmental Protection

The Environmental Services section in Monaghan County Council is tasked with implementing EU and National Environmental Policy and legislation to protect the environment of County Monaghan.

In the Monaghan County Council Corporate Plan 2020-2024, the council committed to the promotion and protection of a clean, safe environment in a manner which is viable and sustainable, and to progressing the transition to a low carbon and climate resilient society as detailed in High Level Goals 1 and 12 respectively. The priorities and objectives for the Environmental Services section are outlined in Appendix III together with the performance standards to be met.

In summary the objectives include:

- Implement the County Monaghan Litter Management Plan 2021-2023.
- Implement the Connacht-Ulster Waste Management Plan 2015-2021
- Operate Scotch Corner Landfill in accordance with EPA Licence requirements.
- Implement the River Basin Management Plan 2018-2021 and associated Water Framework Directive requirements.
- Progress Climate Action measures as outlined in the Climate Change Adaptation Strategy 2019-2024.


Climate Action

During 2022 Monaghan County Council continued to progress the implementation of the actions contained in the Climate Change Adaptation Strategy 2019-2024 which was adopted by Monaghan County Council in September 2019. In October, Environmental Services submitted the second implementation progress report to the Eastern and Midlands Climate Action Regional Office demonstrated that considerable which progress was made in progressing the

measures and actions contained within the strategy and within the national Climate Action Plan.

Some of the milestones achieved to date include:

- In terms of energy usage, Monaghan County Council is among the best performing local authority in the country, having already achieved a 51.6% energy improvement by the end of 2021.
- Monaghan County Council was the first Local Authority to complete the full LED retrofit of its public lighting.
- Monaghan County Council continued to partner with CARO on the roll out of Climate change training programs for staff and members.
- New Border Energy Unit formed in 2022 in partnership with Leitrim and Cavan County Councils.
- Installation of additional solar litter bins in the county with 7 new solar bins provided in 2022.
- Construction of BER A rated homes by Housing Section.
- Construction of new BER A rated site office at Scotch Corner.
- Successful applications by Municipal Districts Under the Climate Adaptation and Resilience Scheme for Flood Alleviation Works.
- Funding to the value of €788K secured in 2022 for Bridge Rehabilitation for bridges damaged mainly by instream scouring from flooding rivers.
- Further to the Deep Retrofit Audit carried out in Q4 2021, a number of council buildings have been put forward to SEAI for Approval under the Pathfinder Project to carry out retrofit works.



In late 2022 the Government published the Climate Action Plan 2023. This new plan sets out a roadmap for taking decisive action to halve our emissions by 2030 and reach net zero no later than 2050, as committed to in the Programme for Government. Climate Action Plan 2023 sets out how Ireland can accelerate the actions that are required to respond to the climate crisis, putting climate solutions at the centre of Ireland's social and economic development.

A key component of the 2023 Climate Action Plan is that Local Authorities are required to prepare individual Climate Action Plans which will include both mitigation and adaptation measures, which are to be updated every five years. Local Authority Development Plans must be aligned with their Climate Action Plan. Whilst work on drafting the new Monaghan County Council Climate Action Plan (CAP) will commence during 2023, Monaghan County Council secured departmental funding in 2022 to carry out preliminary work including the provision of baseline emission data and a Climate Risk assessment both of which will help inform the development on the Monaghan County Council Climate Action Plan during 2023.



Waste Enforcement and Regulations

Waste Enforcement continued to be a challenge in 2022 with the improper management of waste continuing to be an issue both at local and national level. Again, in Co Monaghan in 2022 the dumping of diesel laundering waste was problematic with 21 instances of diesel laundering waste dumping in 2022 in the south of the county. The costs incurred in dealing with diesel wash waste in 2022 was €92,000 which was subsequently recouped from the Department of the Environment Climate and Communications.

Again, the work plan for our waste enforcement team during 2022 was prepared in line with the National waste enforcement priorities which were communicated to all local authorities via correspondence issued by the EPA in December 2021 which set the following priorities for 2022:

- Tackling significant illegal waste activity.
- Construction and demolition activity.
- End of Life Vehicle directive.
- Waste Collection at household and commercial level.
- Sites that require multi agency responses.

During 2022 there were three full time Waste Enforcement Officers in the County and in 2022 Monaghan County Council recouped €192.000 from the Department of **Environment Climate and Communications for** costs associated with waste enforcement activities. In addition, there was one full-time environmental patrol warden. As well as working on the national waste enforcement priorities staff were engaged on other activities such as the investigation of waste complaints, the processing of Certificate of Registration and Waste Facility Permit applications, the assessment of planning applications to ensure waste management compliance, and ensuring that waste activities taking place within County Monaghan are being carried out in compliance with waste management legislation through the appropriate certification and permitting regime.

In delivering on these priorities in 2022 Monaghan County Council completed the following:

- Carried out over 1,000 inspections.
- Investigated 344 waste complaints.
- Initiated 221 enforcement actions including the issuing of 69 waste warning letters, 16 notices under Section 55 of the Waste Management Act, 23 Fixed Penalty Notices under the Waste Collection Permit Regulations, and 54 litter fines under the Litter Pollution Act.

Water and Air Quality

During 2022 there were three full time environmental technicians working in water quality and air quality. In December 2021, the National Water and Air Priorities were forwarded to each local authority for 2022 through correspondence issued by the EPA. The water priorities for 2022 included:

- Pressures from agriculture (slurry/soiled water collection and storage)
- Pressures from agriculture (slurry and fertiliser spreading)
- Domestic Wastewater Treatment Systems / Septic Tanks
- Discharge Licences/Misconnections
- Local Priorities and Water Quality Monitoring

Under the 2022 RMCEI Enforcement and inspection plan that was prepared in February in line with national priorities, Monaghan County Council's water quality team continued its programme of water quality sampling in conjunction with the EPA, carried out investigative assessment work on selected river and lake waterbodies, undertook a farm inspection program, investigated a significant number of water pollution incidents, regulated effluent discharges through licensing, and worked with the Local Authorities Waters Program (LAWPRO) with the aim of improving water quality in areas designated as priority areas for action under the River Basin Management Plan which sets out the actions that Ireland is taking with the aim of improving water quality and achieving 'good' ecological status in water bodies (rivers, lakes, estuaries and coastal waters) by 2027. In October 2022,

Environmental Services secured €60K funding from the Department of Environment Climate and Communications to conduct additional farm inspection work. This funding was used to fund additional resources to assist in conducting this additional inspection work.



During 2022, 967 water quality related inspections were carried out including:

- 129 Farm inspections.
- 344 samples taken as part of Water Framework Directive monitoring on rivers and lakes.
- Investigation of 110 water pollution complaints/incidents.
- 37 Discharge licence inspections
- 25 bathing water inspections.

During 2022 our water quality team further progressed the Lough Muckno Road to Recovery project. Recent EPA Water Quality Reports had highlighted Lough Muckno as one of the most polluted lakes in Ireland currently. Under this phase of the project the aim is to complete a Paleolimnological study of the lake sediment to reference trophic changes and predict lake recovery times.

In light of the work being carried out on this project, in March, the Environmental Services unit, in response to the Public Consultation on the draft River Basin Management Plan for Ireland 2022-2027, formally requested the inclusion of Lough Muckno as a Proposed Area for Action in Irelands River Basin Management Plan 2022 -2027 as a "Catchment Project Area for Action" which will be led by Monaghan County Council and supported by the Local Authority Waters Programme.

In relation to air enforcement during 2022 over 60 routine air quality inspections were carried out under the Solid Fuels Regulations, the Petroleum Vapour Regulations, the Solvent Regulations and the Decorative Paints Regulations. By the end of 2022 the following facilities were regulated under the following air regulations.

- 29 car-refinishers were authorised under the Decorative Paint Regulation.
- 4 dry-cleaning facilities and one industrial premises were authorised under the Solvent Regulations.
- 25 petrol stations were authorised under the Petroleum Vapour Regulations.

Waste Management Facilities

During 2022 Monaghan County Council continued to operate a comprehensive recycling facility infrastructure network in the county comprising of two recycling centres at Scotch Corner and Carrickmacross and 26 strategically placed bring centres. The operation of the two recycling centres in the county is somewhat unique. Whilst the vast majority of local authority owned recycling centres operate at a loss, Monaghan County Council in 2022 continued to receive a significant income from the operator who runs both facilities at Carrickmacross and Scotch Corner on behalf of the council through the concession contract.

In 2022 Monaghan County Council retendered for the servicing of the bring site network with Glassco Recycling subsequently awarded the contract for an initial two-year period

In relation to the landfill facility at Scotch Corner further small-scale infrastructural improvements were progressed and completed on site including gas infrastructure upgrade works, surface water management works, leachate management, and additional groundwater and surface water investigations. During 2022 significant monitoring and sampling works continued to ensure compliance with our licence.

The most recent EPA site demonstrated that the Scotch Corner Facility was fully compliant under the terms of the licence with no noncompliances noted during the audit.

In 2022 works on the reconstruction of the new site office at Scotch Corner were substantially completed. The main contractor for these works was McCusker Contracts with significant input from local precast manufacturer Wright Concrete Products Ltd who constructed the modular building. This new building is a climate resilient structure which will provide for our requirements on site going forward in a sustainable manner.

Historical Landfills

During 2022 Monaghan County Council secured €100k funding from the Department of Environment Climate and Communications to progress further works under the Waste (Certification Management of Historic Unlicensed Waste Disposal and Recovery Activity) Regulations 2008. Under these regulations local authorities are required to conduct an environmental assessment of closed landfills that were previously operated by local authorities during the period 1977 to 1997. Works carried out in 2022 under the departmental funding included the completion of the Environmental Risk Assessment works at the Corkeeran site in Ballybay and the preparation of planning regularisation applications for subsequent submission to An Bord Pleanála for approval under Section 177AE of the Planning and Development Act for the Killycard (Castleblayney) and Killycronaghan (Smithboro) historical landfill sites.

Environmental Awareness

Monaghan County Council is committed to supporting local communities to promote, enhance and develop their local area. Environmental Awareness projects continued to be delivered to groups and schools during 2022, some of which included:

- Supports to Tidy Towns, Resident Association's and environmental groups through the annual Environmental Services funding programme.
- Repair, Reuse Demonstration Café in conjunction with the Rediscovery Centre and Connaught Ulster Regional Office
- Interactive awareness pollinator planting and tree planting with schools and groups.
- Dog Fouling and Anti-Litter Campaigns.
- Biodiversity Action Day with summer camps and Tidy Towns and Eanna Ní Lamhna
- Supports including litter pickers, bags and skips to groups for participation in Spring and World Clean Up Day
- Interactive projects with the Horticulturist including Little Acorns, Mighty Oaks grow, Gairdín an tSuaimhneas, Natural Habitat workshops

- Fast Fashion Workshop and Swap Shop with Comhairle na Nóg
- Supports to Agricultural Shows including Castleblayney Show and Tydavnet Show
- Continuation of the roll out of the Green School's Programme throughout the county.
- Provision of Electrical Recycling Days throughout the county

Veterinary Services

Food Safety

Monaghan County Council has a contract with the Food Safety Authority of Ireland (FSAI), to provide food safety control and support services to small food business operators in the county engaged in the slaughtering, processing and wholesaling of meat and meat products, ranging from fresh meat to ready-to-eat foods containing cooked meat. A list of food businesses approved by Monaghan County Council is available on the Council's website. In accordance with EU and national legislation, the Council employs veterinary inspectors to check animals before and after slaughter, audit the structural and operational hygiene standards in premises, and operate sampling and training programmes to assist owners and staff in attaining the required standards. The purpose of the service is to ensure the safety of the food produced by these food businesses, the welfare of the animals slaughtered and the safe and proper disposal of animal byproducts. In 2022, 602 cattle and 999 sheep slaughtered in Council-supervised were abattoirs in Monaghan. 74 inspections were carried out in 19 food businesses, and 37 samples were taken and tested for residues and hygiene standards. 4 new food businesses registered with the Council, one of which was required to be approved prior to registration. Three businesses ceased operating in 2022, one of which moved its operations north of the Border.



Dog Control Service

The Council employs one full-time Dog Warden for the county. Shelter facilities for the detention and care of stray and unwanted dogs are provided on behalf of Monaghan County Council by Carrick Dog Shelter in Lisdoonan. The number of dogs admitted to the Dog Pound in 2022 was 382, more than double the number admitted in 2021. This dramatic increase was mirrored in many local authority dog pounds across the country and appears to be related to the ending of pandemic restrictions and the increase in the cost of living, causing a collapse in the demand for dogs and an influx into Pounds of unwanted dogs. All but 3 of these dogs were either reclaimed or rehomed to members of the public or dog rescues. 2 dogs were put to sleep on suspicion that they had attacked sheep, and 1 was put to sleep as it had attacked children. The number of dogs licenced in Monaghan in 2022 was 5,961, a slight drop on the number licenced in 2021. Approximately one third of licences were bought online. The Council continued its advertising campaign to highlight the danger of straying dogs to sheep. The Council also continued its inspections of registered Dog Breeding Establishments (DBEs) within the county. 1 new DBE was registered in 2022. 2 others were deregistered, leaving a current total of 4 DBEs. One person was prosecuted and fined for operating an unregistered DBE.

Horse Control Service

The Council employs the services of Hungry Horse Outside, a horse charity based in Longford, to collect stray horses in the county. Three horses were seized by the Gardai in 2022 because they presented a danger to public safety. They were subsequently reclaimed by their owner. There were a number of other complaints investigated during the year relating to both stray horses and horse welfare, but no further seizures were necessary.

Fire & Civil Protection

During 2022 Monaghan Fire and Civil Protection (MFCP) maintained the delivery of a range of services for the citizens of Monaghan. These services included Fire Safety and Building Control functions, that encompasses implementing the statutory requirements of the Building Regulations and Building Control Regulations, inspection of new and existing building stock for compliance with fire safety requirements, licensing of filling stations, inspection of licensed premises, advice and enforcement under the Fire Services Acts and the promotion of fire safety in the community. Operational services encompassing both Fire Service & Civil Defence include; responding to emergency calls and providing Community Support, assistance to other emergency services, public safety and reviewing and enhancing Major Emergency Planning in consultation with the other Principal Response Agencies.

Operations

Monaghan is served by five retained fire stations at Clones, Monaghan, Ballybay, Castleblayney and Carrickmacross, providing an operational fire and emergency response service at all times. 2022 seen a return to relative normality in terms of an easing of various response protocols implemented to restrict the contagion of Covid 19.

Monaghan Fire & Civil Protection were mobilised to 326 incidents in 2022 a marginal increase of 3% on 2021 to first attending appliances, and a 2% reduction to 2nd appliance turnout.

In 2022 the top five incident types attended by Monaghan Fire Service were Road Traffic

Collisions, Monitoring Alarm Activations, domestic house fires, and tertiary fires (i.e. small fires/bin/skip). Road Traffic Collisions remain significantly high in recent years, while there has been a notable reduction in chimney fires in 2022.

The most notable incidents attended in 2022 involved an ammonia leak at Lough Egish Industrial Park which necessitated the evacuation of a number of business units and the deployment of Hazard Material management procedures and decontamination arrangements.

Training

The 2022 training programme returned to relative normality with a reduction in the extent of precautions associated with Covid 19.

Training completed included Flood First Responder, Emergency Service Driving Standard (ESDS), Hazmat and Emergency First Responder.

Workshops and training sessions were undertaken in 2022 to supplement the Wildfire Management Plan for Sliabh Beagh. Works will commence in 2023 with various interest groups and stakeholders.

The MoU with Northern Ireland Fire & Rescue Service for attendance at Road Traffic Accidents (RTA) in the border area has been utilised in 2022. The MoU sets out agreed geographical identifiers (townlands/roads) to secure the location of an RTA and the deployment of the nearest brigade.

Along with the provision of Critical Incident Stress Management, the Employee Assistance Service has been extended to Fire Personnel and provides support to extended family members.

Health & Safety

Following an Occupational Health and Safety Management System audit completed in March 2022, MFCP successfully retained ISO 45001 Accreditation. The audit outlined scope for improvement in terms of asset management and specifically the development of a system to enable the migration from hardcopy record keeping to a softcopy format. This process commenced in 2022 and will form the basis of our work programme for 2023.

Fire Safety - Fire Prevention

Our Fire Prevention Section reviewed and processed all valid fire safety certificate applications received and provided advice on achieving compliance with Part B of the Building Regulations (Fire Safety). Fire safety inspections were carried out on a range of building types including licensed premises, residential care homes, preschools, flats, petrol stations and community buildings. The conversion of various building types to multioccupancy residential buildings increased significantly in 2022 due primarily to the need to house people fleeing war in Ukraine.

Fire Safety Week focused on fire safety in the home and particularly encouraging all homes to have smoke alarms and ensuring they are tested weekly. Several intensive fire safety campaigns were held during the year, targeting elderly and vulnerable people, along with seasonal campaigns at Easter, Halloween, Christmas and Fire Safety Week. Campaigns involved the issuance of smoke alarms, while local and social media formed the focus of a very successful campaign during this time of Covid-19. A total of 241 Fire Safety & Building Control inspections were conducted in 2022, and 141 planning referral reports completed. All notified licensing referrals for pubs, clubs, dances etc were assessed by a fire officer and recommendations issued to the Courts Service. Performance Inspections resumed however they were restricted in 2022, desktop studies were carried out for 30 pubs/clubs around the county to check on fire safety management and ensure public safety.

Community Fire Safety

A range of fire safety initiatives were delivered focusing on both schools and community groups. Smoke detectors were distributed as part of the Community Smoke Alarm Scheme and the key messages of Carbon Monoxide Awareness Week and Fire Safety Week were promoted via local and social media platforms. The Primary Schools Programme was again delivered by a pre-recorded video, and we continued with a Fire Safety Poster competition for primary schools. Fire safety awareness information was issued to the Traveller Community.

Emergency Management

Severe Weather

The Severe Weather Assessment Team monitored a number of potential severe weather events during the year with regular briefings from Met Eireann, most notably Storm Dudley, Eunice and Franklin during mid-February, resulting in significant rainfall and high winds.

Major Emergency Management


The Cross-Border Emergency Management Group (CBEMG) launched, in March 2022, a multi-agency protocol for cross border notification to ensure procedures are in place to enable an effective response from agencies on both side of the border. A table-top exercise held in Enniskillen tested the protocol's activation, notification and communication process to ensure all relevant partners are familiar with the protocol.

Monaghan Fire & Civil Protection developed, in conjunction with the North-East Regional Emergency Planning Group, a Community Resilience Leaflet which was published in Oct 2022. The Leaflet was distributed via all three Principal Response Agencies and captures the key features of the National 'Be Winter Ready' campaign to raise awareness about the challenges facing the vulnerable members of our community.

MEM Exercise: MFCP completed a Regional MEM exercise in November 2022 to test our response capabilities, the objectives included:

- The testing of procedures to provide an effective interagency response.
- The evaluation of communication and media processes between PRA's and other organisations at a major incident.
- Exercising interoperability of all organisations involved.

The aim of the Multi-Agency Major Emergency Management Tabletop Exercise was to validate plans, systems, procedures, and training, and to identify practical measures to enhance the capability of all stakeholders. This successful exercise involved all relevant agencies (including cross border) working collaboratively to achieve the determined objectives.

Building Control

Monaghan Building Control Authority received a total of 210 valid Commencement Notices in 2022, a decrease of 29% from 2021, reflecting the impact of higher construction cost and inflation. An inspection rate of 42% of new builds was achieved this year. In addition, there were 69 applications for Fire Safety Certificates and 47 Disability Access Certificate applications under Building Control legislation. In 2022 all Building Control Regulation applications were completed via the Building Control Management System (BCMS). This process has significantly reduced the paper element involved in each application and a process has now commenced to digitise all existing legacy hardcopy applications.

Monaghan Fire & Building Control also returned to holding an Autumn workshop for local construction practitioners/agents, with over 30 attending. The topics covered included:

- National Building Control Office & Market Surveillance Office Overview
- Passive Fire Safety & Systems
- BCAR Inspection findings

The level of one-off houses 'opting out' of statutory certification has continued to remain relatively high. In opting out of the requirements for statutory certification the homeowner is making the decision to refrain from having their dwelling included on the Certificate of Compliance on Completion register.

Retention and Recruitment

The National Directorate for Fire and Emergency Management (NDFEM) undertook to review the delivery and sustainability of the local authority 'Retained' Fire Services, with particular emphasis on the recruitment and retention of staff. This resulted in a report titled "Retained Fire Services in Ireland - A Review of Recruitment and Retention and the Future Sustainability of Service Delivery" published in Dec 2022.

It is recognised that significant challenges face the fire service to both retain existing firefighters and to recruit new members. In essence the challenge involves balancing the organisational requirement and ability to respond, with the requirement to improve working arrangements for individual retained firefighters. The implementation of the recommendations of this review will progress in 2023.

In 2022 MFCP had 4 fire-fighters resign, the overarching reason for the resignations was due to the lack of flexibility and continuous availability commitment required.

Capital Investment

There was again significant capital investment in MFCP during the year with the delivery of 2 No. 4x4 crew-cab vehicles, and the award of a new fire appliance for Carrickmacross Fire Service.

The replacement of new appliance bay doors was completed in Carrickmacross Fire Station and a similar door replacement process to commence in Clones Fire Station in early 2023.

Approval was also secured to seek tenders for the construction of a New Fire Station in Ballybay.

Monaghan Civil Defence

Civil Defence activities in 2022 focused on our local community, and particularly the accommodation and support for those fleeing the conflict in Ukraine. Tasks, undertaken by Civil Defence volunteers, included:

- Rest Centre: Providing accommodation welfare facilities for 40 people.
- Transportation duties: Including the transfer of persons from accommodation centres to other locations.
- Medical cover at outdoor events & Irish Blood Transfusion Service.
- Helping vulnerable persons within communities by delivering food and medication and collecting their post during spate conditions.
- Delivery of essential Training & Maintenance

Monaghan Civil Defence HQ accommodated 40 persons during the initial stage of the war in Ukraine. During this period all primary agencies utilised Civil Defence HQ to ensure the safety and protection of all refugees. The commitment of Monaghan Civil Defence Volunteers was acknowledged by the local Ukrainian community in Oct 2022 at a celebratory event held in Teach na Daoine, Monaghan.

The Civil Defence HQ building continued, in 2022, to provide a hub for local community support deployment and to assist Principal Response Agencies during severe weather events, pandemics and other emergency response requirements.

Community Development

Local Community Development Committee (LCDC)



Monaghan LCDC plays a coordinating role at county level helping to ensure that there is a

coherent approach to local and community development in the county managing various programmes including SICAP, LEADER, PEACE, Community Enhancement Programme and Healthy Ireland Fund.

Local Economic and Community Plan (LECP)

In 2022 the LCDC commenced work on preparing a new six year Local Economic and Community Plan for the years 2023-2027. The new plan will build on the lessons learned from the previous LECP cycle, as well as reflecting the current needs of the county.

Social Inclusion Community Activation Programme (SICAP)

SICAP provides social inclusion support to disadvantaged individuals and groups throughout the county. The 2022 budget for the delivery of the SICAP Programme in Monaghan was $\in 683,136$. An additional budget of $\notin 53,080$ was provided to support the Ukraine refugees who arrived in county Monaghan.

MONAGHAN LEADER Programme 2014-2020



Monaghan LEADER aims to develop sustainable rural communities throughout the county, by promoting social inclusion, economic development and stimulating

Enterprise, Tourism, and Community Services.

Monaghan LCDC is the Local Action Group (LAG) and is the decision maker in respect of project applications. The LAG met 8 times in 2022 and approved 16 projects recommended by the IEC members, with a total value of €695,873.13.

2022 was the last year of the current LEADER programme. In total €6,872,946.94 of grants were administered to 132 projects.

In 2022, the European Union Recovery Instrument (EURI) budget allocated to the County of €517,685.25 was also administered benefitting a further 8 projects.

DRCD Rural Funding Schemes

A total of €3,118,077 was allocated to Monaghan County Council in 2022 by the Department of Rural & Community Development.

CLÁR

CLÁR is a targeted investment programme that aims to provide funding for small infrastructural projects in rural areas that have experienced significant levels of depopulation.

The 2022 programme was delivered through two separate Measures as follows:

Measure 1: Developing Community Facilities & Amenities (€660K allocation funding 15 projects).

Measure 2: Mobility, Cancer Care and Community First Responders Transport (€66K allocation funded a wheelchair accessible vehicle).

Peace IV

PEACEPLUS

Preparations are being made for the commencement of the new PEACEPLUS programme which is due to be launched by SEUPB in 2023.

The new PEACEPLUS programme will run until 2027. A new PEACEPLUS partnership board has been formed. The new board is made up of County Councillors, state agency representatives and social partners.

Monaghan Age Friendly Programme

The Monaghan Age Friendly Programme continued to work towards creating the kinds of communities in which older people in the county live autonomous, independent and valued lives.

Monaghan County Council continued to facilitate meetings of our Older People's Councils and Age Friendly Alliances in 2022. Seamus McDermott was officially confirmed as the Age Friendly Ambassador for Monaghan at the Launch of the Croke Park Age Friendly Stadium in May.

Joint Policing Committee Initiatives

The Council continues to support the countywide Don't Pour Your Dreams Away anti-drinking campaign, which is targeted at Junior Cert result recipients.

Funding was also secured to run a women's safety conference in partnership with Monaghan PPN.

Tidy Towns

Co. Monaghan entrants continued to show well in the National Tidy Towns competition, with all groups improving their marks on 2021. The Community Department provides support to Tidy Towns groups through the organisation of network events and activities.

Glaslough was selected to represent Ireland in the international 'Communities in Bloom' competition 2022. The judges visited over a two-day period in July and were met by Council staff and MD elected members. Participating towns are awarded a rating of up to five blooms. The awards were announced in Vancouver in October. Glaslough received five blooms.

Healthy Monaghan

Round 3 of the Healthy Ireland Fund came to a close in 2022.

Work commenced on planning for Round 4 of Healthy Ireland Funding with consultations and research to inform a new Healthy Monaghan Fund Strategy 2023-2025 commencing in October 2022.

Monaghan Comhairle na nÓg 2022

Monaghan Comhairle na nÓg, with support from Monaghan County Council, is the main link through which the local authority engages with young people across the county. In 2022, the Steering Committee worked on the topic of The Environment and aimed to spread awareness to all young people living in the County and to change things for the better.

Monaghan Public Participation Network, with support from Monaghan County Council, is the main link through which the local authority connects with the Community, Social Inclusion and Environment Sectors across the county. Over 600 groups were registered with the PPN by the end of 2022. 54 community representatives represented the PPN across 16 various decision-making committees, putting the community firmly at the heart of local decision making. Thirteen new PPN representatives were elected in 2022.

The PPN delivered training programmes; and public consultations throughout the year with the secretariat meeting on six occasions.

The MWA successfully accessed funding from DHLG for three projects that will take place in 2023/2024, and they are also working in conjunction with the Western Midlands Northern Regional Caucus (WoMeN's Regional Caucus) to deliver three more projects which will help them in their role as public representatives.

Monaghan Sports Partnership (MSP)

After two years of huge limitations faced by the impact of Covid-19, MSP was delighted to be able to return to regular activities in 2022. MSP delivered over 100 programmes and initiatives to keep our communities active during 2022.

Community-based Programmes:

- MSP relaunched the 0-3k Walk to Jog programme in February 2022.
- In Spring & Autumn, MSP returned to facilitating numerous Active Adults (50+) activities in various locations across the county.
- In Summer 2022, MSP facilitated several outdoor community-based activity programmes. These activities included Open Water Swimming, Outdoor Yoga, Outdoor Bootcamp, Get into Golf and Women on Wheels among others.
- MSP also organised *Learn to Cycle* programmes for children to teach them the basic skills of cycling.

Steps Challenge

Members of staff and elected members were invited to register for a 6-week challenge to increase their step count each day and were issued with a step counter to record their progress.

Go All Out – Inclusive Outdoors Week

This year marked the first ever *Go All Out Inclusive Outdoors* Week. The initiative was developed by CARA (Sports Inclusion Ireland) and the purpose was to increase the capacity of sports organisations and groups offering activities to people of all ages with disabilities and giving them added opportunities to increase their physical activity levels.

'HER Outdoors' Week took place in August 2022 and it aims to encourage more females to get out and enjoy the benefits of being in the outdoors. MSP facilitated several events across the county, working with several organisations and NGB's.

Supporting National Events/ Initiatives

Monaghan Sports Partnership supported numerous events and initiatives across 2022, including Women In Sport Week, National Bike Week, Social Inclusion Week.

Children & Young People

MSP provided several new initiatives for primary school aged children. Some initiatives included: the Marathon kids programme, Skipping workshops, Orienteering event day, Volleyball and Little Athletics 4-week programme

Playground upgrades were completed in 7 primary schools across the county with more schools planned for 2023.

MSP also provided Cycle Right training in 4 DEIS primary schools in 2022 and facilitated a weeklong Learn to Cycle programme for children in St. Patrick's Accommodation Centre in Monaghan.

Inclusive Sport & Physical Activities

As part of MSP's continued work with the adult disability day services, the following programmes were delivered in 2022:

• 2 six-week Soccer Skills programmes

- Activator Poles programme in 3 separate day services
- Day Services six-week Scorebowls league
- Inclusive Games for Life programme attended regularly by service users from 6 separate day services.
- MSP also sourced and provided 5 disability day services with tricycles

MSP worked with several external partners in 2022 to provide opportunities for children with disabilities to participate in sport and physical activity. Programmes facilitated in 2022 included:

- 2-day *Football for All* Camp in conjunction with the FAI and Cavan Sports Partnership
- Football for All programme delivered in 5 primary schools
- Inclusive Cycling delivered in 4 primary schools across the county
- Community-based Inclusive Cycling programmes delivered in Carrickmacross, Clones and Monaghan towns
- 2-day Inclusive Multi-Sport camp delivered at The Peace Link, Clones

MSP, in partnership with the HSE Mental Health Occupational Therapy (OT) Team delivered a 12-week Woodlands for Health programme in early 2022. MSP again linked in with the HSE Mental Health OT Team to deliver a *Games for Life* programme in late 2022.

2022 saw the introduction of the Kilmore & Drumsnatt Sports Activity Hub funded through the 2021 Dormant Accounts fund delivering a huge number of activity programmes. In total over 800 participants engaged in hub activities in 2022.

Offer a Home – Ukrainian Refugees

National and local government collaborated in a call for offers of unoccupied houses, apartments, and holiday homes for use by those fleeing war in Ukraine. Monaghan County Council has assigned staff to work on this project and a number of families from Ukraine have been placed into pledged accommodation.

A Ukrainian Community Response Forum was established by the Community Department. The forum ensures that a co-ordinated approached is adopted to providing supports to those who have recently moved into the county.

The Municipal District of Ballybay-Clones

Roads Programme 2022

In 2022, Ballybay-Clones Municipal District undertook a substantial programme of road infrastructural development. The Municipal District carried out drainage, bitmac overlay and surface dressing works on five local roads and three regional roads in the district to the value of €2.7 million under the restoration improvement grants scheme. There were a further 30km of roads surface dressed throughout the Municipal District. The Municipal District also undertook extensive general repairs/maintenance to the road network in the district such as gully repairs/cleaning, road patching, hedge cutting, sweeping and scavenging.

Low Cost Safety Improvement Works

Low cost safety improvement projects were completed in 2022 at Cladowen/Clonvilla on the R183 and also on the R188/L6320 junction at Carsan/Dartrey.

Rural Regeneration Development Fund Projects Clones

Ballybay-Clones Municipal District previously prepared substantial applications for the towns of Clones and Ballybay and were successful in obtaining funding for both towns.

The Clones Town project includes projects entitled Fermanagh Street Business Hub, Heritage project and St. Tiarnach's Plaza.


Together with match funding, there is funding of €0.5M to develop these projects to a construction ready stage. This funding includes for feasibility studies, property purchases, design process and the planning stage.

Consultants have been appointed for all 3 projects and substantial progress in advancing these projects was made in 2022.

Ground Investigation is completed at St Tiarnach's Plaza. This has allowed for the completion of the detailed design stage. Required lands have also been secured.

Lowry Construction has completed works to the former Lennard Arms. These works consisted of stripping out the building and asbestos removal.

The Municipal District office submitted an application for funding under Category 1 of the Rural Regeneration Development fund for the next phase of works for the development of a visitor centre/museum – the Clones Monastic Centre.

Detailed design stage for both the Heritage and Fermanagh Street Business Hub projects has been completed. Part 8 Planning has been secured and the Municipal District has completed required land acquisitions/purchases.

Rural Regeneration Development Fund Project Ballybay

After a series of meetings with housing and planning section of Monaghan County Council a Master Plan was developed for Ballybay courtyard site. It includes 36 car parking spaces and 7 residential units. Works have been completed on the car park and the 7 residential housing development is currently at construction stage, with an anticipated completion in Q2 2023. The completed development will increase off street parking in Ballybay Town along with an increase in the number of Social Housing available.

Greenway Smithborough to Clones

Ballybay Clones Municipal District were successful in securing funding through the Carbon Tax Fund 2020 for €100,000 to further develop the proposals for the provision of a Greenway from Smithborough to Clones building on the feasibility study that was completed in mid-2019.

Clandillon Civil Consulting were appointed allowing for the completion of environmental studies, and route selection options. Extensive public consultations were undertaken prior to preferred route selection.

The consultant's work is substantially completed. Following an additional procurement process, the Council has now appointed McAdam consulting Engineers to advance the project to the next phase, i.e. preliminary and detailed design and securing all necessary statutory approvals. This work is currently ongoing and is scheduled for completion in Q2 2023. Further funding has been received in 2023 to advance further phases of the project.

Ballybay to Castleblayney Greenway

The Ballybay – Clones Municipal District, and Carrickmacross – Castleblayney Municipal District previously agreed jointly to fund a consultant to carry out a feasibility study and constraints report for a proposed greenway along the line of the old railway between Ballybay and Castleblayney, connecting Doohamlet. Funding has been secured under the Departments Outdoor recreation infrastructure programme to advance the project to the route selection and environmental assessment stages. The procurement process for these stages is currently ongoing.



Drumfaldra Culvert Replacement

In 2021 the Municipal District of Ballybay-Clones received funding from OPW, and additional funding from the Department of Transport Climate Adaption and Resilience Fund to replace a defective culvert at Drumfaldra Ballybay to alleviate flooding of the road and properties. A Section 50 application to the EPA was successful, the works were completed in Q2 2022.

Ballybay Outdoor Recreation schemes

The Ballybay-Clones Municipal District received further funding for projects under the Outdoor Recreation Infrastructure Scheme in 2022 to the value of approximately €200,000. These projects were aimed at improving recreational facilities at a number of different sites in the area. The works involve the upgrade works to the Ballybay Town Park which resulted in a safer access route to the park from the Castleblayney Road entrance, additional fencing requirements and a new beach area for Community Events to take place. There were also allocations to upgrade the Boat House to provide a storage facility for boating equipment and improve parking facilities at the Killyvaghan Lake for anglers to park in a safer manner.

Town and Village Renewal Projects

The Municipal District obtained funding under the Town and Village Renewal programme and TII to underground the overhead electrical cables at Cara Street in Clones. This project includes for the removal of cables in the vicinity of the Round Tower and the installation of new public lighting columns to the street. As part of this project, the Municipal District appointed DBFL consulting Engineers to undertake a comprehensive review of traffic movements and flows within the town. This report is currently at draft stage. Under this project 6 additional parking spaces have been provided in Fermanagh Street. These works will be completed in Q1 2023.



Cara Street Town & Village Programme

The Municipal District has obtained funding under the Town and Village Renewal programme to deliver a Streetscape enhancement project for Fermanagh Street, Clones. This project consists of providing assistance for property owners to improve the facades of their buildings. It is also proposed to provide a micro park and mural to the Fermanagh Street carpark entrance. Following a procurement process Craftstudio Architects have been appointed to provide the required technical expertise. This project is due for completion in Q3 2023.

The Municipal District has obtained funding under the Town and Village Renewal programme to develop Village plans for Rockcorry and Drum villages. Following a procurement process, the Municipal District has appointed Sheridan Woods Architects to deliver this project. Extensive public consultation and engagement is planned. This project is due for completion in Q2 2023.

Active Travel Proposals

With funding secured both through Clár and Active Travel, traffic calming measures were put in place in Corcaghan. It included the provision of a footpath from the school to the church and flashing beacons to warn motorists of the school. To the north and south of the village the works included driver feedback signs to warn of the speed limit. A colored road surface highlights the entrance to the village and traffic islands have been placed along the road edge to slow down traffic.

There is a wide range of Active Travel Projects being carried out in County Monaghan. The Ballybay-Clones Municipal District is currently managing 6 projects in Clones, Ballybay, Lough Egish and Corcaghan.

The Lough Egish Junction Realignment Scheme is currently under review for approval by the NTA and has an approximate cost estimate of €1.2million. This project will not only enhance the safety at the Lough Egish Junction but improve the pedestrian facilities throughout the village. The R162 Active Travel Project at Monaghan Road and Old Keady Road Junction, Ballybay, is currently nearing completion. The value of this project is approximately €500,000. These works involve the installation of new public lighting scheme, realignment of the existing junction and the installation of a new footpath to connect the Cuan Mhuire Facility to Ballybay Town Centre.



Preliminary design has been completed for the proposed new Municipal District Depot in Clones. This is a bespoke facility that will serve the needs of the outdoor staff. The project is funded by the Council's own resources. Part 8 planning permission was granted in Q1 2023. The project is now proceeding to detailed design stage.

O'Neill Park & Corrybrennan Park Playground

The Municipal District of Ballybay-Clones secured further funding from the Department of Children and Youth Affairs to repair and upgrade the existing playground facilities at O'Neill Park Clones. This project complements the works already completed in 2021 and consists of the refurbishment of the existing play equipment and the replacement of wet pour surfacing. The estimated cost of the works was €45,000. Works were completed in Q3 2022.

Funding in the amount of €220,000 was secured to design and install a new play area for children within the locality of Corrybrennan & Culbrennan. A playground design workshop, held in February 2023, with works due to commence in September 2023.

Community Actions

The Municipal District provides funding to and works closely with the community & local groups to identify potential investment and improve service delivery.

Phase 2 of the Ulster Canal Restoration was officially initiated with a contract signing in Clones. The contract was signed by Chief Executive of Waterways Ireland, John McDonagh and Managing Director of Jons Civil Engineering Company Ltd, John Pentony, in the presence of Minister for Housing, Local Government and Heritage, Darragh O'Brien TD and Minister for Rural and Community Development, Heather Humphreys TD. The project will involve the development of a new marina, two new access bridges, repairs to an existing masonry arch bridge, and a sustainable water supply. It will also include approximately 1km of restored canal and towpath, with a looped walk and an amenity area on the route of the 180-year-old Ulster Canal in Clones. The amenity area will include car parking, bus / trailer spaces, a service block and picnic area and will be connected to the town and the existing playground. This phase of the project is expected to be completed in 2023.

Road Infrastructure

In 2022, the Municipal District (MD) managed an investment of €4.68million in the Regional and Local Road network. Some 16km of the nonnational road network was strengthened under the Restoration Improvement Programme and a further 24km was resealed under the Restoration Maintenance Programme. The MD also oversaw improvement works to 2 No. Local roads under the Community Involvement Scheme, whilst the Climate Adaptation and Resilience Works Programme 2022 provided for a mixture of design and construction works across 4 No. schemes.

Funding received under the Lower Cost Safety Scheme enabled the implementation of safety improvement measures at 5 No. locations within the District, and monies secured under the Former National Road Rehabilitation Grant provided for 850m of resurfacing and drainage works on the LP4922, Ardee Road, Carrickmacross.

Active Travel

The MD continued to work closely with the Active Travel Unit throughout 2022. There are currently 7 No. projects on going in the District, with a combined value of circa €500,000.

Regenerating our Town and Village Centres

The MD remained actively involved in facilities investment throughout 2022. In Castleblayney Town, the construction of "The Ridge" Enterprise Hub continued apace, with works due to be completed by the end of Q1 2023. A joint initiative with Castleblayney Community Enterprise and Enterprising Monaghan, the 1,350 sqm facility will provide a 28-unit business hub.

In Carrickmacross, a contractor has been appointed for the Design and Build of the C:TEK II Co-working Enterprise Hub. At a total estimated cost of €3.8 million, the project shall realise the delivery of a new 1,450sqm Co-Working Enterprise Hub. The Hub will provide workspace for business start-ups, re-locating enterprises and co-workers seeking to locate in Carrickmacross Town. The development will support talent retention within the South Monaghan area, provide a regional base for former commuters, and attract new start-ups from within the community and Northern Ireland. It is envisaged that site works shall commence in early Q2 2023.

Investing in Public Spaces

Inniskeen Village Public Realm Spatial Plan:

Following extensive consultation with community partners and the wider public, the MD, in conjunction with The Paul Hogarth Company, developed a Public Realm Spatial Plan for the village of Inniskeen. The Plan provides a framework of coherent measures to re-establish the village as a place for people, through the enhancement of key urban spaces, rationalising access and car parking challenges, and the development of pedestrian and cyclist linkages within the village. The Plan has provided the platform to secure funding of €250,000 under the Town and Village Renewal Scheme for public realm, heritage and amenity enhancements to the Village Heart and St. Mary's Space areas of Inniskeen Village. It is intended to commence construction in Q2 2023.

In late 2022, the MD was successful in the receipt of funding for the development of a greenspace masterplan for the Gallows hill area in Carrickmacross Town. It is intended that the Plan shall provide a framework of measures to deliver a new, usable, high quality and accessible public green space and amenity area to the northern end of town. The Plan is scheduled for completion in early Q2 2024.

Tourism Initiatives & Outdoor Recreational Amenities

The MD continues to work collaboratively with the Tourism Officer to deliver tourism initiatives within the District. In 2022, the Team commenced the phased redevelopment of The Monaghan Way walking trail from Castleblayney to Inniskeen. It is anticipated that the overall upgrade works shall be complete by the end of May 2023.

In Castleblayney, Monaghan County Council is seeking to develop Lough Muckno and the Hope Castle demesne as a significant regional attraction. In October 2022, the Council initiated a feasibility study to help shape proposals for the site.

Elsewhere, funding received under the Outdoor Recreation Infrastructure Scheme (ORIS), enabled the completion of the following projects in 2022:

- The installation of a "Poetry Jukebox" and amenity seating at the river front in Inniskeen Village
- The provision of a Public Information digital notice board, walking trail maps and public seating in Castleblayney
- The development of a Dog walking park at Drummond Otra, Carrickmacross
- Phase 1 Biodiversity and Pollinator measures at Tullynaskeagh East & Gallows' Hill
- The completion of the Lough na Glack/Ardee Road/Town Centre walking loop in Carrickmacross Town
- The development of Onomy Walk and Exercise Trail - 720m long nature-based walking trail, interspersed with items of recreational exercise equipment.
- The construction of an Outdoor Education Space at the Point, Black Island
- The enhancement of 5 No. walking routes in Carrickmacross Town and environs

The MD also secured funding under the ORIS 2022 to realise the continued development of outdoor recreational facilities during the period 2023-2024. Schemes include:

- The maintenance and upgrade of existing fishing pegs/stands along developed angling stretches at Lough Muckno including, localised vegetation clearance and pathway repairs to enhance accessibility.
- The development and upgrade of existing angling facilities at Lough Nagarnaman.
- The upgrade and development of angling and boating facilities at Rahans Lake.
- The upgrade of trails on Black Island in Lough Muckno Park.

Community Actions

Community-based CCTV Schemes - MD staff progressed the development of CCTV schemes for both main towns in the District, to the point where it is hoped that these schemes will become operational in the latter half of 2023.

Tidy Towns and Community Groups - The MD supported these groups by way of financial contributions and the provision of logistical assistance throughout the year.

After a two-year hiatus, Summer 2022 witnessed the long-awaited return of community-led festivals to the towns and villages in the Municipal District. Both the Carrickmacross Street Festival and Muckno Mania attracted huge audiences to enjoy a diverse range of activities and events.

Throughout 2022, the MD engaged regularly with both the Carrickmacross Chamber of Commerce and Castleblayney Town Regeneration Team to foster economic growth in both towns. These groups assist in the development of local strategies and provide valuable feedback on proposed initiatives.

Municipal District Meetings

The Municipal District hold their monthly meetings on the third Monday of every month. At our AGM in June, Cllr. Raymond Aughey was elected Cathaoirleach and Cllr. Cathy Bennett was elected Leas-Cathaoirleach for one year. There was a number of other subcommittee meetings to discuss roads, budgets and other issues and programs within the district. The Schedule of Municipal District Works was presented and approved at the March Meeting.

Municipal District meetings were held out in the communities of Glaslough and Ballinode in 2022 with future meetings to be held out in the community in 2023. This allowed for presentations and interactions with community members and the ongoing projects within the communities to be showcased.

Historic Towns Initiative

MCC was successful in obtaining grant funding under the **Heritage Town Initiative** which aims to re-establish residential use in our towns. This will entail external conservation works to eight buildings and internal refurbishment to two buildings for residential use in Dublin Street. This project will be scheduled over 2022-23. Grant funding of $\leq 247,952$ - Municipal District has agreed to match fund this grant. $\leq 12,300$ for the preparation of the initial application and $\leq 22,400$ to engage Conservation Architects to agree design approach, preparation schedule of works and tender action for the external works of the 8 buildings involved.

Roads

2022 Roads Restoration Improvement Program

Drainage works commenced in the Monaghan MD in February. A total of 9.5km of Local roads and 1.6km of Regional Roads were drained and resurfaced in the Monaghan MD under the Road Restoration 2022 program.

2022 Surface Dressing Program

A total of 23km of Local Roads and 4.2km of Regional Roads were surfaced dressed in the Monaghan MD under the Restoration Maintenance 2022 program.

Safety Improvements Works

Low-Cost Safety Schemes Signage was completed at Edenmore School. Hedges removed to improve visibility splays at Drumlester Crossroads, and at a bend at Derrykinnigh More, and adjacent to Garron National School.

Climate Adaption and Resilience Grant

An allocation of $\leq 100,000$ was received for the L1413, Plantation Rd Culvert under the Climate Adaptation and Resilience grant. This project is also to be funded by other grants plus MCC funding, total funding ≤ 500 k. This scheme was detailed designed and tendered in 2022, and it is planned to go to construction in 2023.

Road Maintenance

Drainage works were completed on regional and local roads throughout the year. Two verge grass cuts were completed on National Roads which included litter and Ragwort removal in 2022 program. A program of hedge cutting works was also complete on MCC own property.

A large patching, road repairs contract was completed on regional and local roads. Road marking contracts were also completed to renew line markings.

Financial Supports & Job Creation

In 2022 circa €400,000 was approved in grant aid with a potential to create an additional 45 jobs.

Training

The focus for 2022 was to provide an elevated level of relevant supports and services to encourage and foster new start-ups. LEO Monaghan continued to prioritise aiding existing businesses to expand and grow and face the increasing number of challenges, including Brexit, re-emerging from the Covid-19 pandemic, sustainability and the economic impacts of the war in Ukraine.

In 2022, nearly 1000 entrepreneurs and aspiring entrepreneurs participated in 77 training courses / workshops with Monaghan LEO. The above figure includes 7 Start your own business courses.

Mentoring

Under the Local Enterprise Office Mentor Programme, clients work with an experienced mentor who identifies solutions in areas of exposure within their business. The mentor programme continues to operate very successfully, with feedback from the participants extremely positive, highlighting the importance of non- financial supports to micro businesses.

The LEO's mentoring service is designed to complement the enterprise training and management development supports on offer. The panel of mentors includes experienced business advisors across a wide range of management disciplines. One to one mentoring was delivered to 130 clients in 2022.

Lean for Micro

There has been a substantial increase in the demand of the LEAN for Micro initiative, which is one of the main support tools devised to enhance

productivity and efficiencies within organisations. LEO Monaghan approved 14 micro businesses with the LEAN for Micro offering.

Trading Online Vouchers

The Trading Online Voucher offers eligible businesses 50% of eligible expenditure up to a maximum of €2500 towards the cost of building a new or updating an existing ecommerce website. In 2022 there continued to be a strong demand for this initiative and 28 vouchers were approved.

Green For Micro

As climate action and sustainability continue to be the new norm, Monaghan LEO were at the forefront of adaption planning and awareness building of Monaghan businesses to encourage the transition to low carbon entities.



A novel 'Go Green'- climate action series was designed to support businesses as they transition to low carbon entities. Over 90 businesses attended these events, which ranged from sector specific to narrow focused topics and all had the focus of decarbonising.

This series complemented the Local Enterprise Office Monaghan's Green For Micro support and with the aim of further increasing the capacity and peer learning amongst stakeholders.

In addition, 18 businesses were approved for the Green For Micro initiative enabling businesses to get a measurement of their carbon footprint and some recommendations on how to reduce same and/or to make their business more sustainable.

Student Enterprise Awards

Every September through the Local Enterprise Office Monaghan, entrepreneurial secondary school students begin their business journey to research, set-up and run their own real-world businesses as part of the Student Enterprise Programme.

The programme complements the business studies curriculum at both Junior and Senior level and is a rewarding experience for students, giving them the freedom to develop their business concepts to the fullest. Students can enter either individually or as part of a team.

More than 600 students from 10 schools across County Monaghan took part in the 2022 programme.

Monaghan has had much success over the years. In 2022 there were 5 schools that went through to the National Finals with one student Jesse James Stewart, from the Patrician High School winning an award for the Best Commercial Potential Award in the Junior Category.

Local Enterprise Awards

The Monaghan Enterprise Awards took place as part of a very successful Local Enterprise Week programme of events.

Sean McCleary and Nikita McCrory from Streat School Ltd in Glaslough were the overall winners of the Award for 2022. Streat School went on to represent Local Enterprise Office Monaghan at the 22nd National Enterprise Awards at the Mansion House in Dublin on 2nd June.

Other winners at the virtual Monaghan Enterprise Awards held online on Friday 11th March, included Juno Composites Ltd. for Innovation, Ramfit Ltd in the Export category, The Kick Company for Sustainability, Old Carrick Mill Ltd. for a Pivot award and Gillanders Town and Country for Ecommerce. Best Established Business went to Streat School Ltd and Best Start up went to Glaslough Chocolates.



The engagement objective was to determine the level of understanding and awareness of Digitalisation in the role of competitiveness of Micro and SME's and the outputs will enable enterprise development agencies to determine where the gaps in support are.

Corporate Services

Corporate Services provides support to Senior Management, the Cathaoirleach and Elected Members. It is also responsible for the organising and managing of monthly Council Meetings, Corporate Policy Group Meetings and Joint Policing Committee Meetings. The section is responsible for the collation of the Corporate Plan, Annual Report, Annual Service Delivery Plan, Monthly Management Report and the review of Risk Register.

Corporate Services also co-ordinates the compilation of the annual NOAC Performance Indicators for the Council and has a significant role in terms of governance, ensuring the Council is compliant with the Ethics Framework, Children First Act, General Data Protection Regulations (GDPR), Freedom of Information and Access to Information on the Environment legislation.

Register of Electors

The Electoral Reform Act 2022, the first significant programme of reform in 40 years, was signed into law by the President on 25th July 2022 and brings about much-needed major modernisation of the electoral system, making voter registration easier and more accessible while strengthening the integrity of the process.

The new Rolling Register, one continuous register that can be updated at anytime, replaces the Annual Cycle of Draft, Live and Supplement Registers.

Electors apply to the registration authority to be included or update their details at any time, using a single online application at <u>www.checktheregister.ie</u>, though a paper form will remain available for those who wish to use it.

Total number of electors for Register 2022-2023 was **50,587**

Freedom of Information

Under the Freedom of Information Act 2014 members of the public have a legal right of access

to records held by the Local Authority. **38 requests** were received by the Council in 2022, from members of the media, Oireachtas, business reps and the general public.

Access to Information on the Environment

AIE gives legal rights to those seeking to access information on the environment from public authorities. 8 requests were received by the Council in 2022.

Protected Disclosures

There were no protected disclosures received during 2022.

Twinning

In 2022, Monaghan County Council demonstrated commitment to respecting the individual privacy of the citizens of Monaghan. It continued to develop best practice to ensure compliance and demonstrate accountability under GDPR and data protection. This work included developing and implementing the necessary policies, procedures and protocols, processing personal data in an open and transparent manner, processing data subject access requests and An Garda Siochána requests, delivering staff awareness raising and training and notification of data security breaches. Ethics

Section 19 of the Local Elections (Disclosure of Donations and Expenditure) Act 1999 requires each elected member to furnish to the Local Authority, not later than January 31^{st} , a donation statement indicating whether during the preceding calendar year, the member received a donation exceeding €600. 18 completed forms were received by the closing date of 31^{st} January 2022.

Part 15 of the Local Government Act 2001 obliges each member of the council and relevant staff to complete a form in respect of their declarable interests held during the prescribed period and furnish the annual declaration to the Ethics Registrar no later than the last day of February. 18 completed forms were received, from elected members, by the closing date of the last day of February 2022. 72 relevant staff were asked to complete a declaration form, all forms were received by the last day of February 2022.

At the end of 2022 there was one ongoing investigation regarding a possible contravention in respect of Part 15 (Ethical Framework for the Local Government Service) of the Local Government Act 2001 and the Code of Conduct for Councillors.

Coiste Gaeilge Annual Report 2022

Monaghan County Council's Coiste Gaeilge aims to promote the use of the Irish language in County Monaghan as well as insuring that the Council fulfils its obligations under the Official Languages Act. The Coiste has been established with the following Councillors elected; Cllr. Pat Treanor, Cllr. Cathy Bennett, Cllr, Richard Truell, Cllr, Raymond Aughey and Cllr. Hugh McElvaney.

In 2022 the Coiste returned to in person activities, which included the following

- 1. The Coiste held 4 meetings.
- 2. During Seachtain na Gaeilge our first in person event for over 2 years was held in the Garage Theatre with the fantastic Zöe Conway.
- 3. Gaeltacht Scholarships also returned with 37 students from the County availing of them.
- 4. During Monaghan County Fleadh an outdoor event was held in Scotstown.
- 5. The Coiste supported Muineachán le Gaeilge to run Campaí Sproai, which is an Irish language summer camp.
- 6. In 2023 we hope to continue the good work of the Coiste and ensure the Council complies fully with the Official Languages Act.

Capital Projects

The Capital Projects Unit leads the delivery of major capital projects identified in the three-year multi annual Capital Programme. The unit seeks to ensure consistency of approach in the procurement, management and delivery of projects, in line with the Public Spending Code.

The unit adopts the Capital Works Management Framework (CWMF) in the procurement and management of public works and services contracts. Several major capital projects have been progressed in 2022:

Monaghan PEACE Campus

The Monaghan Peace Campus will provide a new four storey mixed use community building, comprising of a Cultural Heritage Centre, Library, Youth Facility, Shared Community Multi-Functional Space with External Community Space and Underground Parking.

The Campus will act as a new Landmark building for the town, providing high-quality civic gathering spaces, landscaped areas and pedestrian routes. The site has been designed with universal access in mind to encourage a diversity of both uses and users.

The 4-storey facility is located at the old machinery yard site in Monaghan town and will mark a significant investment by the Council in the urban regeneration of the county town.

The project is at an advanced stage of construction by Felix O'Hare Limited and is scheduled for completion in 2023.

Proposed new Civic Office Headquarters

The Capital Project Unit are continuing to progress the design proposals for the proposed new Monaghan County Council Civic Office Headquarters at Rooskey, Monaghan.

In July 2022, the unit appointed an Integrated Design Team, led by Henry J Lyons Architects to deliver the project and prepare designs to progress the scheme.

The Design Team presented the Preliminary Design Report & Feasibility Study to the Project Steering Committee on the 2nd of November and then subsequently to all the Elected Members on the 11th of November 2022. The Preliminary Design approach was agreed and approval was provided to proceed to Stage 2 Design and to prepare documentation for a Planning submission.

The Design Team are making progress developing the design with an anticipated Planning submission programmed for Quarter 2 2023.

A Planning Application, Environmental Impact Assessment Report (EIAR) and Natura Impact Statement (NIS) was submitted to An Bord Pleanala (ABP) in August 2022. Throughout 2022, RPS Design Consultants progressed detailed design proposals for road/footpath infrastructure, utility services, street furniture, landscaping, lighting and various other elements within the regeneration scheme area.

Detailed design for all relevant scheme elements are substantially complete and are expected to be finalised following ABP's planning decision.

Avison Young (Valuation Office) continued communications and negotiations with affected property owners throughout the year. Advanced purchase of one property was secured in June 2022 and negotiations with remaining property owners are ongoing.

The Capital Projects Unit are also continuing to progress proposals for the regeneration of the Dublin Street north area of Monaghan Town. In November 2022, the Capital Projects Unit appointed a Design Team to deliver the project for Monaghan County Council and prepare designs to progress the scheme.

The Design Team are progressing the Preliminary Design stage which is programmed to be completed in Q2 2023 with an anticipated Planning for Approval submission to An Bord Pleanála in Q4 2023.

Phase I – Gate Lodge 2 Library & Public Realm

Broomfield Construction contractors progressed contract works for the Gate Lodge 2 Library Refurbishment and Public Realm facilities throughout 2022. The main elements of works completed during the year included, the construction of the new extension building, reconstruction of the roof on the existing Gate Lodge, installation of new foul water pumping station and public realm paving works at the Lough Muckno entrance.

The construction contract is scheduled for completion in Spring 2023. Following the building handover, fit out works for the library facility will be progressed and it is expected that the new library will be operational in Q2 2023.

Castleblayney Market Square Regeneration Phase II – Castleblayney Market House & Market Square

Dhb Design Consultants progressed the development design proposals for the Castleblayney Market House & Market Square project throughout the course of 2022. During the year a number of surveys, including a topographical, traffic & parking and asbestos survey were carried out to inform the design process. The Design Consultants completed Preliminary Designs in Q2 2022, and Part 8 Planning Approval was secured in Q4 2022.

Dhb Design Consultants are expected to finalise detailed designs for the Market House refurbishment and Market Square public realm improvements in Q2 2023. Monaghan County Council intend to submit a Category 1 Rural Regeneration and Development Fund (RRDF) grant application for the project to the Department of Rural & Community Development (DRCD) once the new RRDF application process is officially opened.

BioConnect Innovation Centre

Midland Construction Ltd commenced construction of the new research and innovation centre at Knockaconny on behalf of BioConnect CLG in January 2022. Construction works have progressed well throughout the year. Works completed include the foundations for the new building, the new steel frame and the superstructure, complete with exterior insulated wall and roof cladding. External civils and ground works were also substantially progressed in 2022. Construction works are ongoing and scheduled for completion in Q2 of 2023. Coral Leisure Ltd manages Monaghan Leisure Complex on behalf of Monaghan County Council. Coral Leisure has operated the facility since 2006 and are one of Ireland's leading service providers.

In mid-2022, Coral Leisure Centre was awarded a grant allocation of €113,000 from the Sports Capital and Equipment Programme (SCEP) which is facilitated by the Department of Tourism, Culture, Arts, Gaeltacht, Sport, and Media. The grant allocation will be used to carry out refurbishment works to various elements of the changing rooms and toilets in the complex. It is proposed that procurement and execution of the works will be carried out on a phased basis throughout 2023.

The upgrade programme for Public Lighting was completed in 2022. The Roads & Transportation Department took over the operation of Public Lighting in 2022.

Property Asset Management



The Council Property Management Software System records and tracks all land and building assets under the control of the Council. This ensures good Governance and effective management of our property portfolio and links to the Financial Assets Register (FAR).

Creative Ireland Programme 2022

Deirdriu McQuaid, Creative Ireland Coordinator, chairs the Creative Ireland Steering Committee, whose members include Somhairle MacConghail, Arts Officer; Liam Bradley, Curator, Monaghan County Museum; Shirley Clerkin, Heritage Officer; Dympna Condra, Tourism Officer; Darren McCreesh, Patrick Kavanagh Centre Manager; Laura Carey, Monaghan County Library; Catherine Elliott, County Librarian; Maire Cullinan, Economic and Planning; Pamela Kerr, LEO. The steering committee reports to John Murray, Head of Finance.

A total of 23 projects were supported by programme funding of €297,419.

The projects are:



Monaghan Murals –

Monaghan County Museum & the Patrick Kavanagh Centre lead this project out working with other kev partners within the **County Council which** is to develop a series of international standard large-scale

street murals throughout the towns of County Monaghan. It forms part of a wider strategy to support creativity in the community, promote pride of place and diversity of experience. The project will celebrate various aspects of local history, heritage, and culture.

Festival in a Van

Festival in a Van returned in September to bring music and joy to new and/or marginalised communities.

Wetlands Short Films Project -

in County Monaghan, there are 711 wetland sites on the Monaghan Wetland Map database. Monaghan Heritage Office created this database following many years of habitat surveying and mapping. These short films are professionally produced, showing the Monaghan wetland-scape.

The Nature Project -

This is an innovative new collaborative project with artist Siobhan McDonald, comprised of a series of enquiries connected with Environmental change - such as the roll of bogs in Climate Change and the impact on our health and well-being of our ecosystems and ourselves. Throughout the duration of The Nature Project, Siobhan is proposing a vast programme of activities across the partnering institutions: residencies, exhibitions, pop-up labs, workshops, and talks. The intention of this project is to raise awareness and foster creative and critical reflections about environmental challenges that our society is currently facing.

Patrick Kavanagh Legacy Programme -

This programme has three distinct project parts involving community groups, the creative community, schools and various cultural, archival and library council services. It is a series of discreet projects stimulating fresh perspectives on the life and work of Patrick Kavanagh, one of Irelands most beloved poets, and the significance of his work in a contemporary context.

Storyteller in Residence -



Francis McCarron is our storyteller in residence for 2022 who is coordinating a new network of storytelling events across the county with the aim to set up a Yarnspinners

network and bring out the storyteller in many of us.

Tradoodle Festival -

Tradoodle Festival is about children and young people, community engagement, and it is about providing opportunities for children and young people to access the traditional arts in innovative, interesting, and meaningful ways.



Elsewhere – The Opera

Elsewhere is a new opera project led by composer Michael Gallen, based on the true story of the world's first Soviet outside the USSR – in the lunatic asylum of a small Irish town – established fleetingly in 1919. The Opera is now getting ready for an international tour.

Local Arts in Education Partnership -

Several initiatives were supported in collaboration with Cavan County Council and CMETB including continued professional training, support towards purchase of a festival production van and programming for young people.

A Memory of Water -

a multi-sensory art project by visual artist Orlagh Meegan-Gallagher based on her work as a seascape and waterscape artist called A Memory of Water.

Originally conceived in the first lockdowns, the project is specifically designed to work through the staff from nursing homes and day care centres to deliver a series of carefully planned activities, using Visual, Auditory, Oral and Tactile stimulus to inspire art making.

Bordering Realities Youth's Creative Response to Border –

Multi Agency and Disciplinary Project – aligned with Decade of Centenaries programme, this project over 2 years is working with young people through music, drama, dance, and visual art on the topic of what constitutes a border, with final performances scheduled to take place at end of 2023.

Lullaby Leaf –

This pilot research and engagement project has come about after a smaller scale engagement piece with the North-East Down Syndrome Centre. This project is to engage renowned award-winning artistic company Ceol Connected to develop a multidisciplinary sensory arts programme for children with down syndrome. Collaboration project with Cavan, Louth, and Meath County Council's.

The Manager –

New play written by Joe Hanratty and presented by Caislean Theater company, taking football to the stage. This new unique play depicts the story behind any club/sport and the involvement of community.

Song Tales sa Speir –

A new and exciting pilot initiative from Ceol Connected and a consortium of partners which aims to invigorate and build upon County Monaghan's strong ecosystem of traditional arts for children. During June, a team of musicians travelled across the county in a specially converted mobile stage!



Partners are Creative Monaghan, Music Generation Cavan/Monaghan, Íontas Theatre, Local Arts in Education Partnership, National Childcare Network and 12 schools/preschools from across the county.

Harp Day –

Music Generation are delighted to present Harp Together in celebration of Harp Day 2022 with the launch of their new energetic Harp Ensemble under the direction of Sabina McCague & Eilís Lavelle with a programme of workshops in schools and special event at Hilton Park, Clones.

Fighting Words –

We are delighted to launch Fighting Words in County Monaghan which is a national initiative which strives to inspire children, young people, and adults to explore their imaginations through writing. Working in collaboration with Creative Schools Cluster and Iontas Theatre.

Samhain Storytelling Festival -

We will host our first ever Storytelling festival in County Monaghan at end of October with a programme of workshops, sessions, and film for all ages, working with groups and communities across our borders.

Culture Night 2022



This was the 8th year for the County Council to coordinate Culture Night, an annual all-island public event that celebrates culture, creativity, and the arts. This year, it took

place on Friday 23rd September with 19 unique events. Thanks to the vibrant rich cultural community in County Monaghan, we were able to present a blended programme for everyone to enjoy. The County Council received €10,000 funding from the Arts Council. Total expenditure

for 2022 is €24,000.

Decade of Centenaries


For 2022, a total of 9 projects took place across the county engaging with different audiences to learn about the historic events of 1922.

A new history writing competition through the Office of An Cathaoirleach was established. A new multi-agency, multi-disciplinary project commenced working with young people on what borders mean to them which will be depicted through music, song, dance, theatre, and visual art at end of 2023. We were successful in capital funding towards the new Museum exhibition of €200,000. Total Funding under this programme for 2022 is €320,000.



Exploring History through Poetry

Poet Ted Mc Carthy worked closely with David Nicholl from Clones branch library to look at how



history has been represented in the poetry of the time. Poems from Yeats, Kipling, Synge, Plunkett, and many more are recited and analysed in this 6-part series.

Library Services



Monaghan County Library Service worked tirelessly throughout 2022 to re-establish a full range of services for customers, as Covid 19



restrictions were finally fully lifted. Our emphasis has been to encourage customers to visit their local library once again; to browse our bookshelves, join a Book Club, use our study spaces, engage in creative writing,

attend one of our many events and reclaim the library space as their own.

Right to Read Programme

The key objective of this programme to bring together the existing knowledge and experience of skilled staff in local authority services and other agencies to deliver literacy support in the County. Right to Read complements and supports existing national literacy strategies and initiatives, including the Department of Education and Skills' National Literacy and Numeracy Strategy.

Library Podcasts



Monaghan County Library staff have been working within the community to produce 2 podcast series.

Star Reads podcast



Throughout the Summer months we interviewed 37 children & young people about their top 5 books as well as discussing the joys of reading. Our youngest guest was aged 3 and arrived with his Mum to talk about his favourite book 'The Gruffalo'. Our older guests were avid readers and discussed issues such as diversity and

representation in books. All episodes are available to listen to on Spotify and to date the podcasts have reached over 1,000 listeners.

School Services



Monaghan County Library staff are always offering support and advice to both Primary & Secondary

schools across the County. This may be in terms of literacy support, guidance on library development or engagement in various projects. We are currently assisting the Literacy committee in St. Louis Secondary School, Carrickmacross in their bid to increase literacy levels among students and the wider community.

Foster Care Library

Monaghan County Libraries and Tusla the Child and Family Agency were delighted to partner together to provide a library collection within the Tusla Wellbeing Centre aimed at Children and Young People in foster care, their carers and all other young people who use the facilities in the centre.

The books provided by Monaghan County Library cover a range of topics and are geared towards all age groups.



Karen McCague, Executive Librarian with Monaghan County Library Services explains "It's important for children and young people to be able to see themselves and their life experiences reflected in stories so that they understand that they are not alone. We hope that by having this collection of books available within the Wellbeing Centre, children will have the opportunity explore the stories with a caregiver or on their own and perhaps recognise themselves, their thoughts, or their experiences."

STEAM Services

Having developed a STEM Resource library for schools, library staff have also made use of the resources to develop a Lego Literacy workshop which was rolled out in Castleblayney and Clones Library this year. Children participated in Lego themed activities which combined literacy, problem solving, group work and technology to create Stop Motion Shorts which were written and recorded by the children.

Summer Stars Summer Reading Adventure



1500 children signed up to the Summer Stars reading challenge this year. That's at least 12,000 books being read during the summer holidays! The Summer Star reading challenge is an important literacy programme which aims to keep children reading during school holidays in a bid to stop the phenomenon known as the 'Summer Slump' – a recognised drop in literacy levels. The Children are awarded certificates and gold medals to mark their achievement. Some lucky readers also won Family Passes to Tayto Park in the end of challenge



Literacy Activity Books



2022 saw two new Literacy Initiatives developed in conjunction with national sports organisations, Monaghan County Libraries joined forces with the GAA and The Football Association of Ireland to pilot sports themed activity books for schoolchildren aged 10-14 years old. The projects are aligned to the national Right to Read programme to promote literacy and reading development for people of all ages and backgrounds. By utilising the popularity of sport, the activity books have been developed to assist teachers in the classroom and provide an educational resource for parents and guardians at home.

Children's Book Festival @ Monaghan County Libraries



2022 saw the return of live 'in-person' CBF events running alongside a programme of webinars. Schools from across the County participated in workshops with bestselling children's authors & illustrators such as Robert Muchamore, Dan Freedman, Paddy Donnelly and Tarsila Kruse, Fiona Longmuir. 20 events took place across the month of October with hundreds of children participating.



Cavan Monaghan Science Festival 2022



Our awardwinning Cavan Monaghan Science Festival was back with a

bang for 2022. Events took place in schools and libraries across the 2 counties. County Monaghan hosted over 30 events across 2 weeks looking at a broad range of topics including The Biomechanics of Running, The STEM of Formula 1, The physiological & psychological effects of grief, The Science of Marvels Black Panther and much more. As COVID restrictions were lifted we were delighted to bring back the Big Family STEM Day in Monaghan Institute.

Little Library Book Bags



As part of the Little Libraries campaign, Monaghan County Libraries have distributed over 1500 book bags to preschools and children starting Primary school this year.

To compliment this programme, we have also

hosted 15 storytelling events for Pre-schools and provided training on the use of Story Sacks in early years settings.

Local History and Genealogy Service

The service continued to be very busy with enquiries throughout 2022 from around the world. Feedback on the service is extremely positive, as it provides a wealth of resources unique to County Monaghan.

Europe Direct Information Centre



This regional service is provided across three counties, Monaghan, Cavan, and Louth.

Europe Direct Information Centres give information, advice, assistance, and answers to questions about the EU and the rights of EU citizens, the EU's priorities, legislations, policies, programmes, and funding opportunities. In 2022 Europe Direct Clones has engaged with citizens across the region in highlighting the priorities of the EU. We were delighted to welcome Colm Markey, MEP and Chris McManus, MEP to the centre during 2022.



A range of events were held focusing on the European Green Deal, the Digital Decade, Democracy and on promoting our European way of life.

Europe Direct Clones are happy to work with groups and attend events which help promote the work of the EU institutions or address Citizen's concerns.

Europe Direct Clones receives annual funding of €31,000 from the European Commission to support the service provided and cover the cost of annual event programming.

Healthy Ireland at Your Library

A grant of €3,000 was allocated in 2022 by Department of Rural and Community Development to Monaghan County Library to promote the Healthy Ireland Campaign through the library service network. A new three-year programme is now in place and will run until December 2025.

County Heritage Office

In 2022, the Heritage Office continued to deliver heritage services, implement and co-ordinate heritage and biodiversity policy and practice, and to liaise closely with the **Department of Housing**, **Local Government and Heritage** and **The Heritage Council** regarding national policy at a local level. The section liaises with other local authorities through the **Local Authority Heritage Officer network**.

The Heritage Section is part of Monaghan County Council's Cultural Team, and during the year moved from the Directorate of Finance, Housing and Culture to the Directorate of Environment.

In 2022, there were three **staff** in the Heritage Office – Heritage Officer, Conservation Assistant, and an Assistant Staff Officer.

The **County Monaghan Heritage Forum** is a multistakeholder forum with representatives from civil society, elected representatives, state agencies and organizations and Monaghan County Council staff. The secretariat is provided by the Monaghan Heritage Office. Its' chairperson is Cllr. Aoife McCooey.

Sadly in 2022, the heritage forum lost one of its most expert members, the late Fearghal Duffy. Fearghal was a knowledgeable Irish scholar, writer, nature photographer and a prolific biodiversity recorder. His last public talk was during Heritage Week 2022, where he presented his research on nature in old Irish writings. It was agreed with Fearghal that a Citizen Scientist Award in his memory will be presented from time to time by the Heritage Forum.

Policy

County Monaghan Biodiversity and Heritage Strategic Plan 2020-2025

The County Monaghan Biodiversity and Heritage Strategic Plan 2020-2025 sets a vision for 2025 the role of heritage and biodiversity for climate change mitigation and adaptation, sustainable communities, functioning ecosystems, health and wellbeing is generally accepted in the county and embedded in the activities of Monaghan County Council.



Thirteen themes are described with objectives for each, and a concise action plan to enable progress. Priority strategic themes are – Climate Change mitigation and adaptation; Monaghan's Wonderful Wetlands; Hedgerows and native woodlands; The Worm Ditch/The Black Pig's Dyke; Pre-historic archaeology; Protected structures; Vernacular and traditional buildings; High Nature Value farmland; Demesnes and Estates; Crossborder heritage; Historic Graveyards, holy wells and church ruins; Indigenous knowledge and traditions; Irish and the vernacular English.

The plan also contains strategic objectives, organization goals and key performance indicators.


County Monaghan Hedgerow Conservation Strategy


Monaghan Hedgerow Survey – A Decade of Change 2010-2021, showed an overall decline in hedgerow extent, length, diversity in Monaghan and ash die back symptoms in 90% of the trees surveyed. These results are of concern for this important habitat and component of our ecological infrastructure across the county.

Workshops with Monaghan County Council staff were held in Spring 2022 to discuss report recommendations:

- Monaghan County Council should produce and adopt a hedgerow conservation strategy.
- Concept of a heritage hedgerow should be recognised in the county development plan and into planning infrastructure. The concept of "Heritage Hedgerows" is proposed for hedgerows which have notable historical, structural or species composition characteristics.
- Guidelines for planners and road engineers for dealing with hedges in planning applications.

Two documents were produced to be adopted in 2023 as council policy.





Monaghan Wetland Action Plan

The County Monaghan Wetland Action Plan 2020-2021 is an integrated plan for the conservation of the wetland resource in County Monaghan, through co-operation and engagement with a wide range of partners and community groups. The action plan sets a way forward to resource, protect and enhance, conserve and advocate for County Monaghan's wetland biodiversity and heritage. The plan aims to progress the sustainable development of the resource and maximise on the biodiversity, climate change mitigation and ecosystem services that wetlands can provide.

Extensive work has been undertaken over the past fifteen years in identifying and characterizing the ecological character of wetlands throughout County Monaghan. The outcome of this work has produced a valuable dataset containing information on 710 wetlands, of which 202 have been subject to field survey.

MWAP has objectively identified management, restoration and rehabilitation priorities for the wetland resource of the county to, amongst other things, improve biodiversity outcomes and climate mitigation/adaptation. This should guide community groups, landowners and others about the most practical and effective restoration measures.

A public engagement strategy was developed, and a Community Wetland Network was launched during Heritage Week. Funding sources are identified to ensure the wide uptake of the wetland action plan among partners and community groups, the primary beneficiaries in County Monaghan. https://monaghan.ie/wp-

The County Monaghan Wetland Action Plan (MAWP) project is a joint project initiative funded by Monaghan County Council, and the Department of Housing, Local Government and Heritage through the National Biodiversity Action Plan funding.

Conservation

Community Monuments Fund

This scheme from the National Monuments Service, Department of Housing, Local Government and Heritage is administered by the Heritage Section. The fund is for the care, conservation, maintenance, protection and promotion of archaeological monuments. Two applications for funding were successful in 2022.

1. Errigal Truagh Medieval Church -

Errigal Truagh Medieval Church – conservation of western gable

Both gable walls are at risk of collapse due to dissolution of mortar, loss of some stone and water migration through wall tops. Increased

frequency of wind-driven rain, and projections for climate change that storm activity will increase puts this structure further at risk. To increase its resilience, the church needs repair and conservation works before these impacts cause partial or full collapse of walls. Full specification for repair were funded through this scheme in 2021, and conservation of one gable funded in 2022. The works were successfully completed.

2. Killeevan Abbey –

Medieval church marked in ruins on Down Survey map of 1657. 1837 commentary by Lewis, "Of the three chapels in the parish (Cill Laobhán) the oldest was colloquially called the 'The Abbey of Killeevan' "but of the original church, there only remains the western gable, with a very small lancet window, which indicates the antiquity of this building." This gable was consolidated in 2021 with funding from this scheme.

In 2022, the project improved the presentation of Killeevan Abbey, building resilience for the site by creating a baseline for ecological status, and improving access virtually on the ground. A film was made with the local school, and three interpretation panels made in conjunction with the local heritage group.

It will enable continued buy-in locally to the site and engage with senior primary school children. This will help create the next generation of custodians for the site.

Collaborative Action for the Natura Network

The CANN project is an Interreg VA funded project led by Newry, Mourne and Down District Council, consisting of an 11-partner consortium of which Monaghan County Council leads the uplands work package.

The project aims to strengthen cross-border cooperation to facilitate the recovery of selected habitats and priority species to meet the targets of the EU Birds and Habitats Directives and the EU Biodiversity Strategy.

Sliabh Beagh is a large upland site contained within the counties of Monaghan, Tyrone and Fermanagh. Monaghan County Council is responsible for delivering direct conservation actions on this site. In 2021, the completion of complex procurement exercises enabled the planning of works for many of the coming seasons. Conservation activities must be timed to avoid nesting seasons and other sensitive times for habitats onsite.

This five-year project finished in Winter 2022, involved 11 partners and three jurisdictions – Ireland, Northern Ireland and Scotland. The aim is to produce conservation action plans and to improve the conservation status of wetland habitats and key species.

Monaghan County Council leads the upland sites work package and led the work on the crossborder site of Sliabh Beagh, where two conservation action plans were developed, one for the NI portion of the site and one for ROI. A result of the project, over 1200 hectares of Sliabh Beagh blanket bog is now moving towards improved conservation status, due to the removal of threats such as invasive species, blocking drainage channels by building peat dams, improvement of nesting opportunities for the Hen Harrier, conservation grazing and creation of a Wildfire Management Plan.

Fire Management Plan was developed for the Sliabh Beagh region. The main aims of the plan going forward are to: Compile knowledge to allow stakeholders to gain an understanding of the fire risk in the area, encourage cross – border actions to sustainably manage the landscape and enhance

landscape resilience through sustainable management practices.

Ammonia Monitoring continues to be carried out by Monaghan County Council Heritage section on Sliabh Beagh on a monthly basis.

Outreach

Heritage at the Heart Podcasts

This third series of podcasts on heritage and nature in Monaghan is presented by the Heritage Office and recorded onsite. They present interviews with local people, custodians, and heritage specialists, with lots of lively discussions and stories about the places and their value. Each podcast is accompanied with specially commissioned music by distinguished Monaghan composer Michael Gallen. Available on all usual podcast platforms. Synopsis of episodes below:

EPISODE 1 'Having an eye' on heritage and climate with Sammy Leslie.

Sammy Leslie, of Castle Leslie talks to Shirley Clerkin, Heritage Officer about managing a historic estate, her plans for rewilding some of the woodlands and pastures, all with a focus on climate change. Recorded in Castle Leslie, Glaslough.

EPISODE 2 Botanically yours with Alexis Fitzgerald.

Alexis Fitzgerald, botanical recorder for County Monaghan meets Shirley Clerkin, Heritage Officer on the shores of Lough Muckno, Castleblayney to talk about what inspires him in the natural world, and his forthcoming publication on the flora of the county.

EPISODE 3 Traditionally home with the Mulligan Family.

Kevin, Clare and their son Mide welcomed Shirley Clerkin, Heritage Officer to their restored vernacular farmhouse where they discuss the challenges and benefits of working and living in an old building. Accompanied by some pet dogs!

EPISODE 4 A burning issue for climate on Sliabh Beagh.

Dermot Brannigan, Chief Fire Officer and others chat with Shirley Clerkin, Heritage Officer on the top of windy Sliabh Beagh to talk about the bog, damage caused by fire and how by working together to produce a wildfire management plan is creating benefits for biodiversity and climate. Also features Paul Sherlock of the CANN project, and Paddy Sherry, local stakeholder.

EPISODE 5 Locally made: Weaving the weft with Liz Christy.

Liz Chirsty, artist and weaver shows Shirley Clerkin, Heritage Officer around her studio and working looms where she crafts luxurious scarves inspired by art, nature and the Monaghan landscapes. Recorded at Swallow Studios, Annyalla.

Traditional Houses in Rural County Monaghan

The typescript for the second volume of the Monaghan Heritage publication series was prepared in 2022.

Building on the county wide survey of vernacular buildings undertaken by the Heritage Office in 2015, the text, images and interviews with owners will form part of the publication which looks at the heritage of these buildings created using local materials and traditional skills. The book which will be published in 2023 examines important considerations for these assets into the future including re-use and adaptation.

Magic Under Monaghan

Wetlands Film for young people

Creative Ireland funded the production of a film to highlight the importance of peatlands for climate and biodiversity. Filmed in the early Autumn on Sliabh Beagh, the film is due for release at beginning of 2023.

The film incorporates animation and a young teacher from RTE school's hub is the presenter

Arts Office

The year 2022 for the Arts Sector was always going to be the year where we knew not what to expect with the sudden and slow departure of the covid 19 pandemic rules. The sector in many ways was not really ready for this jump to action as many of the arts practitioners, facilitators, performers, and Artists had gone into a subdued hibernation of creativity. As life matters started loosening the sense of relief was palpable within the creative arts community. However, there was an equal measure of anxiety within them, stemming from whether the audiences and participants, they had for so many years cultivated, would still be out there on the return of live Arts.

It was our role to assist and to inveigle the artists out again with both resources and financial assistance to start nurturing their creative talents that would lead to a spark which would excite audiences to embark on the longanticipated journey of returning to live events again. However, since the whole country was in many ways caught up in the pandemic narrative of *will we open for good now or might this be temporary,* it took until May at least before we all realised there was no returning to lockdown measures. I must say that there had been always a sense of camaraderie amongst us all in the arts world of County Monaghan, in which Monaghan County nourished.

Monaghan County Council did endeavour to support the Arts throughout the year as it managed in 2021. In many instances the teams that led our cultural landscape through events took decisions on whether they were ready or not themselves in their roll-out of annual events until the following year of 2023.

Responding to Covid restrictions

Our Government through the Department of Tourism, Culture, Arts, Gaeltacht, Sport & Media did realise that the natural uptake of events and arts participation would continue its slow burn to stability and maintained its investment through the well tried and tested Local Live Performance Programming Scheme. We teamed up with the Dept and responded by delivering on the LLPPS scheme III & IV in assisting the arts sector and in particular the loss of skills sets needed to re-configure the arts back to a healthier state.

"The scheme was set up to support employment opportunities for **Artists**, **Performers** and **Crew** in showcasing events across the county which would help underpin the recovery of the live performance sector. The funding was used to support employment and wellbeing in the commercial arts and culture sectors through the provision of live performances."

Of the 2 parts of the LLPPS III was held in May & June and the LLPPS IV held in September & October Monaghan County Council invested some €260K into the local Arts & Cultural sector to which we supported programmed events & Festivals in Carrickmacross, Clones, Hilton Park, Iontas Arts Centre, Patrick Kavanagh Centre, The Garage Theatre, Sliabh Beagh, Monaghan Town and other places & spaces throughout the county.

Over 36 days of events between the 2 the schemes supported and paid 169 Artists & Musicians, 53 Crew and paid a rental fee of 22 days to 10 different venues in the county.

Arts development objectives: 2022

Maintaining our programming and funding model to the 3 strategic goals of our framework agreement with the Arts Council 2020 - 2027 was a key objective again in 2022, in the understanding that the council's commitment and delivery of the arts in the county can be more sustainable this way. These 3 key objectives were the cornerstone of our goals in maintaining a fulfilling role for the arts in the creative society within Monaghan.

Some of the updates in our 2022 delivery are as follows:

1. Supporting the Artist: Value and support the work of artists and extend the range of opportunities for artists to develop their practice.

Our recently added Value-Added Scheme 2020-2027 contributed financially to 4 Artists which at its core is a commitment to support the Professional Artists who have been awarded a **bursary** from bodies such as **The Arts Council/Culture Ireland**

We also co funded with the Arts Council and in association with arts officer association the biannual Platform 31 bursary which is awarded in competition form to an artist in mid-career wishing to engage in new and exciting work award sum €8K

As we also fund many other arts centre, festivals and venues in the county we ask them through our funding programmes to also follow up on the advocacy programme that we commit to in realising the potential of every child and commit to supporting young people in the Arts.

3. Creating Capacity Investing in the professional development of venues, festivals and organisations providing high-quality arts experiences.

Our principal support in this high level goal is our <u>Scéim Ealaíon Compháirtíochta/ Arts</u> <u>Partnership Grant Scheme 2022 - Arts</u> (monaghan.ie) This funding Scheme is open to Arts Organisations, Arts Groups, Arts Festivals and Arts Projects who <u>deliver a sustainable Arts</u> <u>Programme</u> in County Monaghan. Direct grant assistance to venues, arts organisations and festivals deemed to be of strategic importance to the Arts within the County.

The restrictions placed on society by the pandemic did have a huge impact on our Arts Partners in being able to deliver many of their goals. Monaghan County Council maintained its support to these Arts organisations in their time of need in order that they would be able to start reclaiming their audiences and stimulate the arts in the county post covid. It is only with our Arts partners with whom we fulfil our **Creating Capacity** investment, who are in many ways the driving force behind much of the Arts delivery in the county.

Tourism Section

The Tourism Unit within Monaghan County Council implements the Tourism Statement of Strategy and Work Programme 2017-2022. The principal functions of the unit are:

- To raise customer awareness of the Monaghan area as a tourism destination
- To develop and contribute towards the development of the county's tourism product

Tourism Promotion & Visitor Servicing

Monaghan Cluster Trade Workshops

Monaghan Tourism in conjunction with Fàilte Ireland continued its series of tourism cluster workshops in June 2022, targeting key tourism, dining, accommodation, and craft businesses based in north Monaghan to develop a cluster of saleable experiences tailored to domestic and international visitors.

Monaghan Tourism Summer 2022 Campaign

Monaghan once again set its stall as a must-visit staycation destination for summer 2022, with a content-driven promotional campaign across local, national and social media to maximise visibility.

Summer of Food Series

The key pillar of the 2022 campaign was the *Summer of Food* Series. Funded by the Agri-Food Tourism initiative from the Department of Agriculture Food & the Marine, the series saw County Monaghan's food businesses and producers take centre stage over with a content driven campaign highlighting several of the county's leading food businesses and foodie experiences, with a particular emphasis on what's new, innovative and unique about each. The Summer of Food series was launched on Thursday 16^{th} June 2022 by Minister Charlie McConalogue, who visited Monaghan Market House to officially announce funding of €23,000 for Agri-Tourism in Monaghan.

Natalie B Coleman and Ardal O'Hanlon, and features with businesses participating in the Monaghan Tourism *Summer of Food Series*.

Other Promotional Initiatives

Monaghan was showcased in travel features in both print and online media including The Sunday Times, Belfast Telegraph, and MyKidsTime.com, and there were several press visits to the county from a range of influencer and travel journalists, including Catriona Doherty and Neil Leydon (RTÉ Digital).

Monaghan enjoyed coverage on US TV platforms in 2022, including a 25-minute travel feature on *Ireland; County By County*, presented by Ciara Whelan and created in conjunction with Peninsula TV, which aired across 239 stations in the US in January 2022. The full episode is available via the <u>Monaghan Tourism YouTube channel</u>

Monaghan is also set to feature in the next season of popular US travel show *Ireland with Michael*, hosted by Irish singer, theatrical producer and Wexford native Michael Londra, now based in the American Midwest. Filming was completed in Monaghan in June 2022, and the upcoming episode will air in January 2023.

Rossmore Cycle Trail

Under the *Outdoor Recreation Funding Scheme* (*ORIS*) 2019, funding of \notin 289,355 was secured with match funding of \notin 72,338 being provided by

Monaghan MD. The cycle trail was designed following consultation with key stakeholders such as Coillte, Emyvale Cycling Club and Cycle Ireland. The project was completed in 2022 and officially launched by Minister Humphreys on Thursday 14th April 2022.

Monaghan Way Upgrade – Inniskeen to Castleblayney

Funding of €139,490 was received under ORIS 2021, with match funding of €15,499 provided by Carrickmacross-Castleblayney MD for this upgrade project. Trails consultants were appointed in May to survey the route and to provide specifications for upgrade works. The anticipated completion date for the project is April 2023.

Dartrey Forest Enhancements

Another project funded under ORIS 2021 was Dartrey Forest for which €200,000 was received,

with match funding of €24,000 from Ballybay-Clones MD. The Paul Hogarth Company (Landscape Architects) were appointed to work up detailed designs to enhance the wonderful natural asset of Dartrey Forest, with a view to maximising its recreational value. This work is on-going and will be completed in 2023.

LEADER Heritage Cluster Project

Signage - A Design Team was appointed to design and install signage and interpretation panels at Rossmore Forest Park. Funding of €67,313.81 was awarded by LEADER for this element and match funding of €22,437.94 was provided by Monaghan County Council. The signage was installed in September 2022.



Conservation Management Plans - A multidisciplinary Design Team including qualified archaeologists was appointed to draw up Conservation Management Plans for two sites in Co. Monaghan - Rossmore Forest Park and the Black Pig's Dyke at Scotshouse. Funding of €43,015.50 was awarded by LEADER for this element and match funding of €4,779.50 was provided by Monaghan County Council. The plans are available to view at www.monaghan.ie/tourism and the projects identified will be progressed as funding becomes available.



Destination Towns

Under the **Destination Towns** – **Fáilte Ireland** scheme, \notin 497,962 was awarded to Monaghan County Council to deliver initiatives to assist in the enhancement of Monaghan Town as a visitor destination. The funded project for Monaghan is to deliver a multi-use events space in Church Square. Match funding of \notin 165,987 was provided by Monaghan MD and the project is currently being progressed. It is scheduled for completion at end 2023.

Sliabh Beagh Partnership Committee

The Sliabh Beagh Partnership Committee is a cross-border initiative in conjunction with Fermanagh and Omagh District Council and Mid Ulster District Council, with representation from elected members, community groups and the business community in each council area The committee met on a number of occasions in 2022 and was successful in securing Shared Island funding of $\pounds 145,475$, with match funding of $\pounds 17,500$ in total from the three councils for a major tourism feasibility study for the catchment area.

Dromore River Blueway

€50K funding was secured under the ORIS Project Development measure to work up plans to develop a Blueway along the Dromore river system from Ballybay to Lisnalong. Canoeing Ireland was appointed in September 2022 to carry out a technical water survey which is a key project development requirement.

Lough Muckno Vision Report

Following on from the development of a Visioning Report for Lough Muckno Estate, Castleblayney and the surrounding area, a feasibility study of the concept proposals was progressed in 2022. A public consultation event in relation to the Stage 1 feasibility – a Strategic Planning & Environmental Appraisal - was held on Thursday 6th October 2022. The completed Appraisal report is due in January 2023 and will determine next steps in the feasibility study process.

Monaghan Destination & Experience Development Plan (Monaghan DEDP)

A crucial output from the continual collaboration of the Tourism Unit with Fáilte Ireland was the production of the newly developed Monaghan Destination & Experience Development Plan (MDEDP), launched by Ministers Catherine Martin and Heather Humphreys in June 2022. The MDEDP is a five-year commercial destination and experience development plan to support the development of unique and compelling destination experiences focused on a number of immediate and strategic destination opportunities within the county. EZxploring Trail Maps for County Monaghan

Monaghan Tourism worked in conjunction with EZxploring and with the Municipal Districts to create a suite of new town trail maps for the county, specifically targeted at families and children. The maps provide a fun activity-based trail that encourages visitors to get out and about, solve the clues and learn more about the characteristics and heritage of each town along the way. Tourist Office

The Tourist Office re-opened in the Market House, Monaghan town on Tuesday 7th June 2022, recording a steady increase on visitor numbers when compared with 2021, and an increase in international visitors, indicating a return to normal visitor trends following the pandemic. The tourist office closed for the year on Friday 2nd September 2022. Tourism enquiries continue to be handled by the Monaghan Tourism Unit during the rest of the year (September-May) and the Monaghan Tourism website, app and social media channels (updated on a regular basis) continue to function as a key source of information for visitors and those planning a trip to the county.

The Patrick Kavanagh Centre

For its first full operational year the centre has performed above expectations especially so in the face of a challenging national economic outlook. It has seen a significant increase in groups albeit from the domestic market and the centre has also started to diversify it's offering to optimise revenue potential for exhibition experiences.

Official Launch of Centre

The centre received its official launch in June, with two senior cabinet ministers present along with the CEO of Fáilte Ireland and various Monaghan County Council representatives. The Poetry Jukebox, a popular addition to the Kavanagh trail was also launched on the same day. Over 200 attended what was a lively event punctuated by street performance by Castleblayney Players and a wonderful introduction by Kavanagh stalwarts John & Tommy McArdle.





Digital that Delivers

As a client of Failte Ireland the Kavanagh Centre was part of an ambitious programme to transform our digital capacity and online presence. Through this programme the centre has invested in a new website, integrated 3rd party ticketing and CRM solution, content development, social media and google analytics training to support its marketing needs, along with training in Connected distribution with 3rd party vendors like Tripadvisor.

Kate Beagan Card Collection

To celebrate the reopening of The Patrick Kavanagh Centre, acclaimed local artist Kate Beagan was commissioned to produce artwork inspired by the poet in the context of the landscape where he grew up. A series of six greeting cards were produced as part of this based on an appropriate poem by Patrick Kavanagh.

Commissioned and produced mural of Patrick Kavanagh in Carrickmacross, which has quickly gained iconic status supporting the council's wider tourism goals for the South Monaghan region.



Kavanagh Poetry Award & Weekend Event

The 51st edition of the Patrick Kavanagh Poetry Award took place in September along with a Keynote Kavanagh Address (delivered by author John Connell) as part of a reduced Patrick Kavanagh Festival Weekend. This was the first proper running of the event since 2019 and over 100 attended what was a very well received event.

Taking Flight Radio Series

A series of radio essays celebrating the work and continued influence of the poet Patrick Kavanagh. Four essays were commissioned with artists such as composer Michael Gallen and folk singer Lisa O'Neill among the contributors. These will be broadcast in 2023. Support was also provided for a radio documentary celebrating Raglan Road which will be broadcast in December.

Creative Ireland


commissioned traditional arts producers Ceol Connected to create a new theatrical work inspired by Kavanagh's timeless poem A Christmas Childhood. A co-production with National Concert Hall and Draoicht Arts, the development of the work started during the summer with a series of workshops in St. Daigs Inniskeen NS. This work will inform the production which will have its premier in 2023.

Creativity in Schools

supported creativity associate Declan Gorman who facilitated a series of workshops with 12-14 yr olds in Inver College. The workshops essentially explored the student's sense of creative self, legitimacy of the artist and their own cultural heritage and culminated in a group visit and creative exercise to the Kavanagh Centre and Trail. The workshops included a visual artist, theatre practitioner and poet supporting the widest possible experience of creativity in the group. This is a model we may well pursue with other interested schools.

'Almost Everything' Release

Almost Everything is a re-issue of famous Kavanagh recordings originally produced by Claddagh Records in the 1960s, including new additional recordings of his poetry by prominent Irish celebrities and personalities including Bono, President Michael D Higgins, Liam Neeson, and Imelda May. This release has already exceeded expectation and is selling well, bringing a great deal of publicity to Kavanagh domestically and internationally. Prague Presentation

The Patrick Kavanagh Centre was invited to deliver a presentation about the story of the centre's development in the context of developing literary and cultural assets as a tourism product. This event, which took place on 24th October in Prague, was organised at the behest of Department of Foreign Affairs and Ambassador Cliona Manahan and was delivered to an audience of academics, diplomats, Tourism Ireland representatives and other tourism industry stakeholders.

Information Systems & Innovation

The Information Systems & Innovation section leads innovation and digital transformation in Monaghan County Council and provides modern and secure ICT infrastructure, systems, and solutions to enable efficient service delivery. The section is also responsible for facilitating the National Broadband Plan.

The strategy, Connecting Government 2030: A Digital and ICT Strategy for Ireland's Public Service, was unveiled by Minister for Public Expenditure and Reform Michael McGrath and Minister of State for eGovernment Ossian Smyth in March 2022.



The Government is seeking to develop a "trusted, user-driven, intuitive, inclusive and efficient world-leading digital government service", with 90 per cent of applicable services to be consumed online by 2030. It also aims to have 80 per cent of eligible citizens using the online MyGovID service by 2030. Towards meeting these objectives Monaghan County Council established and is leading a collaboration between Monaghan, Cavan, Leitrim, Dún Laoghaire-Rathdown, Laois, Clare, Sligo, Mayo, Carlow, Kerry and Meath County Councils, Galway City Council, the Department of Housing and Local Government and the Local Government Management Agency to develop MyCoCo.ie, a secure online portal where businesses and individuals will be able to access local authority services digitally.

COVID-19 accelerated the global demand for, and the transition to online digital services, and led to increased expectations by the workforce for remote working opportunities. Monaghan County Council introduced blended working in October 2022 the roll-out of which entailed close collaboration across a number of departments including HR, Corporate Services and I.S.

Security, Networks and Infrastructure

The I.S. Section is responsible for ensuring availability and security of ICT systems and services, on-premises and in the Cloud, and for managing the network infrastructure in over 37 Council offices and buildings throughout the county including County Offices, MTek1 and MTek2 buildings, the Planning Office, Municipal District Offices, Fire Stations, Libraries, Museum, and Water Treatment Plants.

In 2022, the new Landfill building was completed, and we are overseeing the installation of IT and telephony services into the building. Projects for the new library building in Castleblayney and the Peace Campus Monaghan are ongoing and have also been receiving considerable attention.



Cyber-security is a major priority for Monaghan County Council and much of the work carried out by the I.S. Section in 2022 related to strengthening the security posture of the organisation. The antivirus system was replaced with a more costeffective solution which provides additional security features including endpoint detection and response, and vulnerability scanning. Independent pen testing was carried out and any vulnerabilities identified remediated. A new digital Compliance Management System was implemented to deploy policies, online training, and phishing simulations. Security of library public services was enhanced with the installation of new VPNs at all branches. Monaghan County Council also engaged security consultancy services in 2022 to assist with the development of an Incident response policy for the organisation and to facilitate a simulated cyber-security incident via tabletop exercise.

Broadband Services

The Broadband Officer continued to support the rollout of The National Broadband Plan throughout the county and the delivery of fibre to community BCPs and to schools. The first Deployment Area in Co. Monaghan was completed under the National Broadband Plan, covering the rural areas surrounding Monaghan town. Build work commenced for approximately 65% of premises to be connected under the NBP by the end of 2022.

Engagement is continuing with all communities, Broadband Connection Point owners and business leaders in relation to the delivery of broadband and connectivity services. The Broadband Officer continues to assist business organisations, and individuals with broadband needs, and to advise on the correct approach to acquiring appropriate broadband solutions. He has continued to prioritise work with BCP owners and enterprises on the development and promotion of digital hubs and hot desk spaces.

In May 2022, Monaghan County Council hosted its first Telecommunications Action Group meeting (TAG), featuring broadband officers from across Ireland. This event took place in Carrickmacross and was opened by Minister Heather Humphreys.

A meeting of the Shared Island Forum also took place in Drumhowan BCP in May through the Department of An Taoiseach's Shared Island unit, welcoming visitors from North and South including government ministers, MLAs and members of the European parliament.

In 2022, SIRO announced that they would be entering the broadband market in Co. Monaghan. Siro is a collaboration between Vodafone and ESB which delivers their broadband network along ESB power lines. This is a welcome development which will greatly improve the broadband speeds available to users in these areas and improve competition within the county. In the latter part of 2022, SIRO commenced the build work in the Carrickmacross urban area and will commence work in Monaghan town early in 2023.

In the latter part of 2022, Openeir/EirEvo also commenced work on their IFN network in County Monaghan which will facilitate the delivery of full fibre to the premises solutions for residents and businesses within the Monaghan area in the near future.

Business Applications and Innovation

The I.S. Section works with other sections in the Council to help achieve further efficiencies and deliver on the Council's paperless office agenda. In 2022 we assisted with the implementation and roll-out of new digital solutions including a new Blended Working Application, Spydus Library Management System, and ProWork Road Application. We also assisted with the development and implementation of a new Room Booking System, and with the development of a new digital Performance Management and Development System (ePMDS) and a new digital system for recording Annual Ethics Declarations for Councillors and relevant Staff, both of which will go live in 2023.



Online forms for grants and fund applications were developed including the Community Fund Scheme 2022 and the Community Activities Fund Round 2. In addition, an online form for submitting broadband enquiries was developed.

As well as introducing new systems, we also carried out applications upgrades to some of the Council's key business systems including the Councils Financial Management System, the Register of Electors System, the Housing Management System, the Property Asset Register and the Museum Collection Management System.

In 2021 Monaghan County Council developed its first innovation strategy and set up a crossdepartmental innovation team to coordinate delivery of the objectives contained therein. The team continued with this work throughout 2022 undertaking innovation training, participating in workshops, and developing skills to help bring innovative thinking to address challenges and opportunities.

In 2022, having completed a successful proof of concept, Monaghan County Council proceeded to procure the provision of a cloud hosted public services platform for the delivery of local authority services on behalf of the local government sector. Monaghan is leading a collaboration with 11 other local authorities to deliver online services to business users and citizens through this new secure portal known as <u>MyCoCo.ie</u>. Monaghan was the first local authority to go live with MyCoCo with online solicitor services. A new MyCoCo payments app has been developed and is due to go live in March 2023.

Monaghan County Council also led the development of an innovative MyCoCo Councillor App. Councillor Raymond Aughey piloted the mobile App throughout 2022 and it will be rolled out to additional Councillors in Monaghan and in other local authorities in 2023.



A number of other services are also being developed in MyCoCo including the Housing for All housing loan application, and a range of permit and licence application processes.

I.S. Service Desk

The technical support team continued to deliver a high-quality technical support service to over 400 staff and elected members whether working in the Council Offices or from home.

In 2022 the technical support team provided support for over a thousand devices comprising laptops, desktops, tablets, smart phones, lone working devices, and loggers.

The number of issues logged in 2022 was 4417. While the total number of calls in 2022 returned to pre-pandemic figures, the introduction of new applications, security requirements and blended working increased the complexity of the support calls, which is reflected in the reduction of calls resolved within 24 hours.

Non-National Roads

Non-National roads account for 95% of the network and are funded from grants from the Department of Transport and the Council's own resources. In 2022 Monaghan County Council received an allocation of €16.22m from Department of Transport for Non-National Roads and provided almost €4.4 million from its own resources which included technical and administrative costs.

Restoration Improvement Grant

In 2022 the Department of Transport provided an allocation of €7,269,000 under the Restoration Improvement Grant to Monaghan County Council for the rehabilitation of Regional and Local Roads

identified as having a PSCI rating of between 1 and 4. 42.4km of road were upgraded in 2022, 31.2kn Local & 11.2KM Regional.

Restoration Maintenance

The Department of Transport allocated grants totalling €2,002,500 in 2022 for the resealing and restoration of skid resistance on the non-national road network. 83.5km of roads were upgraded in 2022, 71.5km Local & 12.0km Regional.

Discretionary Grant

A grant allocation of €2,070,500 was received in 2022 from the Department of Transport under the Discretionary Grant. The funding is predominately used by the Municipal Districts to carry out maintenance works such as minor pavement improvement works, drainage renewal, footpath restoration, pothole repairs, gulley cleaning, hedge and verge trimming and the renewal of road signs and markings on Regional and Local Roads.

Specific Improvement Grant

R181 Drummillard to Crossduff: €150,000 The Department of Transport allocated €150,000 in 2022 to advance the detailed design and CPO process for this scheme.

Brackley Bridge



The Department of Transport provided a funding allocation of $\leq 1,000,000$ in 2022 to complete the Brackley Bridge project. This project was substantially complete in 2022. The works included the replacement of a collapsed bridge that traversed underneath the L-4210 road, upgrade and widening works on the L-4210 road

over a length of 300m, improvements to the L-4201/R180 junction with the resurfacing of 425m of the R180 and the installation of a vehicle restraint system.

Bridge Rehabilitation

In 2022, an allocation of €788,500 was received from the Department of Transport for the rehabilitation of 14 bridges. This allocation was the 4th highest out of the 28 Local Authorities who received a funding allocation under the Bridge Rehabilitation Grant.

Safety Improvement Works

An allocation of €262,000 was received in 2022 for the delivery of twelve low-cost safety improvement Schemes.

Training Grant

In 2022 the Regional and Local Road Grants included €53,000 for non-national road training for Local Authority engineering and administration staff.

Local Improvement Schemes

Funding allocations totalling €932,009 were received from the Department of Rural and Community Development under two rounds in May and July 2022. 5 lanes were completed in Round 1 with a further 9 lanes completed in round 2.

Community Improvement Scheme

An allocation of €432,850 was received from the Department of Transport in 2022, which, together with community contributions, enabled the resurfacing of 4 roads.

Pilot Schemes in 2022

The RAP Trial was undertaken on 2km of the R180 in Lough Egish in July 2022. Continuous monitoring and testing are being undertaken on a monthly basis for the next year to ascertain how the road/material is preforming. The trial generated a lot of interest on a national level with various roads authority representatives from different local authorities arriving on site to observe the trial. The scheme was presented at the National TII conference in September 2022.

Climate Change Adaptation Funding

An allocation of €418,000 was received in 2022 for the delivery of six climate adaptation and resilience works schemes.

National Roads

N54 Tullybryan

Monaghan County Council Roads Department are working in partnership with Transport Infrastructure Ireland (TII) to upgrade a 3.1km section of the N54, which will enhance Road Safety and east/west connectivity. The proposed scheme will deliver improvements to the visibility and cross section of the route and aims to provide significant improvements to the long-term accident rates and reduction in fatalities. A Compulsory Purchase Order to acquire lands was published in June 2022. The Total Scheme Budget for this project is €17.3 million.

N53 Ballynacarry Bridge

The Ballynacarry Bridge is located on the border with Northern Ireland on the N53 National Secondary Road and A37 in County Armagh. The main objective of the new bridge project is to address safety issues, by improving alignment and incorporating road widening into the design. A consultant was appointed in April 2022 to progress the project through the various phases of the TII Project Management Guidelines. Various on-site surveys were completed in 2022 with data collected used to inform the route selection process. The project will progress into Phase 4-Statutory Processes in 2023, subject to TII approval.

Safety Schemes (National Roads)

Following a serious collision in June 2022, Monaghan County Council collaborated with Donegal National Road Design Office to develop a Safety scheme along the National Road, N2 on the northern approach to Emyvale Village. Various options were developed and assessed to ensure that the primary objective of reducing the speeds of south bound vehicles approaching the village is achieved. Transport Infrastructure Ireland's Road Safety section were consulted throughout Q4 2022 for comment on the Feasibility and Options Report for the scheme, with feedback resulting in some amendments to the design.

In addition, Feasibility and Options Reports were prepared in 2022 and subsequently submitted to TII for approval for the following locations-

- N2, Cluain Ard junction at St Macartan's College.
- N12, Skinnagin junction.

As part of the TII Road Safety Improvement Programme 2022, 1.05km of timber post & rail fencing was replaced with timber post & tensioned mesh at various locations along the National Road network at a cost of €60,000.

National Road N2 Cycle Paths

An allocation of €345,000 was provided by TII in 2022 to fund the design of four cycle path schemes on the N2. Locations are as follows

- Ballyalbany Junction to Coolshannagh Roundabout (0.8km).
- Emyvale Village (0.25km).
- Corlat Roundabout to the Collegiate College (0.65km).
- Upgrade of Hard verge to Cycle Path N2 Ballyalbany to Tydavnet Junction (5.2km).

These schemes progressed through Phases 1, 2 & 3 of the TII Project Management Guidelines in 2022. Detailed Design and Environmental Evaluation progressed and discussions with potentially affected landowners with regards to land acquisition were initiated.

Pavement Renewals on National Routes

In 2022, two major Pavement Rehabilitation Projects progressed with a combined budget of €3.4 million. The N2 Tullyvin to Lislanly Pavement Rehabilitation scheme (Castleblaney Bypass South) involved pavement strengthening and Vehicle Restraint System replacement for 5.80km. The N2 Monaghan Town (adjacent to Kingspan) scheme involved the resurfacing of 300 metres of carriageway.

National Route Maintenance & Defects Works

Targeted road resurfacing and repairs were carried out to distressed sections on the National Road network at locations including N54 Edenaforan, Smithborough and Legnakelly. Additional maintenance works including isolated drainage improvements and hedge/verge maintenance were implemented throughout the network. Other works included pedestrian lights replacement at Church Square, Monaghan Town and acoustic fencing replacement along the N2, south of Carrickmacross.

N2 Ardee to Castleblayney Road Scheme

Monaghan County Council is working in partnership with Louth County Council and in association with Transport Infrastructure Ireland (TII) and Westmeath National Roads Office (WNRO) to develop the N2 Ardee to Castleblayney Road Scheme, which proposes to upgrade 32km of the N2 to dual carriageway standard. Jacobs Engineering Ireland (Jacobs) is the Consulting Engineer for the scheme.

In 2022 the project team continued to develop Phase 3 - Design and Environmental Evaluation – in which Jacobs developed the road alignment design, identifying the land take required, and undertaking an Environmental Impact Assessment.

By Summer 2022, a wide range of surveys and investigations were substantially complete, and the N2 Project Team had prepared an initial design for the proposed road. Approximately 300 landowners were directly affected, and the project team held meetings with these landowners over a 5-week period in Carrickmacross, online in September and October 2022. The initial design was then published on the project website www.N2monaghanlouth.ie to allow the wider community to view details of the proposed road, including sideroad diversions and access arrangements. Feedback or submissions in relation to the initial design could be made directly to the project team for consideration. The N2 Project Team is to consider this feedback before a design is finalised in 2023 and the Compulsory Purchase Order (CPO) documentation and Environmental Impact Assessment Report (EIAR) are prepared.

N2 Clontibret to Border Road Scheme

The project entered Phase 3 (Design & Environmental Evaluation) in February 2021, however as no funding was received in 2022 the project was suspended in early 2022 and the Phase 3 design process could not be progressed.

Opportunities to source other funding to progress the project through the 'Shared Island Initiative' were explored, but the available funding did not support a project of this scale. Monaghan County Council then commenced a funding application through the EU's 'Connecting Europe Facility,' with the closing application date for applications in January 2023. An indicative date for decisions on the funding is June 2023.



Active Travel Unit

Monaghan County Council secured an allocation of €2,500,605 from the Active Travel Investment Grants for 2022. This allocation was for 46 schemes in total across various project codes. This targeted funding will make walking and cycling in our towns and villages safe and sustainable. The range of projects to be delivered include upgrades along our existing Greenway, footpath/cycleway provision, streetlighting, pedestrian crossings, pedestrian bridges and safe to school infrastructure as well as the development of a Local Transport Plan.

An Active Travel Unit has been established within the Transportation Section, consisting of 4 staff tasked with the roll out and delivery of the various schemes under this funding.

Upgrade of Monaghan Town Greenway

One of the largest projects which received funding was for the upgrade of 4.5k of the Monaghan Town Greenway. This upgrade included drainage, lighting, fencing, resurfacing and road lining from Roundabout Coolshannagh the to the Threemilehouse Road. By the end of 2022 80% of the works were complete with seating and signage outstanding. As part of Greenway Upgrade, we enhanced the appearances of the entrances to the greenway by planting trees, shrubs and grasses. This also contributes positively to our Climate Action Plan, we planted, 38 Betula Pendula Trees (Silver Birch), 750 Shrubs/Plants and 700 Various Grasses.

Walking & Cycling Strategy

Several actions in the Walking & Cycling Strategy are completed or at various stages of progression. A Walking & Cycling Interdepartmental Committee has been established with senior staff from various relevant sections leading and delivering on various actions.

A Walking & Cycling Forum consisting of external stakeholders with an interest in walking and cycling matters was also formed. This forum will continue to meet quarterly and input into ongoing policy and the practical development of sustainable transport solutions in walking and cycling in Co Monaghan.

New Walkway for Castleblayney

The new walkway is located between Coill Darach & Knocktornagh Housing Developments. The installation of a new footpath, upgrade of existing path and new streetlighting will enhance the permeability of this part of the town by opening a direct pedestrian/cycling route from the rear of these estates to facilitate movement between the estates, allowing a shortcut to the nearby community amenities/town centre.

EU Mobility Week

To mark European Week of Sport and EU Mobility Week, the Active Travel Unit and Sports Partnership in partnership with the Wellness Committee planned some lunch time staff events from 26th – 30th September. These lunch n learn events were a tremendous success. Staff from Planning, the Glen and MTEK offices participated in walking and cycling sessions.

Bike Week 2022

Bike week was another huge success in 2022. 14 different events which included E-bike and family

guided cycles, bike skills workshops for children, a secondary school's cycle along the greenway to Rossmore Park, mountain biking for teenagers, council staff E-bike competition and a number of online webinars took place. Over 200 participants were at in person events and over 380 attended online webinars. Bike accessory packs also were distributed through the libraries and available for collection.

Due to the popularity of our staff e-bike scheme which was launched in September 2021 in 5 locations in the County we have recently added to the fleet. 2 additional bikes have been purchased and are located at Monaghan Fire Station and Monaghan machinery yard. The e-bikes will prove extremely useful for staff who have a variety of duties to carry out in the urban area and also an environmentally friendly method of travel. To date staff have been using the bikes for leisure purposes on their lunch break or attending meetings locally.

Ulster Canal Greenway – Phase 2

Monaghan County Council, along with project partners, Waterways Ireland, Armagh City Banbridge & Craigavon Borough Council and the East Border Region continued to progress the Ulster Canal Greenway Phase 2 project.

The Border to Middletown section in Northern Ireland successfully secured planning permission in May. Detailed design and tender documentation for this section are due to be completed in Q1 2023.

Despite a protracted period of negotiations, Armagh City, Banbridge and Craigavon Borough Council failed to reach agreement with some landowners to acquire the necessary lands to construct the Greenway in Northern Ireland. As a result, the SEUPB confirmed they would no longer fund the project as the project outputs could not be delivered within the timeframe of the INTERREG VA programme. Armagh City, Banbridge and Craigavon Borough Council are actively seeking alternative funding to deliver the section of Greenway in their jurisdiction.

Site investigation works were completed on the Monaghan – Middletown section and this information was utilised to inform the detailed design. The detailed design for the Monaghan – Border section is complete and the tender documentation for the construction stage of this section is due to be completed in Q1 2023.

A Compulsory Purchase Order (CPO) was published in Q3 for the necessary lands to construct the Monaghan to Border section. Three objections were received during the submission period. An Bord Pleanála have indicated a timeframe of Q3 2023 for an oral hearing, should it be necessary to close out the CPO.

Given the departure of the SEUPB from the project, Monaghan County Council commenced discussions with possible alternative funders for the Monaghan to Border section. To date, discussions have been positive with Transport Infrastructure Ireland. A decision on the matter is expected in Q1 2023.

Transport Infrastructure Ireland are now the Approving Authority for the Smithborough – Monaghan section. Draft Part VIII planning documentation for this section has been prepared and agreed with the Approving Authority subject to certain conditions. It is expected to lodge the Part VIII planning application with Monaghan County Council in Q1 2023.

Road Safety

Action 94 of the government's Road Safety Strategy 2021-2030 titled 'Our Journey Towards Vision Zero' tasks each Local Authority with establishing a Road Safety Working Together Group to co-ordinate a multi-agency road safety policy and its implementation at a local level. The holistic Safe System approach has identified seven priority intervention areas namely:

- Safe roads and roadsides.
- Safe speeds.
- Safe vehicles.
- Safe road use.
- Post-crash response.
- Safe and healthy modes of travel.
- Safe work-related road use.

The Road Safety Action Plan for Co Monaghan was developed in 2022 and will be implemented over three phases, the first of which will run until the end of 2024. Phase 2 and Phase 3 will cover the periods 2025-2027 and 2028-2030 respectively. The Co Monaghan Action Plan aims to deliver at a local level the national road safety strategy objective of reducing deaths by 15% and serious injuries by 10% by 2024. Provisional figures for 2022, released by the Road Safety Authority have shown a rise in the number of fatal accidents in County Monaghan. Five fatal accidents occurred during the year, resulting in the loss of six lives. This compares to 2021 provisional figures where five people lost their lives in five fatal accidents.

County Monaghan schools continued to perform well at the Road Safety Authority's national 'Seatbelt Sheriff' competition. Second class students from Annalitten NS, Castleblayney, came out on top in the 'Hi-Glo Silver' category for their "Glow Before You Go!" poster. The annual Road Safety Shows for Transition Year students were again put on hold but are scheduled to resume in March 2023 when approximately 700 pupils will once again attend events in the lontas Theatre in Castleblayney and the Garage Theatre in Monaghan.

This year also saw a welcome return of the RSA's Check It Fits child car seat testing service to the county with two visits to Monaghan Town and one each to Carrickmacross and Castleblayney.

Flocking Arts, a young film makers initiative based in County Monaghan, were winners at the Road Safety Authority's annual Leading Lights in Road Safety Awards for 2022. Their short film which is targeted at young people examines the dangers and consequences of driving under the influence of drugs. Filmed in County Monaghan the project was funded by the Co Monaghan Drugs and Alcohol forum with assistance of students from Beech Hill College and featured interviews with members of the emergency services who deal with the aftermath of collisions involving intoxicants.

Planning

Development Plan

The Monaghan County Development Plan for the period 2019-2025 provides an overall strategy for the proper planning and sustainable development of County Monaghan. It is consistent with both national and regional spatial planning policies and objectives. Spatial planning, through the development plan objectives and policies, endeavours to achieve balance between the common good and the interests of individuals.

Two variations to the County Development Plan were adopted by the elected members in April 2022. Variation No.3 incorporated Objective MPO 15 to, 'Ensure that all development proposals within the Dublin Street North Regeneration Plan area have regard to the regeneration strategy and development objectives of the Dublin Street North Regeneration Plan'. Variation No.4 incorporated Objective MPO 16 to, 'Ensure that all development proposals within the Roosky Lands Master Plan area have regard to the master plan strategy and development objectives of the Roosky Lands Master Plan.'

Residential Zoned Land Tax Mapping

The Residential Zoned Land Tax (RZLT) was introduced in the Budget 2022 under the provisions of the Finance Act 2021. The purpose of the proposed measure is to activate existing planning permissions and zonings where housing is permitted and where the land is connected to, or has access to services (road infrastructure, footpaths, public lighting, surface water, wastewater & water supply), but remains undeveloped. The legislation clearly sets out that land in scope for the tax will be zoned for residential development or a mixture of uses including residential.

Although the RZLT will be administered by Revenue Commissioners, all local authorities are required to undertake mapping to identify the lands in scope for the tax in their respective functional areas. The RZLT mapping is required to be carried out on an annual basis.

The applicable date for lands zoned and serviced to be liable for the tax was 1st January 2022 with the final date for inclusion of lands on the Draft Map being 1st October 2022. Local authorities were required to undertake mapping to identify the lands in scope for the tax in their respective functional areas and publish these maps by 1st November 2022. Interested parties (landowners and members of the public) were able to make comments on the published maps by 1st January 2023 indicating errors or omissions or detailing why the lands should or should not be in scope for RZLT.

A total of 80 submissions relating to 92 land parcels were received. A final determination on lands in scope and notification of landowners is required by 1 April 2023.

Housing Need & Demand Assessment

Every local authority is now required to carry out a Housing Need and Demand Assessment (HNDA) to enable it to:

- develop long-term strategic views of housing need across all tenures,
- provide a robust evidence base to support decisions about new housing supply, wider investment and housing related services that inform an overall national housing profile,
- inform policies about the proportion of social and affordable housing required,
- provide evidence to inform policies related to the provision of specialist housing and housing related services.

KPMG consultants were engaged by the Planning Section to carry out the HNDA and a draft report was prepared by the consultants in 2022 for review by the Planning and Housing Sections.

Housing Provision Review

KPMG consultants were also engaged by the Planning Section to carry out a Housing Provision Review, which is an analysis of existing housing provision in County Monaghan and a review of progress on the delivery of housing units on zoned residential land in the County Development Plan 2019-2025.

Following an extensive consultation process with stakeholders such as landowners, planning agents, estate agents, solicitors and financial institutions a draft report was prepared by KPMG consultants for review by the Planning Section.

Development Management

The Planning Authority received 542 planning applications, 20 extension of durations of planning permission, and 30 exempt development applications during 2022. Although the number of applications received in 2022 was lower than that received in previous years, it is noted that there was an exceptional 18% increase in applications received in 2021 over that received in 2020. Although the influx of applications in 2021 seems to have resulted in less applications being received in 2022, the average number of 691 applications received over the two years of 2021 and 2022, is still an increase on the numbers received both in 2019 and 2020.

Whilst the majority of applications received were for single dwellings, home extensions and agricultural development, a number of significant and complex applications, (most of which were accompanied by Environmental Impact Assessment Reports and Natural Impact Statements) were submitted in 2022. Applications of note submitted in 2022 included:

- Permission for the excavation of the former underground mine by open cast mining methods for the purposes of gypsum extraction incorporating community sports complex at Drumgoosat, Magheracloone
- Permission for a significant extension to Silverhill Foods Ltd at Emyvale

- Permission for a significant extension to Abbot Ireland Ltd at Cootehill
- Permission for a new school at Killycard, Castleblayney
- Permission for a new community centre at Magheracloone

17 decisions were appealed to An Bord Pleanala in 2022, which represents 3% of the applications received in 2022.

The Planning and Development (Amendment) Act 2018 (Commencement) Order 2021 (SI 714 of 2021) brought section 23(4) of the Planning and Development (Amendment) Act 2018 into operation on 17 December 2021. This legislation requires the Planning Authority to deal with any compliance submission in respect of a condition(s) attached to a planning permission which requires the written agreement of the Planning Authority within a time limit of eight weeks. The 146 compliance submissions received by the Planning Authority in 2022 placed additional pressures in terms of issuing responses within a statutory time limit.

There was also a 30% increase in the number of planning searches received from solicitors in 2022 compared to 2021.

Planning Registers

A detailed review of the Planning Registers was carried out in 2022. This significant body of work has ensured all registers which are required to be maintained by the Planning Authority in accordance with Section 7 of the Planning and Development Act 2000 (as amended) are easily accessible and maintained going forward in accordance with the planning authority's statutory obligations.

E-planning

Training for the Planning Section in advance of the roll out of E-planning commenced in September

2022. Meetings were held between key personnel from the LGMA Working Group, and the Planning, IT & Finance Sections to discuss systems and requirements needed prior to going live. Testing of the new portal with Laserfiche was also undertaken in advance of E-planning going live in Quarter 1 of 2023. Training for internal consultants and agents on the new system will be held in advance of the roll out.

Taking in Charge

30 estates were progressed through various stages of the taking in charge assessment process in 2022. A number of estates underwent a technical assessment in 2022 to enable them to be progressed to taking in charge in 2023. A significant number of applications are currently with Uisce Eireann for agreement and it is hoped that these can be substantially progressed in 2023. At least two developments require Site Resolution Plans to be agreed with Uisce Eireann.

The Planning Section also continued to pursue security bonds on a small number of developments throughout the County. The Planning Section will continue to progress the Taking in Charge of residential developments in 2023.

Planning Enforcement

When the Planning Authority becomes aware of a breach of planning permission or unauthorised development, discussions with offender(s) are often sufficient to ensure remedy. However, where issues are not addressed by the offender then formal enforcement action is taken. Continued development activity throughout the County in recent years has resulted in an approximate 10-20% increase in case numbers. Enforcement statistics for 2022 are set out below.

The number of planning enforcement complaints received during 2022 is broadly on a par with 2021, although a higher level of enforcement notices were issued than in the previous year. The planning authority has moved up two places to now rank 9th nationally in terms of percentage of cases closed on foot of formal enforcement proceedings. Overall, the total number of cases open has reduced from 2021 following a review of historical and long-standing cases.

Development Contributions

Early invoicing and enforcement action in the recovery of unpaid development contributions has resulted in receipts amounting to €1,208,999 in 2022.

Derelict Sites

Work continued in 2022 on addressing dereliction in the County with seven sites added to the Derelict Sites Register. No sites were removed from the Derelict Sites Register during the year. There were thirty-one sites on the Derelict Sites Register at 31st December 2022.

Regeneration

Ongoing support was provided in project identification, project development, preparation and submission of applications under the Town and Village Renewal Scheme.

A total of €247,952 was secured under the Historic Towns Initiative, funded by the Heritage Council for the project, 'Re-establishing residential use in historic Dublin Street, Monaghan'. In 2022 work was carried out to provide external enhancements to eight buildings and internal refurbishment of two buildings to facilitate residential use.

The Dublin Street North Regeneration Plan and the Rooskey Lands Masterplan were adopted by the elected members in April 2022 by way of Variations 3 and 4 to the Monaghan County Development Plan. These plans provide a framework for the future comprehensive development of these town centre areas.

Built Heritage

Monaghan County Council's Planning Section administer two annual heritage grant schemes annually, the Built Heritage Investment Scheme (BHIS) and the Historic Structures Fund (HSF).

The Built Heritage Investment Scheme encourages the investment of private capital in small scale, labour intensive projects to repair and conserve historic structures and to support the employment of skilled and experienced conservation professionals, craftspeople and tradespersons. County Monaghan received an overall allocation of €96,000 in 2022.

In 2022 nine projects were awarded funding under the BHIS, with eight availing of same as follows:



The primary focus of the Historic Structures Fund is on conservation and enhancement of historic structures and buildings for the benefit of communities and the public. It aims to enable conservation works to be carried out on heritage structures which are deemed to be significant and in need of urgent support. Total funding under the HSF for 2022 was €147,970 and three projects received funding as follows:

- Holy Trinity Church, Dartrey, Rockcorry
- St Macartan's Cathedral, Monaghan
- Rossmore Mausoleum, Monaghan

Section 57 Declarations

Under the Planning and Development Act 2000 (as amended) works which would normally be considered exempted development under Section 4(1)h of the Act may not be exempt in respect of a Protected Structure or a Proposed Protected Structure.

Section 57 of the Act allows for the owner or occupier of a Protected Structure or a Proposed Protected Structure to make a written request to the Planning Authority to issue a declaration as to the type of works which it considers would or would not materially affect the character of the structure or any element of the structure, thereby clarifying which works would be considered exempted development and those which would require planning permission. Monaghan County Council issued five Section 57 Declarations in 2022.

Monaghan County Museum



Monaghan Murals: Rossmore Castle Returns to Monaghan!

The *Monaghan Murals* project launched in 2021 when a mural in Castleblayney, featured in an earlier newsletter, was unveiled in the town. This mural was inspired by the photography of Castleblayney native Dr JJ Clarke. Fast forward a year and three more murals are enlivening towns across Co. Monaghan. The fourth and latest of these was unveiled in Monaghan town this October and in the dull and dreary winter weather no one could fail to have their day brightened by this new work of art.

This latest addition to the *Monaghan Murals* project features Rossmore Castle and is

fittingly located on the back wall of The Westenra Hotel, named after the Westenra family who were incumbents of the Rossmore title, and the residents of the original Rossmore Castle that was situated just outside the town. Rossmore Castle was built in 1827 by the second Baron Rossmore. It was enlarged in 1858 and over time further small changes resulted in a building of some three towers and 117 windows! Following World War II, the stately Rossmore Castle was beset with a serious case of dry rot and eventually became lost to the county when it was demolished in the 1970s. Now the former glory of the castle has been recaptured in this mural by the artist Omin, allowing Monaghan's younger generations to once more marvel at its architectural splendour.

National Museum of Ireland Inspection of Loans

Monaghan County Museum plays a vital role in preserving the archaeological heritage of the country and under Section 68 (2) of the National Cultural Institutions Act, 1997 is legally entitled to retain archaeological objects on behalf of the State. The curators of designated museums have the authority to act on behalf of the Director of the National Museum of Ireland (NMI) to ensure that discovered objects are investigated, reported and preserved as State property.

To reach a wider audience and increase public access to its collections, the NMI lends objects from its collections to designated museums. Monaghan County Museum has several objects on display that are on loan from the NMI including the late bronze-age Lisdrumturk Cauldron, bronze swords, weapons and a Viking sword.

Monaghan County Museum must meet strict guidelines to ensure all objects are kept in environments suitable to their material and maintain tight security controls for the objects on loan. The Collections Care team in the museum are responsible for monitoring and recording the environmental conditions for these objects and for facilitating regular inspections of the items by the NMI during the loan period.

Recently, the museum welcomed Isabella Mulhall, Assistant Keeper of Antiquities and Dr Paul Mullarkey, Conservator from the NMI as they undertook their most recent site inspection.

As a result of their visit, the NMI were satisfied that the physical and environmental standards at the museum were being monitored and maintained correctly and were happy to extend the loan of these objects for a further three years.

Blended Working

In this context, Monaghan County Council implements Blended Working while maintaining commitment to the delivery of the highest standard of public services directly to citizens and local communities.

There is a minimum office attendance of 3 days per week for full-time employees.

Training & Development

The Human Resources Department engages with line managers and staff in promoting their personal and career development thus enabling them to reach their potential and contribute fully to the achievement of the Councils strategic and business objectives.

Gender Pay Gap 2022

Monaghan County Council published its Gender Pay Gap Report for 2022 on the 19th December 2022. The Gender Pay Gap Information Act, 2021 requires organisations with over 250 employees to report on their Gender Pay Gap. 2022 was the first year that organisations were required to report on their Gender Pay Gap. Organisations were asked to select a 'snapshot' date in the month of June. The reporting period is the 12 month period immediately preceding and including the snapshot date. For local authorities, the snap-shot-date was the 30 June 2022. The information must be published on the employer's website or in some other way that is accessible to all its employees and to the public.

WHO IS INCLUDED?

All persons employed by the employer on the snapshot date, including employees not rostered to work on that date and employees on leave. The mean and median figures must also be given separately for parttime and temporary employees.

WHAT DO WE MEAN BY THE GENDER PAY GAP?

The Gender Pay Gap calculates the percentage difference between the average earnings of males and females irrespective of their role. The Gender Pay Gap is not the same as equal pay. Employment Equality legislation provides for equal pay for like work. All male and female employees in the local government sector are paid equally for work that is the same or similar or for work of equal value, therefore this report does not examine equal pay. Rates of pay within the sector are agreed through national wage agreements negotiated regularly between employers and staff representatives. Most employees are paid according to an incremental salary scale and the salary ranges for various roles are available on the local government jobs website at

The Service was celebrated by Canon Paddy McGinn, Adm and Rev. Alan McQuade. Bríd Donnelly, Lucy, Charlie and Bobby O' Brien provided the music and the choir was made up of staff from Monaghan County Council.

All those who attended were invited for refreshments following the Service.

Corporate Procurement

Overview

Despite the challenges resulting from inflation pressures and the vacancy in the Procurement Officer role, the Council's procurement activity for 2022 remained consistent with 2021 figures. The Council took a policy decision in 2018 that all procurement competitions above the national threshold would be conducted electronically, and this helped ensure that our procurement activities could proceed smoothly during this turbulent time.

In 2022, The Council published 140 Requests for Tenders using eTenders (91) and <u>www.supplygov.ie</u> (49) platforms. Nineteen of the competitions advertised on eTenders competitions were for values in excess of the EU procurement thresholds (i.e. €5,382,000 for works or €215,000 for goods or services).

The Council's staff conducted 91 quote competitions through the etenders platform using the quick quotes option. This is a substantial increase from last year where 56 competitions were conducted. Of these competitions, 44 were for the procurement of services, 8 for supplies and 39 for works. Conducting quote competitions through this platform ensures transparency for all our purchases regardless of value.

Procurement Procedures

The Council's Procurement Procedures Rev 5. were updated on the SharePoint portal in May 2022, taking account of the updated EU thresholds for procurement and structural change of procurement personnel within the sections. The procedures ensure that procurement is conducted in line with the requirements of Public Sector reform, the Office of Government Procurement, EU Directives and National Guidelines. A step-bystep guide to the Procurement procedures is now available on the Council's Sharepoint, for use by all staff.

Procurement Team

The Procurement Officer role was vacated in early July 2021 and efforts are continuing to recruit a new Procurement Officer and possibly a centralised unit consisting of three staff members. In the interim period the Assistant Procurement Administrator continues to guide and support all procurement operations to help ensure that goods, services and works are procured in compliance with all relevant legislation and guidelines, while managing risk and achieving value for money. Through ongoing learnings from the management and ownership of procurement competitions, the Procurement Leads and Admin Leads in each department have developed significant expertise in procurement practices.

Public Spending Code

The Council issued a Quality Assurance Report to NOAC in May 2022, to confirm compliance with the Public Spending Code (PSC). The report included an inventory of all projects/programmes costing greater than €0.5m, distinguishing between capital and current expenditure and categorised by expenditure being considered, expenditure being incurred, and expenditure recently ended. The PSC also requires the Council to publish procurements with a value of more than €10m and to submit self-assessment checklist.

Model Publication Scheme

The Council is obligated to report quarterly on public contracts (tenders) awarded, for the Model Publication Scheme, which is part of the Freedom of Information regime. The publication relates to all public works contracts with a value over \in 25k. All Sections have assisted in the compilation of contracts awarded for 2022 and this information has now been published on the Council's website and can be found on the following link:https://monaghan.ie/corporateservices/procure ment/

Office of Government Procurement (OGP)

The Council has signed a 'Memorandum of Understanding' with the Office of Government Procurement (OGP), which sets out the principles governing the procurement relationship between the two parties. The arrangement recognises that the Council and the OGP are engaged in a partnership focussed on delivering efficient and suitable procurement services and value for money, ultimately to assist the local authority in meeting service delivery needs.

The Council continues to avail of OGP frameworks for all procurement processes, where possible.

Covid 19 PPE

The requirements for Covid 19 PPE diminished significantly throughout 2022, as remote working became established early in the year. The Assistant Procurement Administrator collated all the Council's PPE requirements, across all sections, to ensure that adequate PPE was ordered to meet all needs. The Procurement Unit co-ordinated the distribution of the PPE to the various sections as requested.

Strategic Policy Committees

The role of Strategic Policy Committees is to formulate policy proposals, evaluate and report on policy implementation for consideration; provide policy centred committees which can harness the experience of external bodies in the formulation of policy. The Committees are not designed to deal with routine operational matters in relation to the delivery of services.




In September, a review was carried out on the role and purpose of the SPC, with members and the Executive committed to dealing with as many topics as possible within the remit of the SPC.
