### Key Information for Potential Operators

While the overall canal network will take some years to fully connect to the Erne and Shannon, in the short term the new body of water and short section of water at Clones provides a range of leisure and recreational opportunities for enjoyment by both visitors and the local community. It is important to note that no mooring jetties will be installed until Phase 3 is complete and the development is open to navigation.

The Phase 2 investment at the Ulster Canal at Clones provides an opportunity for an operator to create a high-quality recreation and leisure experience with a focus on destination development, sustainability and community benefits.

We believe the site offers a range of recreation, leisure and amenity opportunities for use by both visitors and the local community, particularly with improved links to the town centre. At this stage, we don't want to be too prescriptive as to the type of use. We are keen to encourage innovative and creative activities at the site, which could include:

- · On-water products and uses
- Land-based recreation, e.g. bike hire
- · Extending the catering offer
- · Performance space and events

A range of background information is provided in this Prospectus, which sets the context and articulates the opportunity for a new operator. Procurement arrangements are summarised opposite:

### Stage 1: Market Soundings

Waterways Ireland proposes to enter into a Market Soundings process with potential providers, who are interested in delivering a high-quality visitor experience(s) and community resource, with a focus on both on-water and land-based activities. Waterways Ireland is keen to encourage innovative and creative activities at and around the canal basin, which will contribute to the overall vision for the site.

The Market Soundings will provide an opportunity to engage with interested parties who may have ideas on potential uses, and this will inform the next stage of the process. Through discussions, partners will be able to be more definite about activities that can be delivered by the market - as well as helping to define the sort of activities that are not appropriate at the facility.

### Stage 2: Competitive Tendering

Following the Market Soundings and subsequent conversations with interested parties, the project partners will produce a specification with parameters clearly defined relating to the provision of destination services and facilities within the Phase 2 waterside development site.

The specification produced will form the basis of a competitive public concession tender which will be published by Waterways Ireland on the procurement portal **www.etenders.gov.ie** on behalf of the project partners.

#### Introduction

Located adjacent to the historic town centre of Clones in County Monaghan, Clones Marina and the associated 1km of canal that is due to open in 2024 will be a new water-based asset along the Ulster Canal which is being restored and rediscovered on a phased basis.

While the overall canal network will take some years to fully connect to the Erne and Shannon, this new Marina and short section of canal in Clones provide opportunity for the town to enjoy, test and develop its connection to the water and confirm its place as a hub within the wider region.

Initial conversations between Failte Ireland, Monaghan County Council and Waterways Ireland propose that Clones has the opportunity to build on its heritage, community and industry assets to become a memorable and unique visitor hub.

This document outlines this exciting opportunity and proposes a vision to be developed alongside the local community, businesses and industry to help decide the future of Clones Marina.



A very strong turn out of 287 responses were recorded and analysed through the consultation process in October 2023.

Alongside this online questionnaire, an in-person information day was held in Clones Town centre - and advertised widely through each of the three partners' channels and networks - so as to garner as much local interest and responses as possible. Below are a number of key themes from this successful response:



A very strong support has been received for the draft Vision Statement as issed as part of the consultation. Out of a total of 270 responses to this question, over 91% of respondants liked this vision statement. With additional comments now received, this Vision has now been further refined to reflect additional ideas

#### **Outdoor Activities** for visitors and locals

Across a wide variety of written responses received, there was a strong interest from the public in providing for outdoor activities and active infrastructure at the future Clones Marina site.


#### **Safe Connectivity** to the town centre



### Where is the site within the town of Clones?





### **Operational Considerations**

We are keen to ensure that any uses complement facilities at the Ulster Canal Stores, enhances destination appeal and contributes to the regeneration of Clones town.

Any future operation will need to adhere to the local plan and landuse zoning designation. The area is designated as a recreation and amenity zone, where the provision of tourist facilities is open for consideration. Any permanent or semi-permanent structure is likely to require planning consent from the Council.
