# **Urgent Business**

On the proposal of Cllr S Conlon, seconded by Cllr P Conlon it was agreed to suspend Standing Orders to receive a delegation from the Irish Farmers Association.

Speakers from the IFA asked that Monaghan Co Co would do its utmost to highlight the issues raised and seek a fundamental reset of how farm policy is devised and implemented both at the EU and in Ireland.

The Speakers asked that Monaghan Co Council support the following motion:

'Monaghan County Council resolves to write to the President of the EU Commission, the Taoiseach and the Minister for Agriculture advising them that the Council has passed the following resolution.

Monaghan County Council supports the IFA 'enough is enough' campaign.

The Council recognises the significant contribution that farming, and the Agri-sector makes to the Irish and local economy.

The Council acknowledges the income challenge on Irish farmers arising from the significant increases in the cost of doing business, regulatory costs and cuts in Basic Income support for farmers.

The Council calls on the Government to introduce no further regulations on farmers or any measures that may increase costs on farms without full negotiation and agreement with the Irish Farmers Association (IFA). The Council calls on the European Union and the Irish Government to provide additional stand-alone funding, separate to the Common Agricultural Policy (CAP), to support farmers to undertake climate and biodiversity measures'.

The Cathaoirleach informed the members that he had received a second notice of urgent business as follows:

'That focused on the key principles of social, economic, and environmental sustainability, Monaghan County Council agree to proceed with the development of Lough Muckno and its environs. In so doing, Monaghan County Council agree to the engagement of consultants to progress the proposed 10-year Masterplan and Development Framework for Lough Muckno and its environs.'

On the proposal of Cllr A Campbell, seconded by Cllr PJ O'Hanlon, it was agreed to enter 'into Committee' to discuss whether to accept the motions submitted as urgent business.

Following a short discussion, it was agreed to take the motions of urgent business at the end of the meeting.

On the proposal of Cllr C Bennett, seconded by Cllr B McKenna, it was agreed that the Council revert to public session.

## Proposals arising out of correspondence:

On the proposal of Cllr C Carthy, seconded by Cllr R Aughey it was agreed that this Council support the Cork Co Co motion calling on the Minister for Finance, An Taoiseach and An

Tánaiste to ask that the VAT rate for pubs should be reduced down from 23% to 17%.

On the proposal of ClIr B McKenna, seconded by ClIr C Bennett it was agreed that this Council support the Cork Co Co motion calling on the Minister for Finance, An Taoiseach, An Tánaiste to ask that the hospitality VAT rate be reverted to 9% and that the collection programme be fair and sensible.

On the proposal of ClIr C Bennett, seconded by ClIr N Keelan it was agreed that this Council call on the Government of Fianna Fáil, Fine Gael and Green Party to provide the additional funding of 5.9 million needed to achieve proper road maintenance in Co Monaghan as referred to in the NOAC Report.

On the proposal of Cllr PJ O'Hanlon, seconded by Cllr A McCooey it was agreed that this Council call on the Minister for Finance, Michael McGrath to liaise with Minister Eamonn Ryan and Minister Jack Chambers in relation to additional funding for the 'hot tarring' to fill the potholes in Co Monaghan.

3. To consider Part VIII approval for PT8MN63 Ballyalbany Bridge - Construction of a new pedestrian and cycle bridge on the east side of the existing Ballyalbany Bridge

Mr A Hughes, Senior Planner outlined the Part VIII proposal circulated with the agenda. He advised that the proposed development is the construction of a new pedestrian and cycle bridge on the East side of the existing Ballyalbany bridge, which is a protected structure. The new bridge will directly abut the existing bridge. The new bridge will be adjoined to the existing bridge but will be supported independently via new piled abutments and new wingwalls.

Mr Hughes recommended that the members proceed with the proposal. Mr Hughes and Mr K West responded to members questions.

On the proposal of ClIr R Aughey seconded by ClIr C Bennett, it was agreed that the Council approve the construction of a new pedestrian and cycle bridge on the east side of the existing Ballyalbany Bridge as detailed in the Chief Executive's Report of 12 February 2024 prepared in accordance with Part VIII of the Planning and Development Regulations 2001 (as amended).

Cllr S Conlon abstained on this proposal.

4. To consider Part VIII approval for PT8MN 64 Horseshoe Bridge - Construction of a new pedestrian and cycle bridge on the west side of the existing Horseshoe Bridge

Mr A Hughes, Senior Planner outlined the Part VIII proposal circulated with the agenda. He advised that the proposed development is for the construction of a new pedestrian and cycle bridge on the west side of the existing Horseshoe Bridge. The new bridge will directly abut the existing bridge. The new bridge will be joined to the existing bridge but will be supported independently via new piled abutments and new wingwalls.

Mr Hughes recommended that the members proceed with the proposal. Mr Hughes and Mr K West responded to members questions.

On the proposal of CIIr B McKenna seconded by CIIr R Aughe, it was agreed that the Council approve the construction of a new pedestrian and cycle bridge on the west side of the existing Horseshoe Bridge as detailed in the Chief Executive's Report of 12 February 2024 prepared in accordance with Part VIII of the Planning and Development Regulations 2001 (as amended).

Cllr S Conlon abstained on this proposal.

5. To consider Part VIII approval for PT8MN67 Glenmore Quarry - Refurbishment works are proposed at Glenmore Quarry, Carrickroe, Co. Monaghan.

Mr A Hughes, Senior Planner outlined the Part VIII proposal circulated with the agenda. He advised that the proposed development is to upgrade facilities at the existing council facility at Glenmore, Carrickroe to afford for the reception, storage and transfer of inert bituminous material. The proposed development includes the provision of a hard standing area, weighbridge and welfare facility.

Mr Hughes recommended that the members proceed with the proposal. Mr Hughes and Mr K West responded to members questions.

On the proposal of ClIr B McKenna seconded by ClIr R Aughey, it was agreed that the Council approve the proposed refurbishment works at Glenmore Quarry, Carrickroe, Co. Monaghan as detailed in the Chief Executive's Report of 12 February 2024 prepared in accordance with Part VIII of the Planning and Development Regulations 2001 (as amended).

6. To receive Chief Executive's Report on submissions received on Pre-Draft Public consultation process of Monaghan Co Development Plan 2025-2031 at March Co Co Meeting

Mr T Gourley, Senior Executive Planner advised members that the review of the current County Development plan and the preparation of a new County Development plan for the period 2025-2031 formally commenced last year. He stated that an eight-week Pre-Draft Consultation process was held to gather opinions on the content of the Draft Development Plan. A Strategic Options and Issues Paper was on public display which set out the key discussion topics of Climate Change, Environment & Heritage, Infrastructure & Services, Settlement Strategy, Housing Strategy, Community Services / Facilities, Economic Activity, and Environmental Assessment & Monitoring.

The consultation process attracted sixty-six submissions from a wide range of public bodies, other organisations and individuals. In accordance with Section 11(4)(b) of the Planning and Development Act 2000, this report provides for the elected members a summary of the issues raised in the sixty-six written submissions received, the Chief Executive's opinion on the issues raised and his recommendations on the policies to be included in the draft development plan.

Mr Gourley stated that workshops will be arranged with each grouping over the next few weeks to assist members in reviewing the report and to discuss the matters arising within it

Mr Gourley responded to members' queries. The Cathaoirleach thanked Mr Gourley for his presentation.

## 7. To consider the Draft Policy and Procedure for Derelict Sites.

Mr K McNally, Town Regeneration Officer provide members with a presentation on the Draft Policy and Procedure for Derelict Sites. He stated that the policy set out the methods which the Council would use going forward to reduce the level of derelict properties in the county in conjunction with relevant Government policies such as the Town Centre First policy and the Housing for all Strategy. During the course of his presentation, Mr McNally referred to issues leading to property dereliction and vacancy; schemes/initiatives to deal with vacancy and dereliction; progress to date in dealing with dereliction and next steps.

On the proposal Cllr S Gilliland seconded by Cllr S Conlon it was agreed that the Draft Policy and Procedure for Derelict Sites as circulated, be approved.

#### 8. To consider the Arts Partners Grant Scheme

In accordance with the Ethics Framework, Cllr Bennett declared a possible conflict of interest in relation to this item and withdrew from the meeting room whilst the matter was being dealt with.

The members considered the report from the Arts Officer recommending the allocation of grants under the Arts Partnership Grant 2024. The Arts Officer responded to members' queries.

On the proposal of ClIr A McCooey, seconded by ClIr N Keelan, it was agreed that the Council approve the allocation of the following grants under the Arts Partnership Grant 2024:

# 10. To consider the Traffic Calming Policy 2024

Mr K West, A/Senior Engineer outlined the Draft Traffic Calming Policy 2024 circulated to members. He stated that the **objectives** of the policy are to:

- Provide guidance and a standardised procedure for implementing traffic calming measures within County Monaghan
- Improve Road Safety
- Reduce and control vehicular speed
- Improve driver awareness of vulnerable road users
- Enhance the environment
- Reduce noise, disturbances and anxiety in our towns and villages

The aims of the **policy** are to:

- Incorporate traffic-calming measures at the planning and design stage of all new schemes.
- Introduction of an appraisal system for traffic calming on existing public roads.
- Introduction of a prioritising scheme selection system.
- Set up a shared centralised database between the Three MDs and the Roads Section to:
  - I. hold all requests for traffic calming measures from the public and elected members,
  - II. act as a knowledge share database.

Mr West outlined the phases of the Traffic Calming Implementation process from initiation through to formal consultation, funding approval and implementation. Mr West responded to members' queries.

Cllr R. Aughey proposed, Cllr C Bennett seconded that the Traffic Calming Policy 2024 as circulated, be approved. A vote by show of hands resulted in 14 for, 1 abstention. The Cathaoirleach declared the proposal carried.

# 11. Diospoireacht as Gaeilge / Tuarascail Bhliantuil - Coiste na Gaeilge

Cllr P Treanor introduced the presentation by highlighting that the Coiste spent almost €12,000 in 2023. He advised that the All-Ireland Ceili Band would visit the Garage Theatre on Sunday next to start Seachtain na Gaeilge. Cllr Treanor thanked Nial Ó Conchúir for his work and thanked the other members of the Coiste Gaeilge for their work during the year and outlined details of the activities listed in the report.

An tUasal Nial Ó Conchúir, Oifigeach Gaeilge outlined the work of the Coiste Gaeilge during 2023 and thanked them for their help and support. He stated that the Coiste aims to promote the use of the Irish language in Co Monaghan as well as insuring that the Council fulfils its obligations under the Official Languages Act.

He highlighted the Coiste's activities during 2024:

- 1. The Coiste held 4 meetings.
- 2. The Coiste organised a concert for Nollaig na mBan.
- 3. Two community groups availed of Seachtain na Gaeilge funding.
- 4. 37 scholarships were awarded to students to attend the Gaeltacht.
- 5. The Coiste funded Ulster Comhaltas to host Omós na nUltach, composed by Scotstown native, Michael Rooney, in the Garage Theatre.
- 6. Funding was given to Monaghan County Comhaltas to promote the use of Irish language at the Co. Monaghan Fleadh.
- 7. The Coiste supported Muineachán le Gaeilge to run Campaí Sproai, which is an Irish language summer camp.
- 8. The Council worked towards compliance with Section 10(a) of the act.

He concluded by stating that in 2024 the Coiste hope to continue their good work and ensure the Council complies fully with the Official Languages Act.

#### 12. To consider the Draft Annual Service Delivery Plan for 2024

Ms. M. McGarvey, A/Senior Executive Officer, outlined the main elements of the Annual Service Delivery Plan (ASDP) for 2024, which had been circulated with the agenda for the

meeting. She stated that the plan, which had been prepared in accordance with the Local Government Reform Act, 2014 and in conjunction with the Draft Corporate Plan 2020-2024, identifies the services that the Council intends to provide to the public in the year ahead. She further stated that the Plan, which reflected the provisions of Budget 2024, sets out the objectives and priorities for each department; the strategies for achieving those objectives and the priorities and performance standards intended to be met. She acknowledged the contribution of all staff and Directors in the preparation of the plan.

On the proposal Cllr H McElvaney seconded by Cllr S Conlon it was agreed that the Draft Annual Service Delivery Plan for 2024 as circulated, be approved.

### 13. To note Annual Report of the Joint Policing Committee for 2023

The Annual Report of Co Monaghan JPC which details the work of the Committee over the past 12 months and is also an important means of communicating and highlighting the role and work of the Committee was noted and agreed by members.

## 14. To consider recommendations and minutes from Corporate Policy Group

The members noted the minutes of the Corporate Policy Group meeting held on 20 February 2024, which had been circulated.

On the proposal of Cllr P Treanor seconded by Cllr R Aughey it was agreed that the minutes of the Corporate Policy Group meeting held on 20 February 2024 and the recommendations contained therein be approved.

# 15. To receive Management Report - February 2024

The Chief Executive introduced the Management Report for February 2024 which had been circulated with the agenda.

The members noted the Management Report.

The Chief Executive and Directors of Services responded to queries from the elected members.

On the proposal of Cllr S Conlon, seconded by Cllr D Maxwell it was agreed that this Council writes to the Departments of Agriculture and also Department of Rural Affairs in follow up to the publication of Working Group of Dog Control seeking the immediate allocation of funding to support the recruitment of an additional dog warden for Co Monaghan.

## 16. To receive reports from Members attending Conferences/Training events.

The members noted the reports from Cllrs D. Maxwell, relation to attendance at the following Conference/Training events:

#### 22. Questions

## Cllr C. Carthy asked:

1. Has the executive completed their assessment of tenders received for the Feasibility Study and Strategic Assessment Report for a Swimming Pool/Leisure Centre for Carrickmacross? If so, is the council prepared to formulise an engagement with selected consultants in March?

**Reply:** Monaghan County Council completed the formal tender assessment process on the 19<sup>th</sup> of February 2024. Having regard to compliance with relevant procurement procedures

and timelines, it is expected that the contract for engagement of professional consultants will be executed before the end of March 2024.

2. Has the council received confirmation from the Department of Housing yet that would allow us to proceed with our 'Affordable Purchase Scheme' and can the council pursue an 'Affordable Rental' model with the Department also?

**Reply:** Circular: Housing 06/2023 sets out information and documentation suggested to accompany applications for funding support from the Affordable Housing Fund for those local authorities who were not set affordable housing targets last year for the period 2022 to 2026 by the Minister for Housing, Local Government and Heritage. Monaghan County Council are proposing an affordable housing scheme in Latlorcan. Initial designs are completed and its expected that an application for funding will be made during 2024.

3. In response to numerous issues with streetlights being out for significant periods of time, has the council been engaging with ESB to avoid similar issues arising in future? Is there a need for certain lines to be upgraded and, if so, what plans are in place to make those improvements?

**Reply:** After storm Isha some locations were without lights for a prolonged period as priority was given to reestablish power to homes and businesses. Also, the public would need to log outages/lighting issues for us to know there is a problem.


Monaghan County Council maintains and improves the existing public lighting network on an ongoing basis. There are a group of streets out in Patrician High School, Carrickmacross due to a cable fault, Enerveo, MCCs public lighting contractor, is liaising with ESB on this.


#### Cllr S. Conlon asked:

4. Regarding the urgent need for Council houses and apartments across our county, with supply continuously falling behind the demand by eligible applicants, has the Department of Housing set a forecast target for social housing completions and acquisitions for 2024? What was the total number provided in 2023?

**Reply:** The Department has given Monaghan County Council a target of 58 properties to be delivered in 2024 under the Housing for All programme. No target has been detailed for single property acquisitions.

See table and graphic below detailing projected number of 109 Acquisitions and Build properties to be delivered in 2024 by Monaghan County council and Approved Housing Bodies.





A total of 98 additional social housing units were provided in 2023. These homes were delivered through a mix of new build and acquisitions. The Department of Housing target set for Monaghan County Council for 2023 was 56 social housing units, this was exceeded by 75% in 2023.

In 2023 Monaghan County Council completed the purchase of 19 houses. These properties were purchased for Tenants in situ (13), Disability (1), Exit from homelessness / prevention of homelessness (3) and properties for people in exceptional need (2). Monaghan County Council exceeded the acquisition target by 9 properties.

Through the Mortgage to Rent scheme a further three houses are now being managed by "Home for Life". These properties are officially recorded under the "Leasing" heading as they might eventually return to the ownership of the occupiers, however they are currently in the ownership of "Home for Life" to allow occupiers to remain in their homes in spite of mortgage issues.

5. In line with the core objectives of implementing carbon footprint mitigation measures as outlined throughout the recently adopted Climate Action Plan, what number of the Council's social housing stock remains to be retrofitted with energy saving measures that will result in an optimum BER rating of B2 or better, along with a reduction in fuel poverty that many Council tenants experience? Aligned to this, what is the total number of Council owned housing stock?

**Reply:** The energy efficiency retrofitting programme in its current format was launched by the Department of Housing, Local Government and Heritage in 2021 as a ten-year programme of works to improve the energy efficiency of Council owned housing stock to a minimum B2 Building Energy Rating or cost optimal equivalent. This programme for government superseded the original Phase 1 Energy Efficiency programme which was launched in 2013. Under the Phase 1 programme all council owned housing stock received energy upgrades in the form of attic insulation, cavity wall insulation (where possible) and heating control upgrades along with insulated water cylinders.

In 2023 Monaghan County Council's Housing Section upgraded 92 houses under the Energy Efficiency Retrofit Programme (EERP) at a cost of €2.93million (average cost €31,868 per dwelling). The Housing Section are currently developing another ambitious programme of works for 2024. The programme being developed by Monaghan County Council will continue to select properties in order of priority dictated by their Building Energy Rating with an emphasis on properties with the poorest Building Energy Ratings. The works included new windows and doors, internal or external wall insulation (if required) and heat pump installation. Works also include removing old, inefficient heating systems, upgrading flat roof

insulation, closing existing chimneys and all other works necessary to achieve a minimum B2 Building Energy Rating (BER). See graphic below detailing 199 properties (Photos of completed properties) that received deep Energy Efficiency Retrofitting works since 2021.



In 2024 Monaghan County Council plan to undertake Energy Efficiency Retrofit works to over 100 properties subject to funding.

To date 652 properties have a B2 Energy Ratings of higher, 1,136 properties remain to receive works to bring them up to B2 Building Energy Rating and the average BER for properties to receive works is D1 Building Energy Rating.

Monaghan County Council's Social Housing stock was 1,788 properties on the 01/01/2024 based on the National Oversight Audit Commission (NOAC) criteria.

Also, I ask the Housing Section, what are the total number of social houses provided by our partner Associated Housing Bodies, and of that number, what is the percentage that are of a B2 or better energy rating?

We do not have the BER's for these properties are they are not in MCC ownership. However, the older AHB owned houses have BERs averaging between C and D (Ard na Lorgan Castleblayney and Convent Lands Carrickmacross etc). The more recently constructed AHB houses have A or B rated BERs (Emy, Drumbear Wood, Coill an Ri etc).

6. For the purpose of this Council aligning to Environmentally Sustainable Development Goals, and objectives outlined in the recently adopted Climate Action Plan, will the Councils Rural Water Services Section engage with the Department of Local Government for the purpose of establishing a Group Sewerage Scheme funded by the Departments

Multi-Annual Programme for the dwellings in the Milltown area of Monaghan, that will provide long overdue provision of this necessary civic infrastructure.

Reply: The relevant funding measure, Measure A8 of the Multi Annual Rural Water Programme-Waste water collection and treatment needs for villages and settlements without access to public wastewater services, was announced by the Minister in early 2022. Water services looked at proposals for this measure at the time and engaged with the Department in relation to Milltown. However, the settlement did not meet the minimum criteria required for application. The projects approved by the Minister under this measure were announced in December 2022. Monaghan County Council will continue to monitor developments and will re-engage with the Department if there is any indication of a change in the eligibility criteria.

7. In reference to the lengthy delays in processing applications for the Taking in Charge of housing developments by this Council, I ask for an update on what progress is occurring relating to the following developments being Taken in Charge, what date the application was originally submitted, and are Uisce Eireann solely responsible for any delays?

**Reply:** The Planning Authority received a taking in charge application for Millbrook in 2017. The Planning Authority are still awaiting the agreement from Uisce Eireann to progess the taking in charge.

The Planning Authority received a taking in charge application for An Crannog in 2018. The intent to take in charge this estate has been formally advertised and it is expected that it will go to the April Council meeting.

The Planning Authority received a taking in charge application for An Crannog in 2020. Uisce Eireann will not agree to take in charge this estate until a wayleave is required to a pumping station. Water Services are engaging with a third-party landowner with regards acquiring such a wayleave.

The Planning Authority received a taking in charge application for Cois Cnoic in 2018. Due to third party land issues and following discussion with Uisce Eireann it has not been possible to progress the taking in charge of the development. Water Services are exploring and discussing possible solutions to the routing of the Cois Cnoc gravity foul line with various relevant third parties. This pipeline is being monitored for any signs of deterioration to enable early action to be taken to prevent any possible discharge to the surrounding environment.

# Cllr N. Keelan asked:

8. Given the ongoing scourge of littering across our county including along the N2.

What success have we had over the course of last year 2023 in detecting some of these litter louts, how many fines have been issued over the course of last year 2023 for littering excluding those issued for bring banks violations?

Reply: 47 Fines issued.

9. How many properties across the county come under the housing assistance payment scheme (HAP). How much was paid out to landlords under the (HAP) scheme in 2023 How many inspections of private rented accommodation have been carried out in 2023, what was the outcome of these inspections?

**Reply:** There are currently 506 active HAP tenancies with Monaghan County Council. € 3,367,620.46 was the cumulative 2023 figure paid to HAP landlords for Monaghan County Council.

There were 404 private rented inspections carried out in 2023.

305 were non-compliant after the 1st Inspection.

86 were compliant after the 1st Inspection.

181 became compliant in 2023.

In the first quarter of 2024 the inspection team is following up on non-compliant properties.

10. How many local authority housing tenants, if any, find themselves in rent arrears at present of over three months, six months, twelve months or more?

Only 71 of the >12 weeks old are still active tenants. The remainder are those that have surrendered their tenancy with arrears on their accounts. These customers remain on our listings as a point of reference.

Revenue collectors are actively engaged with all customers who are in arrears and support them in setting up payment plans and arranging payments through the Household Budget.

11. What is the up-to-date position in relation to the taken in charge by Monaghan County council of the Sliabh Dubh estate at Corduff Carrickmacross, have the issues with Uisce Éireann being resolved given that this seems to be the problem in terms of moving the process forward?

**Reply:** Sliabh Dubh is served by a standalone wastewater treatment plant which is not maintained by the original developer. Monaghan County Council has previously intervened and carried out remedial works relating to this plant when a public health matter has arisen. In the 2015 Memorandum of Understanding agreed between local authorities and Uisce Eireann, it was confirmed that Uisce Eireann would not take in charge developer provided infrastructure (DPI), such as that installed in Sliabh Dubh.

When taking in charge an estate, the Local Authority is obliged to take in charge all infrastructure and cannot decide to omit certain elements (such as standalone wastewater treatment systems). In the case of the taking in charge of Sliabh Dubh, if the Local Authority proceeds to take in charge the development, it will be liable for the future maintenance and repair of the wastewater treatment system, which is defective.

The Local Authority must consider the implications of taking in charge of DPI, particularly considering Uisce Eireann's position, and future potential liabilities to the Council. It is understood that Uisce Eireann may be reviewing its position with regards DPI.

12. How many tradesmen / tradeswomen, plumbers, carpenters etc, are currently employed by Monaghan County council, what plans have the council to roll out an apprenticeship scheme for the various trades in the time ahead?

Correspondence from the Human Resources Section was circulated on 19<sup>th</sup> February 2024 to Career Guidance Teachers of all Secondary Schools in County Monaghan providing details to Leaving Certificate Students that a recruitment campaign for the above apprenticeships will go live mid/late June 2024. This is to align with the completion of the Leaving Certificate examinations. Recruitment adverts for the apprenticeships will be placed in the local newspaper, the Northern Standard and the Council's Social media platforms and website <a href="https://www.monaghan.ie">www.monaghan.ie</a>. Students are also encouraged to submit an expression of interest email to <a href="mailto:recruitment@monaghan.coco.ie">recruitment@monaghan.coco.ie</a>

Nominated mentors for both apprenticeship programmes have been identified and approved and both mentors are available to visit any school in the County or Monaghan Institute to speak with students that may be interested in these programmes.

In addition to the above CMETB have invited Monaghan County Council to take a stand at a career fare scheduled to take place in Monaghan Institute May 2024. Monaghan County Council welcome this opportunity and appropriate staff will be available on the day to promote the apprenticeship programmes coming on stream for September 2024.

#### Cllr P. Connolly asked:

13. In view of the fact Louth Co Co recently purchased a JCB Pothole Pro (pothole filler) which was partially funded by the department of Environment and is halving the cost of filling potholes and improving the quality of work what plans have Monaghan Co Co to purchase a similar machine?

**Reply:** Monaghan County Council have currently no plans to purchase a similar machine. The major cost incurred for repairing potholes is the traffic management and labor involved. Monaghan County Council have previously purchased a velocity patcher, which has provided significant savings, and have also an additional velocity patcher on hire to repair potholes across the County.

Cllr P Treanor proposed, Cllr A Campbell seconded that Monaghan County Council writes to the President of the EU Commission, the Taoiseach and the Minister for Agriculture advising them that the Council has passed the following resolution.

Monaghan County Council supports the IFA 'enough is enough' campaign.

The Council recognises the significant contribution that farming, and the Agri-sector makes to the Irish and local economy.

The Council acknowledges the income challenge on Irish farmers arising from the significant increases in the cost of doing business, regulatory costs and cuts in Basic Income support for farmers.

The Council calls on the Government to introduce no further regulations on farmers or any measures that may increase costs on farms without full negotiation and agreement with the Irish Farmers Association (IFA). The Council calls on the European Union and the Irish Government to provide additional stand-alone funding, separate to the Common Agricultural Policy (CAP), to support farmers to undertake climate and biodiversity measures'.

Following discussion on the motion, the Cathaoirleach put it to the meeting and the motion was agreed unanimously.

On the proposal of Cllr P Connolly, seconded by Cllr R Aughey it was agreed that In view of the fact that Ash Dieback has been identified as a roadside safety issue by an IFA delegation and the fact that they sought help from Monaghan Co Council at this morning's Co Council meeting that this Council request funding from the Department of the Environment to initiate a pilot

scheme to cooperate with farmers by providing funding and logistics to help with the removal of trees affected by Ash Dieback

Cllr B McKenna and Cllr A Campbell proposed, Cllr A McCooey seconded that focused on the key principles of social, economic, and environmental sustainability, Monaghan County Council agree to proceed with the development of Lough Muckno and its environs. In so doing, Monaghan County Council agree to the engagement of consultants to progress the proposed 10-year Masterplan and Development Framework for Lough Muckno and its environs.'
