PART I

Preliminary

1. Long title

Monaghan County Council (hereinafter referred to as “**the Council**”), in exercise of the powers vested in them pursuant to, *inter alia*, the Local Government Act 2001 (as amended) (*inter alia*, s.131A and Schedule 14A) and the Road Traffic Act 1994 (as amended) (*inter alia*, s.36), and in compliance with same, having consulted with the Commissioner of An Garda Síochána (*per s.36(3)(a) of the Road Traffic Act 1994*), hereby make the following Bye-Laws for the control and regulation of the parking of vehicles in parking places on public roads and car-parks in Monaghan Town, within the functional area of the Council.

2. Short title

These Bye-Laws may be cited as the Monaghan County Council: **Monaghan Town Parking Control (Pay-Parking) & Car Park Bye-Laws 2025**.

3. Commencement of Bye-Laws

These Bye-Laws shall come into operation on **[Date to be Confirmed]**.

4. Revocation

All previous Bye-Laws relating to Monaghan Town parking control and pay-parking are hereby revoked.

5. Areas of application

These Bye-Laws apply to the areas delineated/identified in Drawing Titled -----No. 001 contained at Schedule 3 to these Bye-Laws – Parking Control Area (including Road Markings) and the car parks mentioned in Schedules 1, associated with these Bye-Laws – in the Municipal District of Monaghan.

6. Interpretation

In these Bye-Laws:

“Road Traffic Acts”	Means the Road Traffic Acts 1961-2024 (as amended)
“Agent of the Council/Traffic Warden”	Means any person employed by the Council or any other person authorised by the Council to carry out functions under these Bye-Laws.
“Authorised person:	Has the meaning assigned to it by s.103(8) of the Road Traffic Act 1961 (as amended), including Member of An Garda Siochana
“Business hours”	Means the period from 9.00a.m. to 6.00p.m. (09.00 to 18.00) from Monday to Saturday inclusive, on a day which is not a public holiday.
“Car park”	Includes each of the car parks as set out in Schedule 1 hereunder.
“Disabled bay”	Means a bay provided for a disabled permit holder and indicated by road markings RPM014 as specified in the Road Traffic (Signs) Regulations 1997-2024.
“Disabled person”	Means a person who holds a valid permit for a disabled driver – provided the permit is prominently displayed and legible on the vehicle.
“Disabled persons parking permit”	Means a permit granted in accordance with Article 43 of the Regulations of 1997-2024 by the Irish Wheelchair Association, Disabled Drivers Association. A permit issued by out of state authorities is also recognised but not a timecard.
“electronic means or electronic payment”	Means payment of a parking fee by electronic means (including payment by means of an app)
“Goods vehicle”	Means a vehicle used exclusively for the carriage of goods or burden in the course of trade or business and licensed and taxed as a goods vehicle.
“Holiday”	Means Good Friday or any day that is a public holiday for the purposes of the Organisation of Working Time Act, 1997.

“Information plate”	Means a plate accompanying a traffic sign which indicates the period during which the restrictions or prohibition indicated by such traffic sign applies.
“Licence”	Means a valid motor vehicle licence (Tax Disc).
“Long Stay Area”	Means an area where a vehicle may be parked for the full day at the appropriate rate as set out in Schedule 1.
“Pay Parking App”	Means the online application which allows the purchase of a parking ticket in the requested pay parking zone when the appropriate parking fee prescribed by these Bye-Laws is paid.
“Pay parking area”	Means an area on a public road or carpark where traffic signs or signs No. RPM 016 and No. RUS 018 authorised by the Road Traffic (Signs) Regulations of 1997-2024, together with an accompanying information plate(s) indicate that parking of vehicles is permitted subject to the exhibition of a pre-paid parking ticket.
“Parking bay”	Means a space which is intended for the parking of one vehicle and so indicated by surface or other signs or markings or where the space is intended for the parking of motorcycles, or more than one vehicle.
“Parking fee”	Means a fee payable in accordance with these Bye-Laws for the parking of a vehicle.
“Parking place”	Means a place on a public road which is a pay parking place, a meter parking place, or a ticket parking place.
“Pay parking place”	Means a place on a public road or in a carpark where the parking of vehicles is subject to the exhibition of a prepaid parking permit.
“Pay parking zone”	Means the street/streets or car park/car parks indicated on a resident’s parking permit.
“Pay and Display parking ticket machine”	Means a machine capable of automatically delivering a Pay and Display parking ticket when the appropriate parking fee prescribed by these Bye-Laws is paid.
“Public road”	Means a road over which a public right of way exists and the responsibility for the maintenance of which lies on a road authority.

“The Regulations of 1997”	Means the Road Traffic (Traffic and Parking) Regulations, 1997 (as amended).
“The Signs Regulations”	Means the Road Traffic (Signs) Regulations, 1997-2024 (as amended).
“Traffic Warden”	Has the meaning assigned to it by Section 2 of the Local Authorities (Traffic Wardens) Act, 1975 (No. 14 of 1975) as amended.
“Valid coins”	Means the coins indicated on the appropriate Pay and Display parking ticket machine.
“Valid Pay and Display Tickets”	Means a ticket issued by the Council which:- (a) indicates the year, month, date, hour or minute; (b) indicates no other year, month, date, hour or minute; (c) shall be exhibited in a prominent and accessible location behind the windscreen of the vehicle.
“Vehicle”	Includes a mechanically propelled vehicle whether powered mechanically or electrically or partially mechanically or partially electrically and includes a motor-cycle.

PART II
Pay Parking

7. Part II Definitions

In this part:

"Parking ticket"	Means a document having marks or symbols capable of indicating the year, date and time when the document or combination becomes a valid parking ticket.
"Valid parking ticket"	Means a parking ticket which: - (a) has been issued by this Council, and indicates the year, month, day in the month, hour of the day and minute of the hour of commencement of a period of parking of the vehicle in which the parking ticket is exhibited in accordance with these Bye-Laws. (b) indicates that the vehicle is so parked for a period not exceeding the period for which it may be parked in a pay parking place in accordance with these Bye-Laws Or (c) indicates that payment has been made, via the Parking App, and indicates the year, month, day in the month, hour of the day and minute of the hour of commencement of a period of parking of the vehicle in accordance with these Bye-Laws.

8. Obligation to display valid parking Pay and Display ticket

8.1 Where a vehicle is parked in a pay parking area on a day and during a period which is indicated on an authorised information plate accompanying Traffic Sign Number RRM016 of the Signs Regulations 1997-2024: -

- (a) a valid parking ticket shall be displayed;
- (b) the valid parking ticket shall be so exhibited in the interior of the vehicle that a person outside the vehicle can ascertain when the parking commenced; and

(c) the valid parking ticket shall be exhibited in accordance with Bye-Law 8.1(b) of these Bye-Laws for so long as the vehicle is parking in that pay parking place

Or

(d) a person may park a vehicle in a parking bay when payment has been made, via the Parking App, and indicates the year, month, day in the month, hour of the day and minute of the hour of commencement of a period of parking of the vehicle in accordance with these Bye-Laws.

8.2 Bye-Law 8.1 of these Bye-Laws shall not apply to the parking of a vehicle in a pay-parking place if there is a valid resident's parking permit displayed.

8.3 Where a vehicle being parked in a pay parking place on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM 016 of the Signs Regulations 1997-2024 is a goods vehicle parked while goods are being actively loaded in or onto it or unloaded from it, Bye-Laws 8.1 and 8.2 of these Bye-Laws shall not apply until the expiration of 30 minutes after the commencement of parking.

9. Manner and time of payment of parking fee

9.1. A Pay and Display parking ticket shall be purchased from an appropriate Pay and Display parking ticket machine or a payment may be made by electronic means, via the Parking App.

9.2. The fee for the Pay and Display parking ticket shall be payable by means of any combination of valid coins or as a digital transaction through the online Parking App.

9.3. Payment shall be made by inserting the appropriate fee into the appropriate Pay and Display parking ticket machine and following the instructions on the parking ticket machine in order to obtain a valid Pay and Display parking ticket.

9.4. The valid parking ticket shall be displayed immediately on parking provided that, where a vehicle is parked at a time not during business hours, the valid parking ticket shall be displayed in accordance with paragraph 8 of these Bye-Laws at the commencement of business hours.

9.5. A person who pays a parking fee by electronic means (including the Parking App) shall not be obliged to display a valid parking ticket.

10. Period of parking in a pay parking place

- 10.1. A vehicle parked in a pay parking place on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997–2024 shall not be so parked for longer than the period indicated as the maximum parking period for that pay parking place by means of an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997-2024.
- 10.2. Where a vehicle which had been lawfully parked in a pay parking place is subsequently lawfully parked in another pay parking place, the period to which the subsequent parking is restricted by Bye-Law 10.1 of these Bye-Laws shall be reduced by a period equal to the period from the time indicated on the pay parking ticket to the time when the subsequent parking commenced.

11. Interference with Pay and Display ticket

- 11.1. Where a vehicle is parked in a pay parking place on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997-2024, a person shall not interfere with a parking ticket exhibited on the vehicle.

12. Removal of vehicle from pay parking place

- 12.1. A vehicle parked in a pay parking place at a time which is not on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997-2024 shall be removed from the pay parking place when the period indicated on the authorised information plate commences, unless at such commencement and during the remainder of the period of parking, a valid pay parking ticket is exhibited in the interior of the vehicle in accordance with Bye-Law 8.1(b) of these Bye-Laws and Bye-Law 8.1(c) of these Bye-Laws shall apply from such commencement in respect of such parking.

13. Prohibition on certain parking inside 2 hours of leaving pay parking place

- 13.1. A vehicle which had been parked in a pay parking place for the maximum parking period for that pay parking place, as indicated by means of an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997-2024, shall not be parked again in a pay parking place in the public road in which that pay parking place is situated until at least two hours have elapsed since the expiry of its earlier pay parking period.

14. Conditions for parking in pay parking places

- 14.1. A vehicle of less than 3 tonnes which is parked in a pay parking place on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997-2024 shall, where parking bays are provided at that pay parking place, be parked within the area comprising a single parking bay.
- 14.2. A person shall not park or cause to be parked a vehicle in such a position that it or any portion of it extends from one parking bay to another.

15. Motor cycles and pedal cycles

- 15.1. A motorcycle or pedal cycle shall be exempt from these Bye-Laws.

16. Issue of valid Pay and Display parking ticket

- 16.1. Pay parking tickets shall be issued by the Council by dispensing machines or online via Parking App.

17. Fee for Pay and Display parking ticket

- 17.1. The fee for a pay parking ticket shall be a sum as set out in Schedule 1 of these Bye-Laws where indicated by an authorised information plate accompanying Traffic Sign RRM 016 of the Signs Regulations 1997-2024.
- 17.2. The payment of fees shall be on a pro-rata basis for any period of parking up to the maximum period allowed in that ticket parking place, as indicated on an authorised information plate accompanying traffic sign RRM 016 of the Signs Regulations 1997-2024.

18. Suspension of Pay and Display machine or ticket parking places

- 18.1. The Council may suspend from operation a pay parking area or part thereof. The suspension shall be subject to any conditions that may be specified in writing by the Council – including, if so required, the payment of a fee/fees by the person requesting the suspension.
- 18.2. The maximum fee/fees payable shall be as indicated in Schedule 3.
- 18.3. The suspension of a pay parking area or a part thereof shall be indicated by the placing thereon of a sign or other device clearly indicating that it is non-operational, or by the temporary removal of the Pay and Display parking ticket machine and the erection of a sign indicating that the parking of vehicles is prohibited in the ticket parking place.

- 18.4. It shall be an offence to breach a condition specified in writing by the Council when a pay parking area or part thereof is being suspended. In the event of vehicles being parked in contravention of these conditions, they shall be deemed to be unlawfully parked for the purposes of the Road Traffic Acts and any Regulations made thereunder.

19. Interference

- 19.1. No person shall insert any coin, article, or object other than a payment card or the coins specified into a Pay and Display parking ticket machine for the purchase of a Pay and Display parking ticket or interfere in any other way with a Pay and Display parking ticket machine in a pay parking area.
- 19.2. No person other than an agent of the Council, a member of An Garda Síochána, an authorised person, or a Traffic Warden shall interfere in any way with a hood, sign or other device placed on a Pay and Display parking ticket machine in a pay parking area.
- 19.3. A person shall not interfere with, alter, or deface a parking ticket.

20. Car parks

- 20.1. No person shall use any car park specified in Schedules 1 and 2 of these Bye-Laws for any purpose other than for the parking of a mechanically propelled vehicle, without the authorisation of the Council.
- 20.2. Where a mechanically propelled vehicle, other than a motorcycle, is parked in a car park (identified in Schedules 1 and 2 hereunder), during business hours, it shall display a valid Pay and Display ticket for each hour, day or week during which it is so parked.
- 20.3. A vehicle parked in a car park at a time which is not during business hours shall be removed from the car park when a period of business hours commences, unless a valid Pay and Display ticket is exhibited or the appropriate charge is paid.
- 20.4. Bye-Laws (20.2) and (20.3) shall not apply to a vehicle in which a valid disabled person's permit is displayed, and which is parked for the convenience of the person to whom that permit was granted, if the permit is prominently displayed on the vehicle when the vehicle is parked.

- 20.5. A person shall not park or cause to be parked in a car park a vehicle in such a position or in such condition or in such circumstances that it would be likely to cause danger to other persons using the car park, or to obstruct the entrance to or exit from the car park, or to obstruct the free flow of traffic within the car park.
- 20.6. A person shall not park or cause to be parked in the car park a vehicle in such a position that it or any portion of it extends from one parking bay to another. A vehicle of less than 3 tonnes which is parked in a pay parking place on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997-2024 shall, where parking bays are provided at that pay parking place, be parked within the area comprising a single parking bay.
- 20.7. A person shall not overhaul or carry out repairs to a vehicle while it is parked in a car park, save where it is necessary in order to enable the vehicle to be removed from the car park.
- 20.8. A vehicle parked in a car park shall not be used for the sale of goods in or from the vehicle or as an office, nor shall any such vehicle be offered or displayed for sale or for hire or as a prize.
- 20.9. A person shall not make any unnecessary noise by means of or in relation to a vehicle while it is parked in a car park or by means of any equipment, fitting or instruments fitted to or carried on the vehicle or any loud speaker or radio in anyway connected to the vehicle.
- 20.10. A person shall not throw, place or leave any bottle or any broken glass, nail, litter or other substances on or in a car park except when deposited in a suitable receptacle and no person shall at any time without the consent in writing of the Council play ball or any game in a car park.
- 20.11. Every person using the car park shall comply with lawful direction given by an officer or servant of the Council authorised for the purposes of these Bye-Laws by Monaghan County Council or member of An Garda Síochána in relation to the parking of a vehicle in or its removal from a car park or in relation to any of these Bye-Laws.
- 20.12. A person shall not in any car park wilfully obstruct, disturb, interrupt or annoy an officer or servant of the Council in the execution of his/her duty, including the execution of any work in connection with laying out or maintenance of any part of a car park by the Council staff and agents.
- 20.13. A person shall give on demand to an officer or servant of the Council or a member of An Garda Síochána his/her name and address and a person shall not resist, obstruct, aid or incite any person to resist or obstruct any

officer or servant of the Council or other person in the execution of his/her duty or lawful exercise of his/her authority in a car park.

20.14. Any person may be requested by an officer or servant of the Council or a member of An Garda Síochána to quit or leave a car park and shall forthwith comply with such a request.

20.15. No person other than a Disabled Permit holder may park at a Disabled Bay provided in any of the locations mentioned in Schedule 1 and Schedule 2 of these Bye-Laws.

20.16. No vehicle shall enter, pass through, or park in any of the locations mentioned in Schedule 1 and Schedule 2 of these Bye-Laws if it does not comply with display of licences required by the Road Traffic Acts.

20.17. No Public Service Vehicles engaged in plying for hire and authorised under the Road Traffic (Public Service Vehicles) Regulations 1963-2000 shall park at any of the locations mentioned in Schedule 1 and Schedule 2 unless picking up or setting down passengers.

PART III
Parking for Residents

21. Part III Definitions

In this part:

"Acceptable evidence"	Acceptable evidence includes: (i) Current insurance certificate confirming that the vehicle is normally kept by the resident at the said resident's address in the pay parking area to which the permit will relate. (ii) (1) A vehicle licensing certificate or a registration book confirming that the resident applying for a resident's parking permit is the registered owner of the vehicle in respect of which the application for a resident's parking permit is being made and that the vehicle is registered at the resident's address in the pay parking area to which the permit will relate

	Or (2) Where the applicant is not the registered owner of the vehicle in respect of which the application for a resident's parking permit is being made, the vehicle licensing certificate or a registration book for the vehicle, satisfactory documentary evidence from the registered owner that the vehicle is normally kept by the applicants at the resident's address in the pay parking area to which the permit will relate and evidence from the Revenue Commissioners that a vehicle owned by the registered owner is normally kept by the applicant. (iii) A driving or provisional licence in the name of the resident applying for the resident's parking permit. (iv) Documentation acceptable to the Council e.g. Utility bills, bank statements or other documentation addressed to the applicant at his/her address in the pay parking area which the resident's parking permit will relate. (v) Confirmation of entry in the Register of Electors. (vi) Any other information that may be requested by the Council.
"Owner"	Means a resident by whom a vehicle is habitually kept and used.
"Resident"	Means a person who satisfies the Council that his/her normal dwelling place is at a premises situated in a street containing a pay parking place.
"Resident's parking permit"	Means a document issued by the Council or its agent for the purposes of Bye-Laws 21 to 30 and containing the particulars specified in Bye-Law 22.
"Valid resident's parking permit"	Means a resident's parking permit which relates to a particular pay parking zone and to a period which

	has not expired and which is issued by the Council or its agents.
"Vehicle"	Means: - (a) A vehicle currently licensed in this state under the Road Traffic Acts 1961-1994. (b) A passenger vehicle with passenger accommodation for not more than twelve persons, excluding the driver, and which is not drawing a trailer or other vehicle (c) A goods vehicle whose unladen weight does not exceed 3 tonnes and which is not drawing a trailer or other vehicle.

22. Non-application of Bye-Laws 6 to 12 of these Bye-Laws

22.1. Bye-Laws 6 to 12 of these Bye-Laws shall not apply to the parking of a vehicle in a pay parking place if there is displayed, in the vehicle when it is so parked, a valid resident's parking permit which relates to the street in which that pay parking place is situated.

23. Particulars of a resident's parking permit

23.1. A resident's parking permit shall contain the following particulars: -

- (a) The words Monaghan County Council.
- (b) The registration number of the vehicle in respect of which it is issued.
- (b) The date of issue.
- (c) The pay parking zone(s) to which it relates.
- (e) The period to which it relates, including the date of expiry.

24. Permission to park vehicle displaying a resident's parking permit

24.1. The display, in accordance with these Bye-Laws, of a valid resident's parking permit on the vehicle in respect of which the permit was issued shall permit the owner of the vehicle (or any person using it with his/her consent) to park it without limitation as to time in a pay parking place in the pay parking zone to which the permit relates.

25. Display of a resident's parking permit

- 25.1. A valid resident's parking permit shall be so displayed in the interior of the vehicle in respect of which it is issued so that it can be read from outside the vehicle.

26. Interference with a resident's parking permit

- 26.1. Where a vehicle displaying a resident's parking permit is parked in a pay parking place, a person shall not interfere with the permit.

27. Issue of a resident's parking permit

- 27.1. A resident's parking permit may be issued by the Council or its agents in respect of the parking of a vehicle in a pay parking area, subject to the production of acceptable evidence.
- 27.2. A resident's parking permit may be issued by the Council or its agents in respect of the vehicle of which the resident is the owner and shall be valid for a period of one year from the date of issue, in respect of that vehicle and for the pay parking zone(s) to which the permit relates.
- 27.3. The fee for a resident's parking permit shall be a sum as set out in Schedule 1 of these Bye-Laws.
- 27.4. The Council may, at its discretion, assign a designated parking place to a qualifying resident for the purpose of resident parking. Such a designated space may not necessarily be located on the street where the resident resides but may instead be located in the nearest suitable parking facility or car park as determined by Monaghan County Council, having regard to availability, safety, traffic management, and the efficient use of parking resources.

28. Issue of replacement of a resident's parking permit

- 28.1. Where the Council is satisfied that a valid resident's parking permit has been lost, destroyed or stolen, the Council or its agents shall issue a replacement to the owner on payment of a fee as set out in Schedule 1 of these Bye-Laws and such replacement permit shall be substituted for the original permit and the original permit shall be void.

29. Return of a resident's parking permit

- 29.1. Where, during the period to which a resident's parking permit relates, the holder ceases to reside at the address notified at the time of issue of the permit or ceases to be an owner by disposing of the vehicle to which

the permit relates, he/she shall return the resident's parking permit to the Council or its agents.

30. Transfer of a resident's parking permit

30.1. If the holder of a resident's parking permit for a vehicle replaces that vehicle with another, he/she shall be entitled, following the surrender of the original permit, to receive a resident's parking permit in respect of the new vehicle which shall be valid for the period specified on the original permit. The fee for such replacement permit shall be a sum as set out in Schedule 1 of these Bye-Laws.

31. Display of a void resident's parking permit

31.1. It shall be an offence to display a void resident's parking permit.

PART IV **Miscellaneous**

32. Non-application Bye-Laws 8 to 14 of these Bye-Laws to certain vehicles

32.1. Bye-Laws 8 to 14 of these Bye-Laws shall not apply to: -

(a) a vehicle being used in connection with the removal of an obstruction to traffic, the maintenance, improvement or reconstruction of a public road, the apparatus for the supply of gas, oil, water or electricity or of a telegraph or telephone line or the provision of a traffic sign.

(b) a fire brigade vehicle, an ambulance or a vehicle being used by a member of An Garda Síochána or the Defence Forces in the performance of his/her duties.

(c) a vehicle in which a valid disabled person's permit is displayed and which is parked for the convenience of the person to whom that permit was granted, if the permit is prominently displayed on the vehicle when the vehicle is parked in a pay parking place on a day and during a period which is indicated on an authorised information plate accompanying traffic sign number RRM016 of the Signs Regulations 1997-2024.

(d) a service delivery or collection vehicle, a refuse collection vehicle or other HGV loading or unloading activity associated with commercial premises, subject to such activities occurring only outside the hours of 7.00am to 7.00pm Monday to Wednesday (inclusive), 7.00am to 9.00pm Thursday and Friday and 9.00am to 7.00pm Saturdays.

33. Electric Vehicles Charge Bays

A vehicle, other than an electric vehicle, must not be parked in an Electric Vehicle Charge Bay at any time, and

- (a) An Electric Vehicle shall not be parked in an Electric Vehicle Charge Bay except for the purposes of charging the vehicle and,
- (b) An Electric Vehicle shall not be parked in an Electric Vehicle Charge Bay for a period exceeding 3 hours
- (c) A plug-in Hybrid Vehicle shall not be parked in an Electric Vehicle Charge Bay for a period exceeding 1 hour

34. Pay-Parking App

Where a vehicle is parked in a pay parking place during operational hours and a valid payment has been made as a digital transaction through the online Parking App, for that vehicle, for that location and for that date & time, Bye-Laws 8, 9.3, 9.4 and 11 shall not apply.
