

Introduction

Monaghan County Council has commissioned The Paul Hogarth Company to identify and assess potential sites in the town of Clones for a proposed Bikers' Memorial and Garden.

Locations with potential have been independently identified and assessed using an agreed set of criteria. This report concludes with a series recommendations for consideration by the elected members of Monaghan County Council.

The Paul Hogarth Company is one of Ireland's leading Landscape Architecture, Urban Design and Planning consultancies. Established in 1990, the practice has been responsible for a wide range of award winning landscape and public realm projects. It has worked for Monaghan County Council on a number of projects and worked with the Clones Town Team in 2021 to produce the Clones Heritage and Economic Plan. The Paul Hogarth Company also provided consultancy advice to Waterways Ireland for the activation of the Clones Marina in 2023/4.

The practice is not currently appointed to any projects in Clones and this report has been written independently of all organisations involved.

Memorial & Garden

A permanent memorial for motorbikers lost to road traffic collisions has been proposed by a committee of the Gone But Not Forgotten organisation. Founded in 1985 the group has organised annual memorial services since 2003, which from 2010 have taken place at the Sacred Heart Church in Clones.

The proposed memorial will been funded by the Gone But Not Forgotten Bikers Memorial Committee through public donations. In 2025 Monaghan County Council published a Public Art Commission Opportunity on the group's behalf and invited artists to submit proposals for "an imaginative and contemporary sculptural work which encapsulates the natural beauty of the location landscape, the history of the Bikers Memorial in Clones, and is a worthy addition to the many heritage sites in the town area" ((Monaghan County Council, 2025).

The memorial would be placed in a purpose designed garden, likely to comprise planting, seating, pathways and lighting. The size of such a memorial and garden could vary and would be determined by a site specific design process. It is assumed that planning consent would be required, depending on the selected site.

It is envisaged that the memorial garden would mostly be visited by individuals and family groups in small numbers throughout the year. Large gatherings are unlikely, except at the time of the annual mass where this would be possible.

Prior to this assessment, discussions took place between the Gone But Not Forgotten Committee and officers of Monaghan County Council about a potential site at Clones Marina. But after opposition to that location was expressed by residents via the Clones Town Team, those discussions and the artist procurement process have been paused and this independent assessment commissioned.

The Process

Meetings - The Paul Hogarth Company visited Monaghan in 19 March 2025 for the purposes of this assessment. On that day they met with a representative of Monaghan County Council. Online meetings were subsequently held with the Gone But Not Forgotten Memorial Committee (15 April) and Clones Town Team (2 May). The purpose of these meetings was to explain the proposed assessment process and to listen to the opinions of each group. Correspondence was subsequently received from the Town Team but no further dialogue took place.

Methodology - the assessment methodology has been designed by The Paul Hogarth Company and approved by Monaghan County Council.

Site Selection - The consultant team has identified 20 potential sites for a memorial and garden. These are all located within the town of Clones and were deemed to offer some potential, albeit with various issues that would need addressed if chosen. The long list of sites was not made public prior to the assessment, as no allowance was made for public consultation at that interim stage.

Criteria Development - a set of criteria were developed by the consultancy team (see opposite). These were shared with the 3 organisations named above. Displacement and Additionality were suggested and subsequently added after due consideration.

Assessment - the 20 sites were independently scored by the consultancy team, from 1 (low) to 5 (high). The total number of scores was tallied and a shortlist of 3 sites identified.

Assessment Criteria

Criterion	Assessment Question
Area	Is there adequate space for a memorial and garden and circulation space for occasional gatherings?
Visibility	Is the site visually connected with its surroundings, giving it prominence while keeping it safe?
Accessibility	Is the site suitable for all users, including potential for wheelchair accessibility and proximity to car parking?
Setting	Would the setting of the location be appropriately attractive and calm in a manner that is befitting for a memorial garden?
Lack of Displacement	To what extent would the garden development minimise the loss or reduction of an important current use of the site?
Additionality & Regeneration	Could a memorial garden in this location add value to the immediate area and contribute positively to the town as a whole?

The following factors have not been assessed but should inform any design and planning process.

- land ownership & leases - ecology

- archaeology & heritage - ground conditions

- utility infrastructure

- road safety

- planning

- impact on site neighbours

- flood risk - public opinion

Location H. Barry McGuigan Park

Score: 23

Pros

- + An existing green space, minimising displacement of other uses
- + Ample space for the creation of a garden

Cons

- Limited car parking immediately adjacent to the area

Summary

This is one of the largest sites considered, meaning that the memorial garden could be placed at a number of locations within the park. This would require good landscape design to ensure the garden fitted within its context. Interpretation within the park would need carefully considered so that the memorial could co exist other information about Barry McGuigan and the park's wildlife.



Location R. Play Area Garden and Clones Marina

Score: 22

Pros

- + An existing garden therefore no change of use
- + Ample parking and next to other amenities, such as the canal and play area

Cons

- Limits the potential to enlarge the adjacent play area in the future

Summary

This garden site has clear potential to be upgraded into a memorial garden, with access to car parking and other amenities close by. A design here would need to take into account proximity to the adjacent play area.

While not part of the scoring criteria, strong local feelings about this site will require addressed to inform the decision making process.

Shortlisted Sites



Location B. Roslea Car Park at Junction with Church Hill

Score: 21

Pros

- + Centrally located in relative close proximity to Sacred Heart Church
- + Significant potential to improve the quality of the site and area

Cons

- Loss of car parking that could affect local businesses

Summary

This site has significant potential, turning a hard and unattractive area into a green and welcoming space. While some car parking spaces would need to be removed to enable development, some could be retained, perhaps for disabled and family parking.

Recommendations

Following this assessment, The Paul Hogarth Company make the following recommendations

- 1. The 3 short-listed sites should be considered in greater detail to enable a final decision to be made by democratically elected members. This should be further informed by a high level review by Council of points not assessed, as noted on Page 3. As the project will be largely funded by monies raised by the Gone but Not Forgotten committee, their views should also be taken into account in the decision making process.
- 2. Consideration should be given to a form of public consultation, so that local people and groups can have their say. This should not, however, be a referendum on sites, but an opportunity for representations to be made. Public engagement will also be key to the development of a design, so that a memorial garden in the chosen location can be visualised, and the outcome informed by members of the public.
- 3. The memorial and garden should be designed together and specifically for the chosen site, rather than be designed in isolation and placed in one of the locations. The three short-listed sites warrant different designs that make the most of their site characteristics and features.
- 4. The memorial should be sympathetically designed to pay tribute to those that have been lost, without being too literal that could risk upsetting members of the public. Memorial gardens do not need to look and feel like graveyards, but can be vibrant spaces that are used and enjoyed by everyone.
- 5. Use of the garden should be managed to allay any local concerns around the possibility of noisy gatherings, road safety issues or antisocial behaviour. Open communication and cooperation between the organisers, council and community will be key to this.
- 6. While a sensitive and emotive subject, the memorial garden should be a positive addition to the town of Clones. To succeed this will be reliant on high standards of collaborative planning, design, construction, maintenance and management.
